## Notes to Financial Statements

December 31, 2024

### 1. Description of the Plan

#### Summary Plan Description

The following description of the Summit Medical Group, PLLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions. Copies of this document are available from Summit Medical Group, PLLC (the “Company”), the plan sponsor.

#### General

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of the Company that are age 21 or older and have completed one year of qualifying service are eligible to be credited with the Company’s contributions and to make participant contributions.

#### Contributions

Participants may elect to defer up to a maximum of seventy-five percent of compensation, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants may direct both Company and participant contributions to any of various investment options available under the Plan.

Each pay period, the Company contributes to the Plan a matching contribution equal to 50% of each participant’s contribution up to 6% of contributions. The Company also contributes a qualified non-elective contribution in the amount of 3% of total compensation for all participants. The Company may also make an annual profit-sharing contribution to the Plan in accordance with the plan document, subject to certain limitations. The Plan Sponsor made a discretionary profit-sharing contribution ranging from 2.7% to 7.33% of eligible compensation in 2024 and 2023.

Cash contribution receivables from the Company are unsecured.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company contributions, as described above, investment earnings and losses that are allocated based on each participant’s relative account balance within the respective fund, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Vesting

Participants are immediately vested in their elective deferral contributions, Company matching contributions, and Company qualified non-elective contributions plus earnings thereon. Participants are vested in the Company's discretionary profit-sharing contributions after five years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
1	20%
2	40%
3	60%

5	100%

Participants may also become 100% vested as a result of death, disability, or reaching normal retirement age of 55.

##### Notes Receivable from Participants

Subject to approval by the Plan Administrator, participants may borrow from the general assets of the Plan up to the lesser of \$50,000 or 50 percent of their vested account balance. The amount and terms of the notes receivable must meet certain criteria as defined in the plan document. The notes receivable are generally repayable in level periodic payments over various terms of up to five years unless it qualifies as a home loan, as defined, which may have extended terms. The notes receivable will bear interest at a reasonable rate, specifically set at prime plus 1% for loans originated beginning in 2011.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Upon default of participant notes receivable, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the Internal Revenue Code (IRC), has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan permits in-service and hardship withdrawals under certain conditions.

##### Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of terminated participants' non-vested accounts can be used to pay the Plan's administrative expenses or reduce future Company contributions to the Plan (*Note 4*). If a terminated participant, who is deemed to have received a distribution, resumes participation in the Plan, then the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the plan document.

#### 2. Summary of Significant Accounting Policies

##### Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis, as are annual returns filed under applicable provisions of ERISA and the IRC.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investments

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments.

The Plan's investments are reported at fair value based primarily upon quoted prices in an active market; accordingly, net appreciation or depreciation in fair value of investments is reflected in statements of changes in net assets available for benefits. This includes all investments bought or sold, as well as those held during the year. Purchases and sales are recorded on a trade-date basis, and dividends are recorded on the ex-dividend date.

#### **2. Summary of Significant Accounting Policies (continued)**

The Plan invests in a common/collective trust fund, the T. Rowe Price Stable Value Common Trust Fund (Stable Value Fund), which holds fully benefit-responsive investment contracts. The statement of net assets available for benefits presents the fair value of the investment in this fund. Participants should refer to the Stable Value Fund financial statements for more information.

The Plan's investments in the participant-directed brokerage accounts consist of money market funds, U.S. government securities, corporate bonds, common stocks, mutual funds, and unit investment trusts.

#### **Contributions**

Contributions from Plan participants and the matching contributions, qualified non-elective contributions, and discretionary profit-sharing contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Administrative Expenses**

Administrative expenses are paid primarily by the Plan. Certain other plan administrative expenses are paid by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

#### **Subsequent Events**

In preparation of the accompanying financial statements, management determined there have been no significant events subsequent to the date of the Statement of Net Assets Available for Benefits (December 31, 2024) through October 14, 2025, the date the financial statements were available for issuance.

#### **3. Income Tax Status**

The Plan adopted a prototype plan that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

#### 4. Certified Information (Unaudited)

Charles Schwab Trust Bank (Schwab) holds the Plan's investment assets and executes transactions therein. Financial information relating to those assets disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, net realized and unrealized appreciation in the fair value of investments (including \$869,095 in 2024 and \$1,095,016 in 2023 from funds of parties-in-interest), investment income (including \$211,690 in 2024 and \$182,458 in 2023 from funds of parties-in-interest), and interest income on notes receivable from participants, is based upon information provided to the Plan Administrator and agreed to or derived from information certified as complete and accurate by Schwab.

The participant-directed brokerage accounts include \$9,063,909 and \$6,645,225, respectively, and mutual funds include \$4,166,576 and \$3,700,797, respectively, in funds of Schwab as of December 31, 2024 and 2023.

#### 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level for the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### 5. Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for investments measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value Fund:* Valued at fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund (Note 2).

*Participant-directed brokerage accounts:* Consists of U.S. government securities, corporate bonds, money market funds, mutual funds, common stocks, unit investment trusts, all of which are valued as determined by the issuer based on the fair values of the underlying assets of the fund. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes to the methodologies used as of December 31, 2024 and 2023.
