INDEPENDENT AUDITOR'S REPORT

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS

NOTE 1—DESCRIPTION OF PLAN

The following description of LaCarte Enterprises, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a participant-directed defined contribution plan covering all full-time employees of LaCarte Enterprises, Inc. and affiliated companies (the “Company”) who have completed one year of service and are age twenty-one and older. After completion of the service requirement, an employee may enter the Plan on the first day of the next Plan month. The trustee of the Plan is responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may elect to contribute up to the maximum percentage of eligible compensation as defined by the Plan agreement, subject to IRS dollar limitations.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations as defined in the Plan agreement and as limited by statute. The Company makes a safe-harbor basic matching contribution equal to 100% of each participant’s contribution, up to 3% of the participant’s compensation. If a participant elects to contribute more than 3%, the Company makes an additional matching contribution of 50% of the participant’s contribution between 3% and 5% of compensation. The matching contribution is made each pay period when the voluntary contributions are made. The Company may also make additional discretionary profit-sharing contributions to the Plan at the option of the Company’s Board of Directors. Discretionary amounts are allocated in the ratio that each qualifying participant’s compensation bears to the total compensation of all qualifying participants. A participant must be employed on the last day of the Plan year to qualify for any discretionary profit-sharing contribution.

The Plan includes an automatic contribution provision for employees hired after January 1, 2022. If a participant fails to elect an alternative contribution amount or fails to elect not to contribute, the Company will automatically defer 3% of the participant’s compensation beginning on the participant’s eligibility date.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company’s contributions and Plan earnings (losses) and is charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions, the safe-harbor basic matching contributions, and actual earnings thereon. Participants become vested in the Company’s discretionary profit-sharing contributions in accordance with the following vesting schedule (a year of service is defined as 1,000 hours during the Plan year):

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 95% of 50% of their vested account balances, excluding the Roth elective deferral balances. Payment terms cannot exceed four and one-half years, except, at the discretion of the Plan administrator, this period may be increased for the purchase of a primary residence. The notes are collateralized by the balances in the participants' accounts and bear interest at a fixed rate of the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – Participants are eligible to receive distributions upon disability, death, termination of employment, attainment of age 59½, or retirement. Participants have the option to receive distributions either via a lump-sum cash payment equal to the value of the participant's vested interest in his or her account or via installments.

Pre-Retirement Distributions – Hardship distributions are allowed by the Plan.

Forfeited Accounts – Any portion of a participant's account, which is not vested, is forfeited upon the participant's termination of service. Forfeitures of employer contributions may be used to pay administrative expenses or to reduce employer contributions. Forfeitures available for use by the Plan were \$435 and \$401, as of December 31, 2024 and 2023, respectively.

Plan Expenses and Costs – Certain administrative expenses are paid for by the Company and are excluded from these financial statements, while others are paid for by the Plan. Fees related to the administration of participant accounts and benefit payments are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Net appreciation or depreciation in fair value of investments includes realized gains and losses on investments sold during the year as well as the current year change in unrealized appreciation and depreciation of investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded as earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary, as the Plan considers all notes receivable from participants to be collectible as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

The Plan has adopted a prototype non-standardized, pre-approved profit sharing plan document sponsored by Dunbar, Bender & Zapf, Inc. The IRS has determined by a letter dated June 30, 2020, that the prototype plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is a qualified plan as described in Section 401(a) of the IRC and is therefore exempt from Federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's purpose would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 3—INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

Empower Trust Company, LLC, the custodian of the Plan, has certified that certain information disclosed in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023, in accordance with Section 2520.103-8 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information includes the composition, cost and current value of all investments and notes receivable from participants held as of December 31, 2024 and 2023, as reported in the statement of net assets available for benefits and supplemental schedule, and the interest, dividends, and net appreciation (depreciation) in fair value of investments and interest from notes receivable from participants, as reported in the statement of changes in net assets available for benefits for the years then ended.

NOTE 4—FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted Prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Shares of registered investment companies (mutual funds) are reported at fair value based on the quoted market price of the fund which represents the net asset value of the investments held by the fund at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the plan are considered to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5—AMENDMENT AND TERMINATION

It is the intention of the Company to continue the Plan indefinitely and to make contributions as herein provided. The Company reserves the right, in its sole discretion by written action of the Plan sponsor, to amend the plan, terminate the plan, or to reduce or cease contributions at any time. Notwithstanding any other provision of this Plan, no action to amend or terminate the Plan may have the effect of decreasing, denying or otherwise adversely affecting any benefit to a participant that is a “protected benefit” within the meaning of Code Section 411(d)(6) and the Treasury Regulations thereunder. In the event of Plan termination, participants will become 100% vested in amounts attributed to the Company’s contributions.

The Plan was last amended effective December 31, 2021.

NOTE 6—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others.

Notes receivable from Plan participants qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

During the years ended December 31, 2024 and 2023, administrative fees of \$32,855 and \$32,227, respectively, were paid by the Plan to the custodian, which qualify as party-in-interest transactions. Additionally, The Plan sponsor also pays certain fees and expenses of the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
