### 1. Description of Plan

The following description of the Citrin Cooperman Profit Sharing Plan – Plan No. 3 (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan established effective January 1, 2008, and restated January 1, 2022. The Plan covers all employees of Citrin Cooperman Advisors LLC (the Company), and employees of Citrin Cooperman & Company, LLP, New CP Holdings, LLC and Citrus Partners Holdings, LP, affiliates of the Company (collectively the "Employer"). Employees are eligible to become participants on the first of each month after the first day of employment, provided that they are not (i) covered by a collective bargaining agreement, (ii) nonresident alien who received no earned income from within the United States of America, or (iii) leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's Board of Trustees oversee governance of the Plan, determine the appropriateness of the Plan's investment offerings, monitor investment performance.

The Plan was amended on January 1, 2024 to change the name of the Plan from Citrin Cooperman & Company, LLP Profit Sharing Plan – Plan No. 3 to Citrin Cooperman Profit Sharing Plan – Plan No. 3. In addition, Citrin Cooperman Advisors LLC replaced Citrin Cooperman & Company, LLP as sponsor of the Plan, and Citrin Cooperman & Company, LLP became a participating employer of the Plan.

#### *Contributions*

The Employer may make discretionary employer contributions determined in its sole discretion to each eligible employee. If no action is taken by the Employer with respect to establishing the percentage of Employer contributions applicable for the plan year, the Employer contribution for such plan year shall be deemed to be zero. For the year ended December 31, 2024, the Employer made discretionary contributions totaling \$1,413,625 to the Plan. The Plan does not permit participants to make elective deferrals. Participants may contribute amounts representing distributions from other qualified plans (rollover). Employer contributions are invested in a portfolio of investments as directed by participants. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### *Participant Accounts*

Each participant's account is credited with Employer's discretionary contributions, if any, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Vesting in the Employer's discretionary contribution is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

#### *Notes Receivable from Participants*

The Plan does not permit participants to take a loan from the Plan. To access Plan assets, participants must be eligible to receive a distribution from the Plan.

#### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive his or her benefit in the form of either a lump-sum or installments. For termination of service for other reasons, a participant may receive his or her vested benefit in the form of a lump sum. Partial withdrawals are permitted for age 59½ in-service distributions, hardship distributions and required minimum distributions.

#### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,085 and \$5,263, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. During 2024, employer contributions were reduced by \$5,263 from forfeited nonvested accounts, in accordance with plan provisions.

#### *Recent Regulatory Event*

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with effective dates beginning January 1, 2023 and beyond. SECURE 2.0 is intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules.

## **2. Summary of Accounting Policies**

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers, custodian/trustee and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### *Subsequent Events*

Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued. See Note 9 for subsequent events disclosure.

### **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Money market funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Accordingly, The Vanguard Group, Inc., the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### 5. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by Vanguard Funds, a related party of the Custodian, and therefore, these transactions qualify as exempt party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. There were no direct payments paid by the Plan for recordkeeping fees for the year ended December 31, 2024. The plan sponsor pays directly any other fees related to the Plan's operations.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### 7. Tax Status

The Plan adopted a pre-approved plan offered by Danziger & Markoff LLP. The pre-approved plan received an IRS Opinion Letter dated November 23, 2020, that the Plan and related trust are designed in accordance with

the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **9. Subsequent Events**

In conjunction with the Company's acquisitions during 2025, the acquired companies' plans were terminated (for those acquirees that had a plan in place), and those participants were given the option to rollover their accounts into the Plan. During 2025, through the date these financials were available to be issued, the Company added approximately 170 employees as a result of acquisitions.
