**1. Description of the Plan**

The following description of the Debevoise & Plimpton LLP Retirement Plan for Lawyers (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan is a defined contribution retirement plan established by Debevoise & Plimpton LLP (the Firm or Plan Administrator) effective January 1, 1968. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Trustee**

The Plan's trustee and recordkeeper is Vanguard Fiduciary Trust Company (the Trustee). The Trustee relies on Charles Schwab & Co, Inc. (Schwab) to operate the Self Direct Brokerage Account feature (SDBA).

**Eligibility**

Each Partner shall become a Participant as of the first day of the first Plan Year coinciding with or next following the date upon which he or she (a) becomes a Partner or (b) attains age 21, provided that an individual who becomes a Partner in the same calendar year in which he or she is first credited with service for the Firm shall become a Participant as of the date such person becomes a Partner.

**Contributions**

Each Plan year, the Firm contributes to the Plan for the account of each Participant the lesser of 100% of his or her annual compensation or an amount equal to the difference between the maximum amount of annual additions allowable each year under Section 415(c)(1)(a) of the Internal Revenue Code (the Code) (\$46,000 in 2024) and the maximum amount of elective deferrals allowable each year under Section 402(g)(1) of the Code (\$23,000 in 2024).

**1. Description of the Plan (continued)**

**Participants' Accounts**

Each Participant has an account in which contributions are separately maintained. Each Participant's account is also credited with the allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' accounts are invested and administered in accordance with the provisions of the trust agreement. The trust agreement provides for separate investment options, and Participants may direct the investment of their accounts into any one or more of such funds, as well as changes in such investment direction and transfers among the funds, pursuant to rules prescribed by the committee appointed by the Firm to administer the Plan (the Committee).

**Vesting**

Effective July 31, 2023 a Participant's shares shall fully vest after three years of service with partial vesting of 20% after two years. Prior to that date, a Participant's shares fully vested after six years of service with partial vesting occurring as follows: 20% after two years, 40% after three years, 60% after four years, 80% after five years, and 100% after six years. Full vesting also occurs upon attainment of age 65 or upon death.

**Forfeitures**

Forfeitures occur if a Participant incurs a break in service, the duration of which is the greater of five consecutive years or the number of consecutive years that equal his or her years of credited service prior to the first year he or she incurs a break in service. Forfeitures are allocated in equal shares among the accounts of the remaining Participants on the last day of the Plan year in which the forfeiture occurs. These amounts serve to reduce future contributions by the Firm for Participants. For December 31, 2024 and 2023, there were no unapplied forfeitures.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a Participant will receive a distribution in the form of (1) an annuity or, (2) if elected by the Participant (subject to spousal consent, where applicable), installments or a lump sum in an amount equal to the value of the Participant's vested interest in his or her account.

**Administrative Expenses**

All expenses properly incurred in the administration of the Plan and its related trust shall be paid out of the trust unless and solely to the extent that the Firm, in its discretion, shall inform the Plan Administrator that it will be responsible for the payment of all or a portion of such expenses. Administrative expenses paid by the Firm are excluded from these financial statements.

**Termination of the Plan**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event of termination of the Plan in whole or in part, each Participant affected by such termination shall be fully vested as of the termination date, and the Committee shall determine the date and manner of distribution of all Participants' accounts.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Payment of Benefits**

Benefits are recorded when paid.

**Investments**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements. Investment transactions are recorded on a trade-date basis. The differences between the current market values and historical costs of securities held at the beginning of the year versus the current market values and historical costs of securities held at the end of the year represent the unrealized appreciation for the current year. The net realized appreciation from sales of investments is determined on an average-cost basis.

Interest is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

**3. Investments**

**Information Certified by Trustee**

Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

#### 4. Fair Value Measurements

##### Investment Options

The Participants' contributions and any related income are invested in accordance with the election made by the Participants among those investment funds selected and authorized by the Firm.

The investment options as of December 31, 2024 and 2023 include equity mutual funds (registered investment company), balanced mutual funds, intermediate term bond mutual funds, money market mutual funds and several common/collective trusts. The Plan also offers a Self-Directed Brokerage Account Option which allows a Participant to invest his or her participant account in a separate individual brokerage account for the purpose of purchasing and holding various investments not offered as part of the Plan's core fund options described above.

The Plan assets and liabilities are measured at fair value. To measure fair value, a hierarchy has been established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs. As such, the hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

*Level 2* – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Observable inputs other than quoted prices that are used in the valuation of the asset or liability (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments are carried at fair value using a daily valuation method. The values of mutual funds and money market funds are based on the quoted redemption net asset values of the respective investment company. The Plan holds shares in several common/collective trusts, including the Vanguard Retirement Savings Trust III as well as several Target Retirement trusts. The underlying investments in the Retirement Savings Trust III include fully benefit-responsive investment contracts and the trust is valued daily using published net asset value as determined by the Trustee. The Target Retirement Trusts are composed of several Vanguard index funds chosen to provide a diversified exposure to major asset classes, with the underlying exposure designed to become more conservative over time and the trust is valued daily using published net asset value as determined by the Trustee. Self-directed brokerage accounts consist mainly of common stocks, mutual funds, money market funds and immaterial other Level 1 assets. Common stocks in the self-directed brokerage account are valued based on closing market prices.

**5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

**6. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated August 24, 2015, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to the receipt of the determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Committee believes the Plan, as amended, is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

U.S. GAAP requires the Plan Administrator to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Party-in-Interest Transactions**

The Plan holds units of common/collective trusts, mutual funds and money market funds managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

**8. Subsequent Events**

Management evaluated subsequent events for the Plan through October 15, 2025, the date the accompanying financial statements were available to be issued.
