Notes to Financial Statements

Clearwater Solutions, LLC 401(k) Profit Sharing Plan & Trust Greenville, South Carolina December 31, 2024

Note 1– Description of the Plan

The following description of the Clearwater Solutions, LLC 401(k) Profit Sharing Plan & Trust provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions:

General – The Plan was established by Clearwater Solutions, LLC (the "Company") on January 1, 2013, for the benefit of all eligible employees of Clearwater Solutions, LLC.

Eligibility – Employees who have reached their eighteenth (18th) birthday and completed two months of service are eligible to participate.

Participation – An eligible employee shall become a participant as of the date the employee has satisfied the age and service requirements. A participant may change the amount of the elective deferral at any time via the online portal. The deferral contributions will begin or change as soon as administratively feasible following the entry date or any following date.

Participants' salary contributions – Participants may elect to have a percentage of their salary withheld and contributed to the Plan on their behalf, not to exceed the maximum as permitted by law. The trustee may limit the amount withheld from higher paid participants in order to meet Internal Revenue Service nondiscrimination requirements. Participants direct the investment of their contributions into assets of their choosing, within certain limits.

Employer's contributions – The Company's safe harbor matching contribution will be 100% of each participant's elective deferrals that do not exceed 6%. The Company may make matching contributions equal to a discretionary percentage, as determined by the Company. The Company may also make a discretionary profit-sharing contribution. Participants must be employed on the last day of the plan year and complete 1,000 hours of service during the plan year to receive the discretionary profit-sharing contributions. For the year ended December 31, 2024, the employer made safe harbor matching contributions of \$1,068,630 to the Plan. There were no discretionary matching or profit-sharing contributions made during 2024.

Vesting of participant's interest – Participants will always be one hundred (100) percent vested in their own contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service.

A participant's vested account balance may be distributed to a participant upon (1) termination of employment, (2) retirement, (3) death, or (4) disability. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, current employees may withdraw amounts from employee pre-tax elective deferral accounts for a hardship purpose.

Note 1 – Description of the Plan (Continued)

Participant accounts – Each participant's account is credited with the participant's contribution, the earnings from the participant's investments and allocations of the employer's contributions and charged with administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant notes receivable – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account, are repaid through payroll deductions, and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. The interest rates on outstanding participant notes receivable were 9.50% to 10.50% at December 31, 2024.

Payment of benefits – Upon termination of service, death, disability, or retirement, a participant may elect to receive the value in his or her vested account as a lump-sum distribution.

Amendment and Restatement – Effective August 1, 2024, the Plan's asset custodian changed from Newport Trust Company (Newport) to Principal Life Insurance Company (Principal), who became both the trustee and custodian. The Plan also implemented participant loans. Generally, the loan may not be more than 50% of the vested account or \$50,000, reduced by any outstanding loan balance, if any during the one-year period ending on the day before the new loan is made, if less. The minimum loan is \$1,000.

Note 2 – Summary of Accounting Policies

Basis of presentation – The financial statements are prepared on a modified cash basis of accounting. Investment income is recognized when received, other than unrealized appreciation or depreciation in the value of the Plan's investments, which is recognized as of the reporting date. Participant contributions are recognized as of the date the participant contributions are withheld by the employer. Employer matching contributions are recognized as of the last day of the month in which the related participant contributions are withheld by the employer. Employer profit sharing contributions are recognized as of the last day of the plan year in which the applicable plan compensation is reported to the plan participants on Forms W-2. Expenditures are recognized when paid. Generally accepted accounting principles record revenues when earned, rather than when received, and expenses when the liability is incurred, rather than when actually paid.

Use of estimates – The preparation of financial statements requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Accordingly, actual results could differ from those estimates.

Valuation of investments – Investments are reported at fair value. The Plan's assets are presented at fair value as reported to the Plan by Principal. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Cash and cash equivalents – The Plan considers all highly liquid investments with a maturity date of three months or less, when purchased, to be cash equivalents.

Note 2 – Summary of Accounting Policies (Continued)

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

Payment of benefits – Benefits are recorded when paid.

Subsequent Events – Management has evaluated subsequent events through October 12, 2025, which is the date the financial statements were available to be issued.

Note 3 – Information Prepared and Certified by the Custodian

At December 31, 2024, the Plan's investments were embodied in an investment contract with Principal. At December 31, 2023, the Plan's investments were embodied in an investment contract with Newport. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the custodians, Newport and Principal, as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Note 4 – Fair Value Measurements

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets, measured at fair value.

Mutual funds: Valued at fair value based upon the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the net asset value (NAV) of units held by the Plan. The NAV is based on the fair value of the underlying investments adjusted for separate account management fees.

Common/collective trust: Valued daily using net asset value as a practical expedient (NAVPE). The NAVPE is the method for valuing accounts and is not the same as the net asset value reported by the fund house, although the financial trend should be the same. Daily prices after the close of the stock market include the net asset value and any dividends and capital gains declared.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 6 – Income Tax Status

The Plan utilizes a volume submitter plan document. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In preparing financial statements, plan management is required to evaluate tax positions taken by the Plan and disclose a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Related Party Transactions

The Company provides certain accounting and administrative services to the Plan for which no fees are charged. Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded as such in the accompanying Statement of Changes in Net Assets Available for Benefits (prepared on a modified cash basis). Certain expenses incurred in connection with the general administration of the Plan are paid by the Company, and therefore, qualify as party-in-interest transactions.

Certain investment options offered by the Plan are managed by Principal for year ended December 31, 2024 and Newport for the year ended December 31, 2023. Principal is the custodian of the Plan's assets, and, therefore, these transactions qualify as party-in-interest transactions. Newport was the custodian of the Plan's assets for the year ended December 31, 2023, and, therefore, these transactions qualify as party-in-interest transactions.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits (modified cash basis).
