Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Bluescape 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As described in Note 1 to the financial statements, the Plan was amended in July 2024 to terminate the Plan, which indicates that the Plan is not a going concern. Effective August 12, 2024, the Plan was terminated and contributions to the Plan ceased. Assets were fully liquidated by January 15, 2025 and the Plan ceased to exist. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to the participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audits.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules included in the accompanying table of contents are presented for purposes of additional analysis and are not a required part of the financial statements, but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by the qualified institutions agrees to or is derived from, in all material respects, the information prepared and certified by institutions management determined meet the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Description of the Plan

Thought Stream, LLC (the Company) established the Bluescape 401(k) Plan (the Plan) on January 1, 2014 to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan was amended in July 2024 to terminate the Plan. Effective August 12, 2024 (the Termination Date), the Plan was terminated and contributions to the Plan ceased. The Plan continued to operate subsequent to the Termination Date until January 15, 2025, which was the date all remaining assets were distributed to participants and the Plan ceased to exist.

General:

The Plan was a defined contribution plan with a salary deferral arrangement qualified under the appropriate provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As of August 12, 2024, Thought Stream, LLC, the Plan Sponsor, was dissolved by its parent company, Haworth, inc. (Haworth) and responsibility for the Plan was assumed by Haworth. The Plan was administered by Company employees, who were responsible for selecting investment options offered under the Plan and monitoring investment performance. Ascensus, LLC, and Ascensus Trust Company (collectively, Ascensus) were the Plan's trustee and record keeper. Ascensus held, invested and reinvested Plan assets in the interest and direction of the participants and their beneficiaries.

Eligible Participants:

Company employees, as defined by the Plan agreement, became eligible to participate in the plan on the first day of the month coinciding with or following their date of hire.

Contributions:

Participants were permitted to make voluntary pre-tax salary deferral and Roth post-tax contributions up to 100% of their annual eligible compensation, as defined by the Plan agreement. Participants who had reached the age of 50 could also elect to withhold additional "catch-up" contributions under the Code. Participants were also permitted to contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), excluding rollovers of after-tax contributions, subject to Code regulations.

Company contributions were not allowed under the Plan agreement. Contributions were subject to certain limitations under the Code.

1. Description of the Plan (continued)

Participant Accounts:

Participant accounts were credited with participant contributions, rollovers, and an allocation of the Plan's net earnings or losses. Allocations were based on participant earnings or account balances, in accordance with Plan provisions. The benefit to which participants were entitled is the benefit that could be provided from the participant accounts.

Participants could elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that were designed to provide the participants with a wide range of investment options. Participants can authorize transfers among investment options at any time.

Vesting:

Participants are fully (100%) vested in their accounts.

Notes Receivable from Participants:

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the Plan agreement. Note receivable transactions with participants qualified as party-in-interest transactions and were exempt from the prohibited transaction rules of ERISA.

Through the Termination Date, participants could borrow up to one-half of their account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which longer terms are permitted. Participants could only have one note outstanding at any time. Participant notes were evidenced by a written note, secured by the balance in the participant account, and bear interest at the prime rate, plus 2%. There were no participant notes outstanding as of December 31, 2024.

Payment of Benefits:

On termination of service for any reason, benefits were paid in a lump-sum cash distribution equal to the value of the participant accounts, in partial withdrawals, or in regular cash installment payments as determined by the participants. Participants who had reached age 59.5 were permitted to take in-service withdrawals of their account balances. Accounts between \$1,000 and \$7,000 were permitted to be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Account balances below \$1,000 were permitted to be automatically distributed directly to participants without participant approval. Benefits were recorded when paid.

1. Description of the Plan (continued)

Liability for Corrective Distributions:

Liability for corrective distributions represents contributions made by certain participants in excess of the allowable limit that must be refunded for the Plan to be in compliance with applicable non-discrimination tests. The December 31, 2023 liability of \$68,319 was refunded in 2024.

Administrative Expenses:

Several of the investment fund options were subject to fees based on a percentage of invested assets, as disclosed in each fund's prospectus. These fees were charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain administrative costs, as determined by the Company, are charged to the Plan and paid from Plan assets. The Company paid all other expenses related to the Plan, which are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants were permitted to invest their account balances in a variety of investment options offered by the Plan. Investments were exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it was at least reasonably possible that changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits in liquidation.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP) through the Termination Date. Upon Plan termination, the Plan's financial statements will be prepared under the liquidation method of accounting in accordance with GAAP.

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investments:

The Plan's investments consisted of mutual funds and a money market fund. These funds were valued at the net asset value of shares held by the Plan at year end, as quoted in active markets.

Fair Value Measurement:

The Plan used a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's investments were classified as Level I within the fair value hierarchy as of December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments were recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends were recorded on the ex-dividend date. Net appreciation included gains and losses on the Plan's investments bought, sold or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023.
- net income on the accompanying statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document had been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan was designed and was being operated in compliance with the applicable requirements of the Code and related state statutes and was, therefore, qualified, and the trust that formed a part of the Plan was exempt from federal and state income taxes.

GAAP required the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator had analyzed the tax positions taken by the Plan, and had concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

7. Subsequent Events

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
