### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fort Wayne Medical Education Program 403(b) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following brief description of the Fort Wayne Medical Education Program 403(b) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan.

#### **General**

The Plan is a defined contribution plan, covering substantially all eligible employees of Fort Wayne Medical Education Program (Company). The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Participants may contribute a portion of their compensation on a pre-tax or after-tax (Roth) basis each pay period, not to exceed certain annual dollar limitations that are set by law. Participants age 50 or older may elect to contribute additional amounts to the Plan up to a maximum that is set by law. Participants may also make qualified rollover contributions of amounts representing distributions from another qualified retirement plan or an Individual Retirement Account (IRA).

Pursuant to the matching feature of the Plan, the Company may make a discretionary match equal to a uniform percent or dollar amount of participants' elective deferrals up to \$3,500 per employee in 2024. Additionally, the Company may make discretionary nonelective contributions to the Plan. The nonelective contribution for the plan year was 5 percent of eligible compensation, until it was discontinued on March 1, 2024.

The Plan allows participants to increase or decrease the amount of their contribution as of a designated election date or stop making salary deferrals at any time and to direct the investment of their account balances and contributions on a daily basis. Participants are currently permitted to divide their contributions among the various investment funds in one percent increments. Participant contributions are recognized when due through salary withholding.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's matching and nonelective, if any, contributions and is credited or charged with an allocation of investment earnings or losses and Plan expenses.

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Participant Accounts (continued)**

Investment income of the guaranteed deposit fund and each mutual fund (including appreciation and depreciation in the fair value of each mutual fund) is allocated to participant accounts at the end of each business day based upon the ratio of each participant's account to the total of the fund balance.

##### **Notes Receivable from Participants**

Participants may borrow amounts from the Plan that shall be for a minimum of \$1,000 and up to a maximum of the lesser of (a) one-half of the value of the participant's account or (b) \$50,000 reduced by the excess of the participant's highest outstanding loan balance during the one-year period ending on the date of the loan over the participant's current outstanding participant loan balance on the date of the loan. The term of the loan is up to five years with a minimum loan term of 12 months. However, if the purpose of the loan is to acquire or construct the primary residence of the participant, the period of repayment may extend beyond five years. Loan payments are made to coincide with the loan applicant's payroll frequency. A loan is secured by the balance in the participant's account and bears interest at two percent over the prime rate as of the date of the disbursement of the loan proceeds. Prepayment of the entire remaining loan balance is permitted. No more than one loan per participant may be outstanding at any time. Should the participant terminate as an employee of the Company, the balance of the outstanding loan (including any accrued interest) becomes immediately due and payable.

##### **Vesting**

Participants are immediately vested in their contributions, including rollover contributions and employer matching and nonelective contributions plus actual earnings or losses thereon.

##### **Payment of Benefits**

Upon termination of employment, a participant with a vested account balance exceeding \$5,000 may receive a distribution equal to the vested value of his or her account as soon as administratively feasible following their termination of employment. A participant may elect to receive the distribution of their entire vested account balance in cash or to roll over their distribution to an IRA or another qualified plan. Certain investment products may provide additional distribution options. The Plan provides that if a participant terminates employment and their vested benefit is \$5,000 or less their entire vested benefit will be distributed to the participant in a lump-sum. Participants who die before taking a distribution of their entire vested account balance will have their remaining balance distributed to their beneficiary or beneficiaries.

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Payment of Benefits (continued)**

The Plan also provides for certain hardship withdrawals and participant loans as previously described. Distributions of benefits are recorded as withdrawals from the Plan and a reduction of assets available for plan benefits in the period paid to the participant.

##### **Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### **Investments**

The Plan's investments are reported at fair value including the guaranteed deposit account reported at net asset value (NAV) as a practical expedient. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

The Plan includes in the statements of changes in assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments.

The underlying investments of the various mutual funds are invested in diverse portfolios with no significant concentration of risk by issue, industry, or geographic location.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related loan origination and annual administration fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **Administrative and Other Expenses**

The Plan will pay some or all Plan related expenses. The expenses charged to the Plan may be charged pro rata to each participant. Administrative expenses are recognized when incurred. Expenses of maintaining the Plan paid directly by the Company are excluded from these financial statements.

##### **Use of Estimates**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits and the statements of changes in assets available for benefits.

#### 3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments and interest, dividends, and investment expenses for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Newport Trust Company, LLC.

#### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### 4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed deposit fund:* Valued at the NAV of units of a guaranteed deposit fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities, and then divided by the number of shares outstanding. The Standard Insurance Company Stable Asset Fund III (Fund) is an interest-bearing account with the goal of conservation of principal. The Standard Insurance Company invests contributions and transfers as part of its general assets. Investment return is determined by the declared interest rate, not by the investment performance of Standard Insurance Company's general assets. All participants in the Plan earn the same interest rate, which is a weighted average of the interest rates on Plan assets over the preceding five years. Interest is accrued daily and compounded quarterly. The Fund invests in a portfolio of high quality bonds with short- to intermediate-term maturities. The Fund provides daily liquidity for participant contributions, transfers, and withdrawals. The guaranteed crediting rate is declared in advance and is reset quarterly. The declared crediting rate will never be below 1 percent. Principal and interest are guaranteed by Standard Insurance Company. The Fund has no unfunded commitments as of December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Tax Status

The plan administrator believes that the Plan, as amended, is being operated in compliance with the applicable requirements of Section 403(b) of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt and the Plan has no income subject to unrelated business income. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions it has taken or expects to take that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to December 31, 2021.

#### **6. Transactions with Parties-in-Interest**

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Newport Group provided certain participant accounting, recordkeeping, and other services for the Plan. Newport Trust Company, LLC provided custodial services. Fees paid during the year for accounting, recordkeeping, and other custodial services rendered by these parties-in-interest were based on customary and reasonable rates for such services.

#### **7. Subsequent Events**
