We have performed audits of the financial statements of Plus Relocation Services, LLC 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plus Relocation Services, LLC 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the Plus Relocation Services, LLC 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a defined contribution plan which was established on January 1, 1996 and last amended effective May 1, 2021. The Plan covers substantially all employees (other than employees covered by a collective bargaining agreement, nonresident aliens, interns, and temporary employees) of Plus Relocation Services, LLC and PRS Holdings, LLC (the Company) who have completed one month of service and have attained age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions

Each year, participants may contribute up to the maximum allowable not to exceed the limits of Internal Revenue Code (IRC), as defined in the Plan, of pre-tax annual compensation (or post-tax compensation for the Roth portion of the 401(k) plan.) Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan. Each new participant will have 3% of eligible compensation contributed to the plan as an employee deferral, unless a different deferral is elected by the participant.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Contributions (Continued)

The Company may contribute to the Plan discretionary matching and/or non-elective contributions. Matching contributions, if any, are determined annually and may be a percentage of compensation or a fixed dollar amount. In addition, each year the Company may contribute a non-elective contribution to the Plan. The Company's non-elective contribution, if any, is allocated to participants eligible to share in the contribution based upon the percentage calculated by dividing the participant's eligible plan compensation by the total eligible plan compensation of all eligible participants. Participants direct the investment of their matching and/or non-elective contributions into various investment options offered by the Plan. The Company's contributions do not exceed the maximum amount deductible by the Company under the regulation of the IRC. The Company did not declare a non-elective profit-sharing contribution for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant elective deferrals, discretionary matching and profit-sharing contributions (if any) and an allocation of Plan earnings and expenses. Allocations of Plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. Participants' accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the participant's highest outstanding loan balance in the previous twelve months and the existing loan balance. Participants may only have one loan outstanding at any point in time. Loan terms range from one to five years for general purpose loans or five to fifteen years for loans for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate of 2% over the Wall Street Journal Prime Rate of interest at the time of the loan. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document. Interest rates on loans outstanding as of December 31, 2024 ranged from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit sharing and matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested in their account after 6 years of service, upon reaching age 65, upon death or upon permanent disability. Termination of employment before any of the above occurs activates the following vesting schedule for the profit sharing and matching portions of their accounts:

Forfeited Accounts

Terminated participants forfeit their non-vested balance upon the earlier of the receipt of their vested benefits or after incurring five consecutive one-year breaks in service. Forfeitures are used by the employer to reduce profit sharing or matching contributions or pay plan expenses. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$25,341 and \$30,216, respectively. Forfeitures in the amount of \$3,717 and \$21,399 were used to reduce employer contributions or pay plan expenses in 2024 and 2023, respectively.

As of December 31, 2024 and 2023, forfeited non-vested amounts totaling \$47,275 and \$25,050 respectively, were available to reduce future employer contributions or pay plan expenses.

Payment of Benefits

Upon termination of employment, death, disability or reaching normal retirement age (65), participants or their beneficiary(ies), where applicable, may receive the value of the accrued vested benefit in the form of a lump sum payment; or if the balance exceeds \$5,000, may elect to defer the distribution in accordance with Plan guidelines. If the participants' vested account balance is less than \$5,000, the Plan will distribute the participant's vested account balance in a lump-sum payment.

The Plan allows for hardship withdrawals from the employee elective deferral portion of the participant's account. The Plan does not allow for other in-service distributions of elective deferrals, employer matching contributions, employer qualified nonelective contributions (if any) or Plan earnings, unless the earlier of age 59½ or normal retirement age has been reached. In-service distributions of rollover account balances are allowed at any time. Benefit payments are recorded upon distribution to participants.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Administrative Expenses

The Plan or Plan Sponsor pays certain administrative expenses on behalf of the Plan. Distribution processing fees are deducted from the benefits paid to participants and are shown as plan expenses along with certain recordkeeping and investment related expenses.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Certification of Investments

The Trustees of the Plan appointed Empower Trust Company, LLC and Empower Annuity Insurance Company of America as Custodians of the Plan's assets. Empower Trust Company, LLC and Empower Annuity Insurance Company of America have supplied the Plan Administrator with certifications as to the completeness and accuracy of Plan investments (including notes receivable from participants) aggregating \$11,627,060 and \$15,867,672 as of December 31, 2024 and 2023, respectively, and the related investment income and interest on notes receivable from participants of \$1,911,170 and \$2,437,326 for the years ended December 31, 2024 and 2023, respectively. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule based on the certifications from Empower Trust Company, LLC and Empower Annuity Insurance Company of America.

Under the terms of the Custodial agreement, the Custodians manage investment funds on behalf of the Plan. The Custodians have been granted discretionary authority concerning the purchases and sales of the investment of the investment funds.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs of unobservable inputs that are corroborated market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

General account investments: Fair value represents the value the Plan would receive if the various contracts were terminated, which is book value less any early withdrawal charges.

3. Fair Value Measurements (Continued)

The methods described on the previous page and below may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants or their beneficiaries are entitled to a distribution of 100% of their account balances in all funds.

5. Plan Tax Status

The Company adopted a non-standardized 401(k) Profit Sharing Plan and Trust which received a favorable opinion letter from the Internal Revenue Service which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The non-standardized 401(k) Profit Sharing Plan and Trust has been amended since receiving its determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Plan management evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal tax returns generally remain open for three years.

6. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Party-in-interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the Custodians of a portion of the Plan's assets and manage certain Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

7. Party-in-interest Transactions (Continued)

The Plan issues loans to participants, which are secured by the participant account balances. These qualify as party-in interest transactions but are permitted under ERISA regulations. Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.
