To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SFH, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

1. Description of Plan

The following brief description of the SFH, Inc. 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

General

The Plan was created by an agreement between SFH, Inc. (the "Company") and the trustees dated May 5, 1997 to provide retirement benefits for eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), and the Internal Revenue Code (IRC). Effective January 1, 2021, the Plan was amended in its entirety and adopted the Pentegra Services, Inc. Non-Standardized Defined Contribution Pre-Approved Plan.

The Plan also covers employees of Fargo Jet Center LLC, Weather Modification LLC, and Exclusive Aerospace LLC, related companies through common ownership.

Plan Operation

The Company is the Plan sponsor and administrator of the Plan. Empower is the Plan recordkeeper, trustee and custodian (the "Custodian" or "Trustee").

Eligibility

Substantially all employees, who are not covered by a collective bargaining agreement, are eligible for participation in the Plan. Employees who have completed one month of service become eligible to make salary deferrals to the Plan. An employee can become a participant in the Plan on the first day of the payroll period coinciding with or next following the date of becoming eligible for participation.

Employees must complete one year of service and reach the age of 21 to become eligible for the safe harbor matching. Employees must complete one year of service to become eligible for employer matching. Employees must complete one year of service and reach the age of 18 to become eligible for employer profit contributions. An employee can become a participant in the employer contributions on the first day of the payroll period coinciding with or next following the date of meeting eligibility requirements.

Contributions

Participants may elect to contribute a percentage of their eligible compensation up to 100 percent on a pre-tax basis to the 401(k) portion of the Plan. Participants are automatically enrolled on their eligibility date to contribute two percent of compensation, unless the participant elects a different percentage (including zero). After participants become subject to the initial two percent automatic deferral amount, the automatic deferral amount will increase by one percent annually (unless the participant elects a different percentage) but will not exceed five percent of compensation.

Participants may elect to make Roth contributions to the Plan.

The Company makes safe harbor matching contributions on behalf of all eligible participants who elect to make salary deferral contributions. The safe harbor matching contribution is 100% of each participant's salary deferrals that do not exceed 3% of total compensation, plus 50% of salary deferrals that exceed 3% but do not exceed 5% of total compensation. Safe harbor contributions were approximately \$502,000 for 2024.

The Company may also make a discretionary additional matching contribution. The total amount of this discretionary additional match contribution will not exceed 4% of compensation. There was no discretionary additional match contribution for 2024.

The Company may annually make a profit sharing contribution to the Plan. This contribution is allocated to participants' accounts according to a formula based upon compensation. There was no profit sharing contribution made by the Company for 2024.

Contributions (Continued)

Contributions are subject to a compensation ceiling and annual limitations prescribed by the IRC.

The Plan allows for rollover and catch-up contributions.

Vesting

Participants are immediately vested in their voluntary contributions, safe harbor match contributions, and rollover contributions plus actual earnings thereon.

The participant's vesting in employer discretionary additional match contributions and profit sharing contributions is twenty percent per year for each of the first through fifth year of service until fully vested. A participant's account also becomes fully vested upon reaching normal retirement age of 65, or upon death, disability, or termination of the Plan.

Forfeited Accounts

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future employer contributions to the Plan. At December 31, 2024 and 2023, forfeited amounts were approximately \$7,000 and \$5,000, respectively. The Plan used approximately \$2,000 to pay safe harbor contributions during the year ended December 31, 2024.

Investment Allocation

Assets of the Plan are held in various funds as determined by the Company. All accounts are participant directed. Participants may change their investment allocation daily.

Net investment gains and losses are allocated based on participant balances in each fund.

Payment of Benefits

A participant's vested benefit is distributed upon death, disability, retirement, or termination of employment as soon as administratively feasible following the date on which a distribution is requested or otherwise payable; in either a lump-sum amount or partial withdrawals or installments for participants who must receive required minimum distributions. The distribution will be involuntarily distributed if the vested account balance does not exceed \$5,000. If the amount of the distribution exceeds \$1,000 and the participant does not elect to either receive or roll over the distribution, the distribution will be rolled over to an individual retirement account established for the benefit of the participant.

In-service distributions are allowed under the Plan upon attainment of age 59 1/2.

The Plan allows for hardship distributions.

Notes Receivable From Participants

Participants are permitted to borrow up to 50 percent of their vested account balance with a minimum of \$1,000 up to a maximum loan amount of \$50,000. Only one note may be outstanding at any given time. The notes are secured by up to 50 percent of the participant's vested account balance. Notes receivable from participants have a term of five years or less, except for the purchase of a principal residence as permitted by IRS regulations and in accordance with Plan provisions. Notes receivable from participants are also subject to the deduction of certain origination and processing charges. The interest rate on notes shall be determined by the Plan Administrator based on terms as described in the Plan document. Upon termination of employment, the outstanding balance of a note becomes immediately payable. At December 31, 2024, the notes bear interest at 4.25% to 9.50% and mature at various dates through 2029.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of Plan termination, participants will become fully vested in their account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Accounting Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in assets available for benefits during the reporting period, and the changes therein, and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates; the effect of any changes could be material.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction (that is, not a forced liquidation or distressed sale) between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented in the net appreciation/depreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Company at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Registered investment companies - mutual funds are valued at the net asset value (quoted prices) of shares held by the Plan at year end.

The Plan invests in investment contracts through a collective trust. The collective trust is valued at fair value using the net asset value ("NAV") as a practical expedient. The collective trust's fair value is calculated using the NAV per share. The collective trust has no unfunded commitments and has a daily redemption frequency.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Contributions

Participant contributions are recorded when the Company makes the payroll deduction. Safe harbor matching and discretionary additional matching contributions, if any, are recorded in the same period as the participant contribution. Company profit sharing contributions, if any, are recorded in the period the Company authorizes the nonelective contribution.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

The Plan is responsible for paying substantially all administrative and investment transaction expenses.

Subsequent Events

In preparing these financial statements, Plan management has evaluated subsequent events and transactions for potential recognition or disclosure through October 15, 2025, the date which the financial statements were available to be issued.

3. Certified Investments

At December 31, 2024, the Plan's investments were held by Empower Trust Company LLC, the Custodian. The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i - Schedule of Assets (Held at Year End) as of December 31, 2024.

The Plan Administrator instructed its independent auditors not to perform, and they did not perform, any auditing procedures with respect to the information certified by the Custodian, except for comparing the information with the related information included in the financial statements and supplemental schedule.

5. Risks and Uncertainties

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and participant accounts.

6. Party-In-Interest Transactions

Notes receivable from participants qualify as party-in-interest transactions. The recordkeeper receives revenue sharing from certain investment funds for administrative services it provides. However, ERISA regulations provide an exemption for such transactions.

7. Tax Status

The Pentegra Services, Inc. Non-Standardized Defined Contribution Pre-Approved Plan has obtained an Internal Revenue Service opinion letter dated June 30, 2020 in which the Internal Revenue Service stated the plan document satisfies the applicable provisions of the Internal Revenue Code.

Due to the tax exempt status of the Plan, the Plan does not have any significant tax uncertainties that would require recognition or disclosure. The Plan is currently not subject to an examination of its tax returns by any taxing authority. The Plan is no longer subject to income tax examinations for the years before 2021.
