In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Computer System Center Inc 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Other Matters

##### 2024 Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year), as of December 31, 2024, is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

BSB combined with PBMares, LLP effective October 1, 2024. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 15, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). ## NOTES TO FINANCIAL STATEMENTS

### NOTE 1 – *Description of Plan*

The following description of the Computer Systems Center, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### General

The Plan was established on January 1, 1996, and amended and restated on January 1, 2024. The Plan is a defined contribution plan intended to qualify under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Act of 1974 (ERISA). The Plan covers all employees of the Plan Sponsor, except union employees and non-resident aliens. Employees may become participants on the first day of the month coinciding with or following the date eligibility requirements are met.

Reliance Trust Company is the Plan trustee and T. Rowe Price is the Plan record keeper. Members of management of the Plan Sponsor serve as the authorized Plan representative and Plan administrator.

#### Contributions

Each year, participants may contribute up to 90% of pretax annual compensation subject to the limitations of the IRC, as defined in the Plan. The Plan allows participants to make Roth 401(k) contributions. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as rollover contributions. Participants are immediately vested in their salary reduction and rollover contributions plus actual earnings thereon.

Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. Participants are immediately vested in their salary reduction and rollover contributions plus actual earnings thereon.

The plan sponsor contributes 50% of the amount of the first 6% of base compensation that a participant contributes to the Plan. In no event, however, will matching contributions be greater than \$2,000 for a Plan year. For the Plan year ended December 31, 2024, the Plan Sponsor made contributions of \$303,605. Vesting in the Plan Sponsor's contributions' portion of their account plus earnings thereon is based on years of continuous service. A participant is vested 50% each year after the first year of service and is 100% vested after two years of credited service.

The Plan Sponsor may designate all or a portion of any matching contributions as "qualified non-elective contributions" or "qualified matching employer contributions" and allocate them to help the Plan pass required IRC nondiscrimination tests. Only non-highly compensated employees are eligible for the qualified non-elective contribution. Participants are 100% vested in these contributions but may not request a hardship withdrawal with these funds. For the year ended December 31, 2024, the Company made no qualified non-elective contributions. The Company may also make additional contributions to the Plan at its sole discretion. For the year ended December 31, 2024, no such contributions were made.

#### NOTE 1 – *Description of Plan, Continued*

##### Participant Accounts

Each participant's account is credited with the participant's salary deferral contribution, rollovers (transfers in from other qualified plans), and allocations of (a) Company contributions, (b) Plan earnings, (c) realized and unrealized gains and losses on investments, and (d) administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of (1) \$50,000 reduced by the highest outstanding Plan loan balances during the year preceding the date of the loan, or (2) 50% of their vested account balance. The number of loans a participant may have outstanding is limited to two. All loans are for a period not exceeding five years unless funds are used to purchase a principal residence. All loans must be approved by the Plan administrator and will bear interest at a rate commensurate with local prevailing rates. As of December 31, 2024, interest rates on participant loans ranged from 4.25% to 9.50%. Loans are secured by the balance in the participant's account. Principal and interest are paid ratably through semi-monthly and monthly payroll deductions through May 27, 2029.

##### Forfeited Accounts

Upon termination of employment, participants forfeit the non-vested portion of the participants' employer contributions. Forfeitures can be used to reduce the Company's contributions to the Plan first; any remaining amounts are used to reduce the administrative expenses. Forfeitures of \$28,562 were used to reduce the employer contributions for the year ended December 31, 2024. The forfeiture balances as of December 31, 2024 and 2023 were \$14,769 and \$2,461, respectively.

##### Payment of Benefits

Participants are eligible for retirement benefits upon attaining the age of 65 or early retirement, defined as age 59 ½, and five years of service. On termination of service due to death, disability or retirement, a participant may receive an amount equal to the value of the participant's vested interest in their account in a lump-sum amount or periodic payments. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or elect a direct rollover distribution. However, if the total value of the vested balance is \$1,000 or less, the entire vested balance will be distributed in a lump sum payment. If the vested balance is greater than \$1,000 but less than \$5,000, the value of the vested interest in their account may be distributed through a direct rollover. Benefit payments to participants are recorded when paid.

The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw part or all their vested account balances while actively employed. These hardship withdrawals are subject to IRC restrictions and penalties. Participants may withdraw part or all their vested account balances while actively employed.

##### Investment Options

Participants are afforded several investment options covering a wide range of investment objectives and risk. Participants may allocate their contributions across these options in any proportion they wish and can change this allocation at any time. Transfers of account balances between elected investment options may also be made at any time.

#### NOTE 2 – Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

##### Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for additional information related to fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Earnings and interest from investments are recorded as earned using the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value includes the Plan's gains and losses investments bought and sold as well as held during the year.

##### Administrative Expenses

The Plan Sponsor may elect to pay the administrative expenses of the Plan. If not paid by the Company, administrative expenses are required to be paid by the Plan. All such costs and expenses will, unless allocable to the accounts of particular participants, be charged against the accounts of all participants on a pro-rata basis or in such other reasonable manner as may be directed by the Plan Sponsor. Certain accounting and administrative functions of the Plan are performed by employees of the Plan Sponsor at no cost to the Plan. Investment related expenses are included in net appreciation/depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

##### Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. The Plan has determined that there are no subsequent events pursuant to the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

#### NOTE 3 – *Information Prepared and Certified by Trustee*

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### NOTE 4 – *Fair Value Measurements*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### NOTE 4 – *Fair Value Measurements, continued*

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** The Plan’s shares of mutual funds are valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at each year end. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1.

**Money Market Funds:** Money market funds are valued at quoted process in an active market, which represents the net asset value (NAV) of shares held by the Plan at each year end and classified as Level 1.

**Common Collective Trusts:** Valued using the NAV per share practical expedient where the NAV of units held by the Plan are based on the fair value of the underlying investments.

The preceding methods could produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 6 – Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, DST Retirement Solutions LLC, has received on June 30, 2020, an opinion letter from the Internal Revenue Service as to the plan’s qualified status. The pre-approved plan opinion has been relied upon by the Plan. The Plan has since been amended and restated and the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 7 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

### NOTE 8 – Related Party and Parties-In-Interest Transactions

Certain Plan investments are managed by the record keeper, T. Rowe Price, therefore these transactions qualify as party-in-interest transactions, as defined by ERISA. Fees paid to the record keeper in administrative expenses during the year ended December 31, 2024 were \$104,765. The Plan also issues loans to participants, which are secured by vested balances. These transactions qualify as party-in-interest transactions.

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. Such transactions qualify as parties-in-interest transactions.

### NOTE 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
