## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator  
Curtis-Toledo, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Curtis-Toledo, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Curtis-Toledo, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Curtis-Toledo, Inc. (the Company and Plan Sponsor) and participating employers. All employees of the Company, excluding employees covered under a collective bargaining agreement, who have one consecutive month of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

EPIC Retirement Plan Services provides recordkeeping services to the Plan. Charles Schwab Trust Bank is the custodian of the Plan's investments. The Plan is administered by the Company. Members of the Company's senior management are the Trustees, who have overall responsibility for the operation and administration of the Plan. The Trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Effective July 15, 2024, the Plan was amended to automatically enroll eligible employees with a deferral contribution of 5% unless the employee elects otherwise. The automatic deferral percentage will increase by 1% per year up to a maximum of 10% of eligible compensation.

**Contributions**

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Company makes a safe harbor matching contribution 100% of the first 3% of eligible compensation plus 50% of the participants' contributions between 3% and 5% of eligible compensation, beginning on the first day after an employee has met the eligibility requirements. Discretionary profit sharing contributions are determined annually by the Company's Board of Directors. Profit sharing contributions are allocated to each participant based upon the ratio of the participant's compensation to the total compensation for the Company. There were no profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to Internal Revenue Service (IRS) limitations. Participants of the Plan elect investment accounts in which their contributions, as well as employer contributions, are invested. The investment account options comprise various degrees of risk and return.

Each participant's account is credited with the participant's contribution, employer matching contribution, and profit sharing contributions plus investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is 1% above the prime rate. Principal and interest are paid ratably through monthly payroll deductions.

**Vesting**

Participants are vested immediately in their contributions and employer safe harbor matching contributions. Vesting in the discretionary profit sharing contribution portions of their accounts is based on years of service, as follows:

Less than 2	0%
2	20%
3	40%
4	60%
5	80%
6 or more	100%

A participant is 100% vested in all accounts upon reaching plan retirement age, early retirement age, death or disability.

**Payment of Benefits**

On termination of service, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either lump-sums, substantially equal installments or partial withdrawals, depending on the size of the participant's account balance at the time of distribution. Participants with a vested account balance of less than \$7,000 must take a lump-sum distribution.

The Plan Sponsor may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from a participant's pre-tax deferral and Roth deferral contribution accounts and are subject to specific statutory and regulatory requirements. Rollover contributions may be withdrawn at any time. In-service distributions from elective deferral contributions are permitted after the participant has attained age 59½ and from all accounts at age 65 (normal retirement age).

**Forfeited Accounts**

Forfeited balances of terminated participants' nonvested accounts may be used to reduce employer contributions or to pay administrative expenses. For the year ended December 31, 2024, forfeitures of \$10,476 were used to reduce employer contributions. Forfeited nonvested accounts were \$4,931 and \$15,031 at December 31, 2024 and 2023, respectively.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from participants are recorded in the period in which they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant's wages are paid.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

**Subsequent Events**

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — CERTIFIED INVESTMENTS**

Information related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Charles Schwab Trust Bank, the custodian of the Plan.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

**NOTE 4 — FAIR VALUE MEASUREMENTS (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the fund, which is the quoted NAV of shares.

*Common/collective trusts:* Valued at the NAV of the fund, which is based on the estimated market value of the underlying investments. The stable value common/collective trust invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value.

**NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS**

Charles Schwab, the custodian of the Plan, is paid for investment management services through the administrative fee paid to the Plan's record keeper, EPIC Retirement Plan Services. These transactions are party-in-interest transactions. Fees paid by the Plan for the contract administration and recordkeeping services amounted to \$56,735 for the year ended December 31, 2024.

**NOTE 6 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their company contributions.

**NOTE 7 — TAX STATUS**

As this Plan is a non-standardized pre-approved profit sharing plan, the Internal Revenue Service issued an advisory letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this Plan will be considered to have a plan qualified under code Section 401(a) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the non-standardized plan agreement.

The Plan is subject to examination by the IRS for the statutory period.

**NOTE 8 — DELINQUENT CONTRIBUTIONS**

During the year ended December 31, 2024, the Company failed to remit to the Plan's trustee/custodian certain employee contributions totaling \$105,935 within the period prescribed by the Department of Labor's regulations. The delay in remitting contributions to the trustee/custodian was due to administrative error. The Company intends to fully restore affected participants' accounts for potential lost income due to the delays.

**NOTE 9 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
