Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PATH Corporation 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

NOTE A - DESCRIPTION OF THE PLAN

The following description of the PATH Corporation 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of PATH and affiliates (the “Employer”) and meets the requirements for plan qualification under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Eligibility

All employees are eligible to participate in the Plan except non-resident aliens. Participants are eligible to make deferral contributions on their first day of employment. All eligible employees who have reached age 18 and have completed two years of service are eligible to receive Employer contributions, subject to monthly entry dates. For purposes of eligibility, a participant must complete 1,000 hours during the applicable 12-month period, as defined, to earn a year of service. Employees covered under a collective bargaining agreement, non-resident aliens and leased employees are excluded from Employer non-elective contributions.

3. Contributions

Participants may elect to contribute on a tax-deferred basis and/or make Roth contributions, up to the maximum deferral limit per Section 402(g)(1) of the IRC. Participants who reach age 50 by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from another eligible retirement plan or IRA, as defined. The Employer may also make discretionary non-elective contributions. The Employer made a non-elective contribution of 5% of each participant’s plan compensation during the year ended December 31, 2024.

4. Investment Options

Investments are held with American Funds and Nationwide Trust Company, FSB (“Nationwide Trust Company”). The Employer remits all new contributions to participants’ accounts held with Nationwide Trust Company. A participant may direct all such contributions, as desired, in any of a variety of investment options offered by Nationwide Trust Company, as chosen by the Employer. Participants may change their investment options daily. Additionally, participants may transfer and direct existing American Fund balances to any of a variety of investment options held by Nationwide Trust Company.

5. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Employer non-elective contributions and plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

6. Vesting

Participant contributions and Employer contributions and actual earnings on all such contributions are fully vested at all times.

7. Forfeitures

Forfeitures attributable to excess Employer contributions may be used to pay reasonable plan expenses or reduce Employer contributions. Outstanding forfeitures available at December 31, 2024 and 2023 were \$26,885 and \$25,390, respectively.

8. Notes Receivable from Participants

Participants may borrow from their account a minimum of \$500 up to a maximum of 50% of their vested account balance, not to exceed \$50,000. Participants may not have more than two loans outstanding at any time. Loans bear interest at two percentage points higher than the prime interest rate. Loans must be repaid within five years of the date of issuance. Loans for the purchase of a principal residence can be repaid over a longer term as defined by the plan agreement.

9. Benefit Payments

Upon termination of service or retirement, or in the event of disability or death, a participant or a participant's beneficiary is entitled to receive the total value of the participant's account balance. Distributions are made in the form of a lump sum. In-service and hardship distributions are permitted if certain criteria are met.

10. Plan Termination

Although it has not expressed such intent, the Employer reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan would cease and the assets of the Plan would be distributed to the participants in accordance with the provisions of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

2. Plan Administration

The Employer is the plan sponsor and the plan administrator. The administrator of the Plan is responsible for carrying out the duties imposed under ERISA.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

5. Payment of Benefits

Benefits are recorded when paid.

6. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

8. Contributions

Contributions from Plan participants and the contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INVESTMENTS

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company (a custodian of the Plan) as follows:

- Investments totaling \$15,890,393 and \$12,387,974 are reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, respectively
- Net investment activity of \$1,862,262 reflected in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024
- Investments of \$15,890,393 reflected on the Schedule of Assets (Held at End of Year)

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market. The Plan holds certain mutual funds through custodial programs and thus follow unitized valuation processes that result in the investment being valued within Level 2.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Nationwide Trust Company and American Funds. Nationwide Trust Company and American Funds are custodians and recordkeepers for the Plan and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Asset Available for Benefits.

NOTE G - TAX STATUS

The Employer is a tax-exempt organization under IRC Section 501(c)(3). The Employer adopted a volume submitter 403(b) plan which received a favorable opinion letter dated March 31, 2017, in which the Internal Revenue Service (IRS) stated that the volume submitter 403(b) plan is in compliance with the applicable requirements of the IRC. The plan administrator and advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the administrator in accordance with applicable IRS correction programs. Therefore, the plan administrator believes that the Plan was qualified and no provision for income taxes has been reflected in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - SUBSEQUENT EVENTS

Effective September 9, 2025, the Plan terminated its contract with Nationwide Trust Company, as custodian and recordkeeper. As a result, all Nationwide Trust Company Plan investments were transferred from Nationwide Trust Company to Empower Trust Company, LLC, the successor custodian and recordkeeper for the Plan on September 9, 2025.

NOTE H - SUBSEQUENT EVENTS (Continued)

Effective September 9, 2025, the Plan was amended and restated to include Employer matching contributions with an eligibility requirement of attaining age 18 and completion of one year of service. Employer non-elective contributions was modified from two years of service to one year. In addition, the service requirement for the Employer contribution vesting schedule was modified from 100% vested to 50% after the first year of service and 100% thereafter.

Plan management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
