## Independent Auditor's Report

To the Plan Administrator and Participants  
Moda Partners, Inc. Employee Retirement Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Moda Partners, Inc. Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Moda Partners, Inc. Employee Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024 AND 2023**

**1. Description of Plan**

The following description of the Moda Partners, Inc. Employee Retirement Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution savings and profit sharing plan established December 30, 1977 by Moda Partners, Inc. (the “Company” or “Plan Sponsor”), under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company and its related employers. The Plan is administered by the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

b. Eligibility

Employees of the Company are eligible to make elective deferrals after completing 90 days of continuous employment (except union employees whose employment is governed by a collective bargaining agreement and non-resident aliens). There is no age requirement to participate in the Plan. Participants enter the Plan on the first day of the month coinciding with or after meeting the service requirements. Participants are eligible to receive employer contributions after completing one year of employment during which they complete 1,000 hours of service.

Effective December 31, 2022, the Plan credits all employees’ service from Ardon Health and Emerging Health as related employer service and the assets of the participants were transferred out of the Plan in 2023.

c. Participant Contributions

Participants may elect to contribute a percentage of their eligible compensation on a pre-tax or post-tax (Roth) basis as prescribed in the Plan document subject to the limits of the IRC. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC. Eligible employees or participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans into the Plan. The Plan includes an automatic enrollment feature. All employees of the Company meeting the eligibility requirements are automatically enrolled with a 3% deferral rate with an automatic escalation clause of 1% per year up to a maximum of 10% of eligible compensation, unless the participant affirmatively elects otherwise.

d. Employer Contributions

Eligible participants employed on the last day of the Plan year and who have completed at least 1,000 hours of service during the Plan year are eligible to receive the Company’s discretionary

non-elective and matching contributions. During 2024 and 2023, the Company made a fixed contribution to the Plan in the amount of 3% of each eligible participant's eligible earnings, as defined by the Plan. Additionally, for the 2024 and 2023 Plan years, the Company matched participants' contributions up to 2%, 4% or 6% of eligible earnings based on years of service of less than 5 years, between 5 and 10 years and more than 10 years, respectively. Company contributions are allocated to each participant based on the participant's contribution allocation.

e. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. Participants can direct their account into a variety of investments offered by the Plan. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant's vested account.

f. Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. The Company's discretionary non-elective and matching contributions vest as follows: 20% after two years of cumulative service, 40% after three years of cumulative service, 60% after four years of cumulative service and 100% after five years of cumulative service. A year of cumulative service is credited when the participant has completed a minimum of 1,000 hours. Additionally, a participant's interest is fully vested in the event of death, termination as a result of permanent and total disability or retirement at age 65 or older.

g. Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account balance. Participants who are no longer employed by the Company and have reached 72 years of age can elect to receive their benefit in lump-sum, installment payments and partial distributions. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Company, at its discretion, can immediately distribute to a participant their vested account upon termination of employment if it does not exceed \$1,000. For account balances greater than \$1,000 but less than \$5,000, the Company can distribute the vested balance to an individual retirement account for the benefit of the participant. In 2024, the limit was increased to less than \$7,000.

h. Forfeitures

Participants who terminate employment forfeit the non-vested portion of Company discretionary non-elective and matching contributions and earnings thereon. At December 31, 2024 and 2023, forfeitures totaling approximately \$41,000 and \$8,000, respectively, were available to reduce future Company contributions or pay Plan administrative expenses. Forfeitures totaling approximately \$131,000 and \$189,000 were utilized to reduce Company contributions or pay administrative expenses during 2024 and 2023, respectively.

i. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their elective deferrals as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of

the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

j. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, subject to a \$1,000 minimum and certain other restrictions. Loans are secured by the vested account balance of the participant. Loans are repayable through payroll deductions over periods ranging up to five years, unless the loan is used to acquire a principal residence, in which case the loan term may be for a longer period of time. Loans bear a fixed, reasonable rate of interest as determined by the Plan Administrator. The interest rate on outstanding loans at December 31, 2024 ranges from 3.25% to 8.50% and the loans mature through 2034.

**2. Summary of Significant Accounting Policies**

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

d. Contribution Receivables

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company or the participants. Contribution receivables are recorded at cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

e. Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. The Plan does not establish an allowance for credit losses on notes receivables since the receivables are fully secured by the participants' contributions to the Plan.

Delinquent notes receivable from participants may be treated as a deemed distribution based on the terms of the Plan document.

f. Payment of Benefits

Benefits are recorded when paid.

g. Administrative Expenses

The Company pays certain administrative fees of the Plan, including legal, trustee and audit fees. Direct expenses paid by the Plan for investment management and recordkeeping were approximately \$307,000 and \$301,000 for the years ended December 31, 2024 and 2023, respectively. Certain expenses are included in the transaction prices of investments bought and sold and are not separately quantifiable. The Plan charges certain loan and distribution fees to the impacted participants.

**3. Investments**

Plan assets are held by Charles Schwab Trust Bank. Participants can direct their accounts among various mutual funds and a common collective trust.

The Galliard Stable Return Fund Class C (“SRF”) is a common collective trust fund managed by Galliard Capital Management, LLC, who is also the trustee. The SRF invests in the Galliard Stable Return Fund Core, which holds fully benefit-responsive investments. The fund and underlying funds invest in guaranteed investment contracts (“GICS”) and security-backed contracts issued by insurance companies, banks and other financial institutions.

Certain events limit the ability of the Plan’s investment in its SRF to transact at contract value with the issuer. Such events include the following: (1) material amendments to the SRF’s structure or administration, (2) changes to the participating plans’ competing investment options including the elimination of equity wash provisions, (3) complete or partial termination of the SRF, including a merger with another fund, (4) the failure of the SRF to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) redemption of all or a portion of the interest in the SRF held by a participating plan at the direction of the participating plan sponsor, including withdrawals due to the removal of a specifically identifiable group of employees from coverage under the participating plan (such as a group layoff or early retirement incentive program), the closing or sale of a subsidiary, employing unit, or affiliate, the bankruptcy or insolvency of a plan sponsor, the merger of the plan with another plan, or the plan sponsor’s establishment of another tax qualified defined contribution plan, (6) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement, applicable to the SRF or participating plans or (7) the delivery of any communication to plan participants designed to influence a participant not to invest in the SRF. Management of the fund does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

**4. Fair Value Measurements**

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1

measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV practical expedient of units of a bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The objective of the common collective trust is to provide a diversified group of investments offering competitive levels of yield consistent with stable fixed-income methodology providing for preservation of capital, stability and predictability of returns and liquidity to pay Plan benefits.

There were no unfunded commitments at December 31, 2024 and 2023.

## 5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

## 6. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule was provided and certified by the trustee, Charles Schwab Trust Bank, as of and for the years ended December 31, 2024 and 2023 as complete and accurate.

- Investments, at fair value

- Non-interest-bearing cash
- Investment income
- Schedule of assets (held at end of year)
- Notes receivable from participants
- Interest on participant notes receivable

## **7. Party-in-Interest Transactions**

Certain Plan investment funds are managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee as defined by the Plan. Additionally, certain investment fees are paid by the trustee and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Additionally, Moda Partners, Inc. is a party-in-interest to the Plan. The transactions between the Plan and the Plan Sponsor included funding of contributions to the Plan and payment of certain administrative expenses of the Plan and are considered exempt transactions.

## **8. Tax Status**

The Plan adopted The Retirement Plan Company, LLC Defined Contribution Pre-Approved Plan Document that received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which stated that the Plan, as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Plan Termination and Spin-offs**

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Emerging Health, LLC became a related and participating employer to the Plan in 2021 and seceded from the Plan on December 31, 2022. As part of Emerging Health, LLC's secession, the Company entered into an agreement to spin off a portion of the Plan to Ardon Health 401(k)

Plan (“Transferee Plan”). Participant accounts under Emerging Health, LLC and funds amounting to \$624,006 were transferred to the Transferee Plan in 2023.
