## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alpha Services Company of Rochester 401(k) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

#### 1. Plan Description and Summary of Significant Accounting Policies

---

The following description of Alpha Services Company of Rochester 401(k) (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan covering all eligible employees of Alpha Services Company of Rochester (the Company). The Plan became effective September 15, 2007. The Plan was last restated effective February 18, 2022. The Plan has been periodically updated to comply with various regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

*Administration* – The Plan is administered by the Company and advised by an external third-party consultant. The Custodian of the Plan's assets is Principal Life Insurance Company (the Custodian). The Custodian executes transactions based upon direction from the Plan's administrator and the Plan's participants.

*Participation* – To be eligible for the Plan, employees must be age eighteen or older and have completed one thousand hours of service in a plan year. Entry dates begin on the first day of the first month and of the seventh month of the Plan year following the completion of the initial requirements.

*Contributions* – Contributions to the Plan include pre-tax salary reduction contributions, after-tax salary reduction (Roth) contributions, rollover contributions, catch-up contributions, and safe harbor matching contributions made by the Company.

Each participant may authorize the Company to contribute into the Plan salary reduction contributions up to the limits prescribed by law.

Participants must also be age eighteen or older and have completed one year of service to receive Company safe harbor matching contributions. The Company matches 100% of salary deferrals up to the first 3% of compensation and 50% on salary deferrals between 3% and 5% of compensation. Company safe harbor matching contributions were \$223,227 and \$228,053, respectively, for the years ended December 31, 2024 and 2023.

*Participant Accounts* - Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) plan earnings (losses), and (c) plan expenses, as applicable. The Plan uses a daily valuation system for each participant's individually directed account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Participant Accounts (Continued)* - The Plan provides for participants to direct the funds in which their account balances are invested. As of December 31, 2024, participants' funds are invested in various pooled separate accounts, common/collective trust funds, mutual funds, and an insurance company guaranteed fixed income account held by the Custodian.

*Vesting* – Participants are immediately vested in their elective contributions, catch-up contributions, and employer safe harbor matching contributions.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at 1% over prime rate, determined on the first business day of the month before loan origination. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions in accordance with the terms of the plan document. Interest rates on all loans outstanding as of December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest is paid through payroll deductions. Participants may have two loans outstanding at one time.

*Benefits* – On termination of service, disability, death, retirement or reaching normal retirement age, participants are eligible to receive a distribution in an amount equal to their vested account balance. If the participant's vested account balance is less than \$1,000, the Plan is allowed to distribute the vested account balance in a lump-sum payment without the participant's consent. If the participant's vested account balance exceeds \$1,000, the participant may elect to take a lump-sum distribution, distribute their account balance in substantially equal amounts, or to leave their vested account balance in the Plan.

*Plan Termination* - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100 percent vested in their accounts.

#### *Basis of Accounting*

The financial statements are prepared on the accrual basis from the financial records supplied by Principal Life Insurance Company, the Custodian.

##### Investment Valuation and Income Recognition

Investments in mutual funds, pooled separate accounts, and common collective trusts are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in guaranteed investment contracts are reported at contract value as reported by the issuing insurance company which is deemed to be representative of fair value. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### Benefit Payment

Benefit payments are recorded upon distribution to participants.

##### Expenses

Expenses of maintaining the Plan are paid by the Company and the Plan. Administrative expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

##### Forfeitures

Forfeited nonvested amounts are first used to pay any administrative expenses of the Plan. Any remaining forfeitures are used to reduce the employer safe harbor contribution into the Plan. There were no forfeitures for the years ended December 31, 2024 and 2023. There were no forfeitures used to reduce plan expenses during the years ended December 31, 2024 and 2023. There were no forfeited nonvested accounts at December 31, 2024 and 2023.

##### Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### Reclassifications

Certain amounts presented in the prior year have been reclassified in order to be consistent with the current year's presentation.

#### 2. Financial Information Certified by the Custodian

---

The Principal Life Insurance Company, the Custodian, has provided the Plan Administrator with certifications as to the completeness and accuracy of total investments and notes receivable from participants of the Plan held by the Custodian aggregating \$3,711,153 and \$3,047,187 as of December 31, 2024 and 2023, respectively, and the related investment income of \$404,020 and \$433,215, respectively, and interest on notes receivable from participants and other interest of \$13,990 and \$8,452, respectively, for the years then ended. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedules based upon certifications from the Custodian.

Under the terms of the custodial agreement, the Custodian manages investment funds on behalf of the Plan. The Custodian acts at the direction of the Plan Sponsor and plan participants when initiating purchases and sales of the investments of the investment funds.

---

#### 3. Fair Value Measurements

---

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobserved inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Mutual Funds:** The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/Collective Trust Funds:** The collective trust funds are valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the Custodian, is published as the fund's fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The common collective trust fund held by the Plan is deemed to be actively traded.

**Pooled Separate Accounts:** Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although not based upon quoted prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Certain plan investments include mutual funds, common/collective trust funds, pooled separate accounts and an insurance company general account that are managed by Principal Life Insurance Company, the Custodian; and therefore, these transactions qualify as party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

#### **4. Party-in-Interest Transactions (Continued)**

---

The Plan issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations. Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.

---

#### **5. Tax Status**

---

The prototype plan document utilized by the Plan has obtained an IRS opinion letter, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months.

The Plan's informational returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal informational returns generally remain open for three years.

#### **6. Risks and Uncertainties**

---

The Plan offers a number of investment options to participants that are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect amounts reported in the statements of net assets available for benefits and participant accounts.

#### 7. Investment Contract with Insurance Company

---

In 2022, the Plan entered into a benefit-responsive investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The Plan administrator believes that for transactions entered into at contract value, which includes most transactions for the insurance company fixed income account, that contract value is representative of fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$15,546 and \$11,841, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are currently reset on a semiannual basis and will never be less than the Guaranteed Minimum Interest Rate. Contract value is considered book value less early withdrawal charges. The average yield earned by the Plan is calculated by dividing the annualized earnings of all fully benefit-responsive investment contracts by the fair value of all fully benefit-responsive investment contracts.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring. However, in the event any of these transactions would occur, contract value would be reduced by a 5% surrender charge.

The guaranteed investment contract average yield for 2024 and 2023 was 4.86% and 4.25%, respectively. By definition, the contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time.

**8. Other Matters**

---

In 2020, 2022, 2023, and 2024 it was determined that \$370,924, \$280,384, \$538,155, and \$548,361 respectively, of employee deferral contributions were not remitted to the Plan within the time period prescribed in the Code of Federal Regulations (CFR). Corrections for 2020 and 2022 deferrals were remitted to the Plan during 2024.

---

**9. Subsequent Events**

---

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.
