Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of BronxWorks Defined Contribution Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of July 26, 2024 (in liquidation) and December 31, 2023 (in liquidation), the related statements of changes in net assets available for benefits for the period from January 1, 2024 through July 26, 2024 (in liquidation) and the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be

independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 7 to the financial statements, the Plan Sponsor, BronxWorks Inc. approved a termination of the Plan effective August 15, 2023 with all assets fully distributed on July 26, 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan has utilized the liquidation basis in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the BronxWorks Defined Contribution Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. **General** — The Plan was a noncontributory defined contribution pension plan established on January 1, 1986, covering all employees of BronxWorks, Inc. (“BronxWorks” or “Employer” or “Sponsor”) who had completed one year of service and had attained 21 years of age. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). During 2020, the Board of Directors of the Plan Sponsor passed a resolution to freeze the Plan effective January 1, 2021. As a frozen Plan, the Employer did not make any contributions with respect to Plan compensation earned after such date and no participant was permitted to make any contributions to the Plan after such date. In addition, no employee was permitted to become a participant after the date the Plan was frozen.
- B. **Eligibility** — All employees of BronxWorks were eligible to participate in this Plan after completing one year of service and attaining age 21, except those who were non-resident aliens with no U.S. source income and those who were classified or treated as independent contractors (even if a government agency or court with the jurisdiction determined that such persons were deemed to be employees for any purpose under common-law principles or federal, state or local law). Certain employees commonly called leased employees and other individuals who were not employees of the Employer, but who were commonly called leased employees because they were employed by a leasing organization were not eligible to participate in this Plan.
- C. **Contributions** — Each Plan year, the Sponsor contributed a percentage of each participating employee's compensation to the Plan up to the amount allowed under the Internal Revenue Service (“IRS”) rules. Participants directed the investment of their contributions into various investment options offered by the Plan. No Employer contributions were made to the Plan since it was frozen.

The following table represents the percentage of compensation based on the employee hire date. Effective December 1, 2009, the Employer contributions were calculated as follows:

<u>Terms of Service</u>	<u>Percentage of Compensation</u>
Less than 5 years of service	4% Participants hired on or after January 1, 2007
Less than 5 years of service	6% Participants hired prior to January 1, 2007
5 years of service but less than 10 years of service	7% regardless of hire date
10 years or more of service	10% regardless of hire date

- D. **Participant Accounts** — Each participant's account was credited with an allocation of the Sponsor’s contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations were based on participant earnings of account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.
- E. **Vesting and Forfeitures**— Participants were vested based on continuing years of service. A participant was 100% vested after three years of credited service. During the year ended December 31, 2023, forfeitures were reallocated to all active participants, as defined, in accordance with the terms of the Plan and provisions of ERISA and amounted to \$295,254. During the year ended December 31, 2023, forfeitures increased by \$64,409. In 2023, \$35,851 in forfeited nonvested accounts were reallocated to pay administrative expenses of the Plan. The forfeited nonvested accounts amounted to \$755 as of December 31, 2023. There were no such amounts as of July 26, 2024. The Plan terminated effective August 15, 2023 (see Note 7). The reallocated amounts were included as other contributions in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023.
- F. **Notes Receivable from Participants** – Participants were not permitted to borrow from their accounts.

- G. **Payment of Benefits** – Participants were entitled to distributions of their vested benefits upon termination of service due to severance of employment, death, disability, retirement, qualified distribution or termination of the Plan. If the individual's vested account balance was greater than \$5,000, the participant was able to elect to receive installment distributions or annuity distributions. Participants who terminated employment with a vested account balance that did not exceed \$5,000 were able to receive a lump sum distribution of his/her vested account balance.
- H. **Administrative Expenses** – Administrative expenses were paid by the Plan Sponsor, except for certain contract administrative fees which were paid for by the Plan.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

- A. **Basis of Accounting** – The financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with generally accepted accounting principles as of July 26, 2024 and December 31, 2023 and for the period from January 1, 2024 through July 26, 2024 and year ended December 31, 2023.
- B. **Use of Estimates** – The preparation of financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. **Investment Valuation and Income Recognition** – Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- D. **Payment of Benefits** – Benefits were recorded when paid.

NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN AS COMPLETE AND ACCURATE

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information was certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. ("Lincoln"), Custodian of the Plan, and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

The Custodian has certified to the completeness and accuracy of the investments included in the financial statements as of July 26, 2024 and December 31, 2023, and investment activity included in the financial statements for the period from January 1, 2024 to July 26, 2024 and the year ended December 31, 2023 as summarized below:

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, “Fair Value Measurement,” provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Lincoln Stable Value Account

The portfolio was valued on a daily basis, and the crediting rate was calculated based on the weighted average of the crediting rates of all of the book value instruments of the fund. Participant account balances were credited daily with interest and don't fluctuate with market ups and downs.

Mutual Funds

Mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding method described may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

Lincoln Stable Value Accounts were invested in a broadly diversified portfolio of predominantly fixed income instruments. The primary objective was to maximize investment income while maintaining preservation of capital.

NOTE 5 – RELATED-PARTY TRANSACTIONS (PARTY-IN-INTEREST)

The Plan's investments included certain stable value funds managed by the Custodian, as defined by the Plan and therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for investment management services are reflected as administrative expenses. There were administrative expenses of \$35,851 as noted in Note 1E, for the year ended December 31, 2023. There were no administrative expenses for the period ended July 26, 2024.

NOTE 6 – TAX STATUS

The Plan adopted a pre-approved plan document for which the Internal Revenue Service issued an opinion letter, dated June 30, 2020, confirming that the form of the document complied with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan had been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan was designed, and was operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan was qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PLAN TERMINATION AND COMPLIANCE

The Sponsor terminated the Plan in accordance with the provisions of ERISA. On June 1, 2023, the Finance and Audit Committee passed a resolution to terminate the Plan effectively August 15, 2023. When a Plan is terminated, the balance of participant accounts are distributed in a lump sum or by delivery of a fully paid annuity contract as permitted by Internal Revenue Service regulations. Following the termination of the Plan, all active participants became 100% vested and the assets of the Plan were distributed as soon as administratively practicable in accordance with the terms of the Plan and based on participants' distribution elections. For those participants that could not be located, \$3,716,413 was transmitted to the Pension Benefit Guaranty Corporation. The assets were fully distributed on July 26, 2024.

The Plan did not file the final 2024 Form 5500 timely due to an administrative error and to correct the late filing, the Form 5500 will be filed under the Delinquent Filer Voluntary Compliance Program which allows plan administrators to voluntarily submit overdue annual reports.

NOTE 8 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
