Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Metropolitan Foods, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Metropolitan Foods, Inc. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of Metropolitan Foods, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all the employees of Metropolitan Foods, Inc. (Company) who have attained the age of 21 and completed three (3) months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustees are responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustees.

SECURE Act

The Plan has adopted certain provisions under the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE 2.0 Act). The Plan intends to formally execute the required Plan amendments for these provisions by December 31, 2026.

The following descriptions of the Plan below have been updated with the provisions of the SECURE 2.0 Act that impact the Plan.

Contributions

All eligible employees may elect to make pretax contributions by authorizing his or her compensation to be reduced by any whole percentage not to exceed the current year's statutory limits. No employee is permitted to make a contribution in excess of the dollar limitation specified in the Internal Revenue Code (the Code) at the beginning of the Plan year.

The Plan provides for an employer matching contribution equal to 50% of a Participant's Elective Deferral which does not exceed 3% of the contributing participant's compensation. The employer matching and any related forfeitures will vest based on years of continuous service. Each participant may direct the matching contributions into an available investment fund, as defined. Employer profit-sharing contributions to the Plan are made at the discretion of the Company.

The Plan provides for an employer discretionary contribution to eligible participants who have attained the age of 21 and completed 3 months and 500 hours of service in a Plan year. When making profit sharing contributions, the Company uses a discretionary formula to determine contribution and uses a pro rata formula to allocate among participants. The Company did not make profit sharing contributions during the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with an allocation of (a) the employer's contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Each participant has a vested interest in the Plan Sponsor's discretionary contributions portion of his/her account plus actual earnings thereon based on years of service, as defined. A participant is vested as follows:

<u>Years of vesting service</u>	<u>Vested Percentage</u>
Less than 1 year	50
1 year	75
2 years	100

Participants also become fully vested upon attaining normal retirement date of in the event of death or disability.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of the vested account balance or \$50,000. The term of the loan shall not exceed five years except in the case of a loan for the purpose of acquiring a principal residence. The interest rate will be based on the rates available for similar loans from commercial lending institutions, as determined by the Plan administrator, and will not change once granted. Principal and interest are paid ratably through weekly payroll deductions. The loans are secured by the balance in the participant's account.

Payment of benefits

A participant may request a payment of benefits if the employee a) is terminated, b) becomes disabled, c) reaches age 59½ and d) is experiencing a financial hardship. Participants may elect to withdraw all or a portion of the payout as a lump sum payment, partial payment, direct rollover, installment payments, annuity contracts (if assets are held in a custodial account) or defer payments until age 70½. On termination of service, if the participant's vested account balance is less than \$1,000, the participant will receive that amount in a lump sum. If the vested balance exceeds \$1,000, a participant may elect to receive their vested amount in a lump sum or leave the vested account in the Plan and defer receipt of benefit. In the event of a participant's death, the vested accounts will be distributed to the beneficiary as soon as practicable. The distribution will be made in the form of a single lump-sum cash payment unless the beneficiary elects to receive the distribution in installments. If a participant dies after commencement of benefit payments, then the remaining portion of the benefit payments shall be distributed at least as rapidly as under the method of periodic distribution being used at the time of death.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,518 and \$2,134, respectively. Forfeitures may first be used to pay Plan expenses. Any forfeitures left after paying Plan expenses are used to offset future employer contributions.

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

2. Summary of accounting policies

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and insurance company. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and from the employer are recorded in the year in which participant compensation is earned.

2. Summary of accounting policies (continued)

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when they are incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Expenses

All administrative expenses shall be paid out of the Plan unless paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction to contributions. Excess contributions were \$236,220 for the year ended December 31, 2024. Excess contributions are reported as corrective distributions on the Form 5500. Excise taxes incurred by the Company on excess contributions were \$2,362 for the year ended December 31, 2024.

3. Tax status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan has elected to utilize the employee benefit plan provisions which allow certain changes to distribution and loan rules as prescribed by the SECURE Act and CARES Act.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. As of December 31, 2024, the Plan Administrator believes that based on evaluation of the Plan's tax positions that any liability as a result of uncertain tax positions would not be material. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. The Plan maintains its investments with an investment manager. Exposure to credit risk is reduced by placing such investments in high quality financial institutions and by following an investment strategy which utilizes a wide range of diversified funds.

5. Certification by Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Lincoln National Life Insurance Company (the custodian of the Plan).

6. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA, which would result in the participants becoming 100% vested before receiving a final distribution from their accounts.

7. Transactions with parties-in-interest

Certain Plan investments are managed by The Lincoln National Life Insurance Company. The Lincoln National Life Insurance Company is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment manager services are included as a reduction in the net appreciation in fair value of investments. Investment advisory and administrative expenses relating to the maintenance of the Plan are paid from the Plan assets. Direct fees paid by the Plan during the year ended December 31, 2024 were \$126,314.

The Plan Sponsor pays for certain professional fees relating to services provided to the Plan. Fees paid on behalf of the Plan during the year ended December 31, 2024 were \$10,000. The Plan Sponsor also provides certain accounting and administrative services to the Plan for which no fees are charged.

8. Fair value measurement of investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (Level 3).

The three Levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 - Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad criteria data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. However, the determination of what constitutes "observable" requires significant judgment by the Plan. The Plan considers observable data to be that market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, provided by multiple, independent sources that are actively involved in the relevant market. The categorization of an investment within the hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to the Plan's perceived risk of that investment.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in registered investment companies are valued at the daily closing price as reported by the fund and are op-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

9. Fully benefit-responsive investment contract

The Lincoln Financial Group Guaranteed Stable Value Fund is a benefit-responsive group annuity contract issued by The Lincoln National Life Insurance Company. By definition, the Lincoln Financial Group Guaranteed Stable Value Fund group annuity contract is an insurance contract. The account is credited with contributions and actual earnings and charged for participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer but cannot be less than zero. Under the terms of the existing contract, the crediting rate is currently reset on a semi-annual basis.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or a merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, or (e) premature termination of the contract. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with the Plan participants, is probable.

Investment contract with the insurance company for the year ended December 31, 2024 was \$520,663.

10. Prohibited transactions

During the year ended December 31, 2024, the Plan Sponsor failed to remit to the Plan participant contributions in the amount of \$452,334 within the period prescribed by the Department of Labor regulations.

11. Subsequent events

Subsequent events have been evaluated through October 14, 2025 which is the date the financial statements were available to be issued. The Plan is not aware of any material subsequent events.
