Note 1 – Description of Plan:

The following description of the Winpak Heat Seal Corporation GCC/IBT Local 568-M Employee Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is sponsored by Winpak Heat Seal Corporation.

General

The Plan was established to provide retirement benefits for employees of the Company. Eligible employees become participants in the Plan following one hundred twenty (120) days of continuous service, as defined in the Plan agreement. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan contains an elective 401(k) deferred compensation component. Eligible participants may elect to contribute not less than 1% or more than 60% of their compensation, subject to limitations of the 401(k) component of the Plan. It is Company policy to match a percentage of the participants’ 401(k) deferrals up to a maximum percentage of eligible compensation, as a result of a collective bargaining agreement. The matching percentage is 6% of the deferral by participants. Profit sharing contributions are also made at the discretion of the Company. The Company’s total employer contributions for the plan year ended December 31, 2024 were \$570,546.

Rollover contributions are permitted under the Plan and shall be accepted from participants and non-participants, regardless of whether they have satisfied the eligibility requirements set forth in the Plan. The rollover contributions during the year ended December 31, 2024 were \$-0-.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the employer’s contributions, and the earnings attributable to the participant’s self-directed account.

Vesting

Participants are immediately vested in their 401(k), voluntary after-tax and rollover contributions, plus actual earnings thereon. That portion of the participants’ account attributable to employer contributions is fully vested after completion of five years of service. Participant’s accounts become fully vested upon attainment of the normal retirement age of 65. Amounts forfeited by terminating participants of the Plan are to be used to reduce the Plan’s ordinary and necessary administrative expenses for the Plan year. Any remaining forfeitures are then to be used to reduce Employer contribution obligations for such plan year.

Note 1 – Description of Plan – Continued:

Distributions to Participants

Amounts credited to an individual participant's account are distributed at termination of employment as a lump sum or in installments. Distributions may be deferred until the later of the participant's actual retirement date or the attainment of age 65, if the value of the distribution is not less than \$1,000. However, the Plan agreement stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the age of 73, unless the participant is not a 5% owner of the Company and is still employed by the Company.

In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to salary deferral contribution accounts and may not include any income earned thereon.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited accounts totaled \$13,074 and \$29,249, respectively. Amounts forfeited by terminating participants of the Plan will be used to reduce the Plan's ordinary and necessary administrative expenses and/or employer contributions.

Participant Notes Receivable

Participants may borrow from their accounts according to the Plan document. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deduction.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Note 2 – Summary of Accounting Policies:

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 2 – Summary of Accounting Policies – Continued:

Investment Valuation and Income Recognition

The Plan's investments are held in a trust. The custodian values all investments, except the fully-benefit responsive common collective trust measured at contract value, at fair value. Investments are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Assets Available for Benefits

Net assets available for benefits at both December 31, 2024 and 2023 included \$-0- allocated to the accounts of persons who, prior to that date, had withdrawn from participating in earnings and operations of the Plan.

Note 3 – Tax Status:

The Plan, originally adopted during 1996, and effective June 1, 1996, restated during 2023, obtained its latest determination letter in June 2020 (volume submitter), in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator and the Plan's Sponsor believe that the plan in currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 4 – Investments:

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$14,135,996 and \$10,780,713 as of December 31, 2024 and 2023, respectively.
- b. Total investment income (loss) as shown in the accompanying statement of changes in net assets available for benefits is \$2,171,408 for the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5 – Guaranteed Investment Contract With Insurance Company:

The Plan has a fully benefit-responsive stable value common collective trust fund (“CCT”) through Fidelity Management Trust Company (“Fidelity”), which invests in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds. Fidelity maintains the contributions in CCT that is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The CCT issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed by the issuers.

Because the CCT is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The CCT is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the CCT as of December 31, 2024 and 2023 was \$14,406 and \$30,350, respectively. The crediting interest rate is based on a formula agreed to with the issuer.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

The CCT does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6 – Fair Value Measurement:

The Plan has determined the fair value of certain assets and liabilities through application of ASC 820. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value are classified and disclosed in one of the following three categories:

- Level 1 – Valuations for assets and liabilities traded in active exchange markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.
- Level 2 – Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or similar assets or liabilities.
- Level 3 – Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets.

Mutual funds and money market mutual funds listed on a national market or exchange are valued at the last sales price, or if there is no sale and the market is still considered active at the last transaction price before year end. Note 8 – Related Party Transactions and Party-In-Interest Transactions:

Certain Plan investments are shares of mutual funds managed by various fund companies. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Loan fees paid out of participant accounts also qualify as a party-in-interest transaction. The Plan Sponsor also pays directly some fees related to the plan's operations.

Note 9 – Uncertain Tax Positions:

Accounting principles generally accepted in the United States of America require the Plan's management evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by applicable taxing authorities. Management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax years prior to 2021 are closed.

Note 10 – Schedule H Reconciliation:

Accounting principles generally accepted in the United States of America require fully benefit-responsive investments to be measured at contract value. However, the Schedule H of the Form 5500 requires all investments to be reported at fair value. This leads to the differences shown below between the financial statements and the Schedule H of the Form 5500 as of December 31, 2024:

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by Winpak Heat Seal Corporation GCC/IBT Local 568-M Employee Savings Plan is included in Note 1 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during the year ended December 31, 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates and Related Disclosures

Accounting estimates and related disclosures are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments.

Financial Statement Disclosures

The financial statement disclosures are neutral, consistent, and clear.

Significant Unusual Transactions

For purposes of this communication, professional standards require us to communicate to you significant unusual transactions identified during our audit. No such transactions were identified.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Significant Difficulties Encountered during the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

Uncorrected and Corrected Misstatements

For purposes of this communication, professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. No such misstatements were identified.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to Winpak Heat Seal Corporation GCC/IBT Local 568-M Employee Savings Plan's financial statements or the auditor's report. No such disagreements arose during the course of the audit.

Circumstances that Affect the Form and Content of the Auditor’s Report

We have requested certain written representations from management, which are included in a separate letter dated October 15, 2025.

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

Other Significant Matters, Findings, or Issues

In the normal course of our professional association with Winpak Heat Seal Corporation GCC/IBT Local 568-M Employee Savings Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as Winpak Heat Seal Corporation GCC/IBT Local 568-M Employee Savings Plan’s auditors.


Other Matters
