Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Valley Home Care, Inc. Defined Contribution Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following summary of certain provisions of the Valley Home Care, Inc. Defined Contribution Pension Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined contribution plan covering eligible employees of Valley Home Care, Inc. (the "Company") who are age 21 or older, who work 1,000 hours or more a year and were hired prior to January 1, 2007. Employees hired on or after January 1, 2007, are not eligible to participate in the Plan. Loans are not permitted under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Assets Held for Investment

All Plan assets are held with Lincoln Financial Group Trust Company, Inc. ("Lincoln"). Among other duties, Lincoln is responsible for the custody of the Plan's assets and for the payment of benefits to eligible participants. Plan contributions are invested in certain funds offered by Lincoln as designated by the Plan participants.

Contributions

The Company may contribute at their discretion 5% of the base salary of each Plan member subject to the limitations of the Internal Revenue Code ("IRC") Section 415(c)(3). "Base salary" consists of total pay, excluding overtime, bonuses, fee for visit, mileage reimbursement, all fringe benefits, incentives, awards, and differential. Employee contributions are not permitted by the Plan.

Participant Accounts

Each participant's account is credited with allocations of Company contributions and Plan earnings and (losses). Allocations are based on a participant's earnings, account balances or specific participant transactions, as defined in the Plan document.

Vesting

Participants are vested 100% after completing 3 years of service, assuming that they have completed 1,000 hours of service per anniversary year. Full vesting will also occur upon reaching early retirement age, disability, or death.

Payment of Benefits

Upon becoming eligible to receive benefits or attainment of age 55, participants with a vested account balance of greater than \$5,000 may elect to receive a lump sum benefit or to choose from a guaranteed annuity. Participants with a vested account balance of less than \$5,000 will receive a lump sum payment. In-service distributions are allowed for participants with 100% vested account balances.

1. Description of Plan (*continued*)

Administrative Expenses

Certain administrative expenses of the Plan were paid on the Plan's behalf by the Company, and excluded from these financial statements.

Forfeitures

When a participant terminates, the nonvested portion of their account, as defined by the Plan, is forfeited. Forfeitures are utilized to pay Plan expenses or to reduce employer contributions for the Plan year. However, if the participant is re-employed and fulfills certain requirements, as defined in the Plan document, the participant's account will be reinstated for such forfeitures. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11 and \$0, respectively. During 2024, forfeitures of \$1,994 were used to reduce employer contributions.

Plan Expense Account

The Plan and Lincoln Retirement Services Company, LLC entered into a Recordkeeping Service Agreement whereby quarterly credits will be made to the Plan Expense Account equal to 0.0450% annually of the Plan's total assets, which will be used to pay Plan expenses or to reduce employer contributions. In order for the Plan to receive credits as a result of this arrangement, the Plan created a Plan Expense Account, which is invested in the Lincoln Stable Value Fund within the Plan. The Plan Expense Account balance was \$16,694 and \$17,250 as of December 31, 2024 and 2023. During 2024, \$930 of funds from the Plan Expense Account were used pay Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

2. Summary of Significant Accounting Policies (*continued*)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value based on quoted market prices, except for its fixed income annuity accounts, which are stated at contract value. Contract value represents contributions made under the contract, plus interest credited, less benefits paid and expenses. The mutual funds are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at the price and are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023 and net appreciation in value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., a qualified institution.

4. Investments

The following are the major categories of investments, measured at fair value on a recurring basis at December 31, grouped by the fair value hierarchy:

The Lincoln Stable Value Fund is recorded at contract value on the statements of net assets available for benefits, which amounted to \$1,969,955, and \$2,408,177 at December 31, 2024 and 2023. The Plan offers investments in YourPath target-date and risk portfolios. These portfolios primarily consist of iShares index mutual funds from BlackRock. Each portfolio also includes the Lincoln Stable Value Account as part of the portfolio allocation to reduce market volatility. The Lincoln Stable Value portion is carried at contract value and across all portfolios the total is \$1,368,061 and \$1,264,711 at 2024 and 2023.

5. Fixed Annuity Contract with Insurance Company

The Plan invests in a fully benefit-responsive fixed annuity contract with The Lincoln National Life Insurance Company ("LNLIC"). LNLIC maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. LNLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by LNLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (A+ as of July 2024), Moody's Investors (A2 as of September 2024), A.M. Best (A as of February 2025) and Fitch Ratings (A+ as of July 2024).

The Lincoln Stable Value Fund represents approximately 21% and 25% of the net assets available for benefits as of December 31, 2024 and 2023.

6. Party-in-Interest

The fixed income annuity investment is managed by LNLIC. LNLIC is related to the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for administrative expenses amounted to \$8,287 for the year ended December 31, 2024.

Certain employees of the Company, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

6. Party-in-Interest (*continued*)

A Plan Expense Account is maintained by Lincoln Retirement Services Company, LLC which receives payments from Lincoln pursuant to a written agreement with the Company. Under the agreement, the Company can use the amounts in the account to pay for administrative expenses incurred by the Plan or for such purposes as determined by the Company. These transactions are considered allowable party-in-interest transactions. The payments are included in other income and amounted to \$0 for the year ended December 31, 2024.

7. Expenses

Administrative expenses are predominantly paid directly by the Company and not by the Plan. For expenses paid by the Plan, monthly asset charges are deducted from the participant's accounts. Certain fees related to transfer of funds are also paid by participants. Fees paid by the Plan for investment management services are included in net appreciation in value of investments.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

9. Income Tax Status

The Internal Revenue Service ("IRS") has determined and informed Lincoln, the Plan document preparer, by an IRS opinion letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in investment securities which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
