Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Krystal Biotech, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Krystal Biotech, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO THE FINANCIAL STATEMENTS**

Note A - Description of Plan

General - The Krystal Biotech, Inc. 401(k) Plan (the Plan), as amended and restated effective January 1, 2024, is a defined contribution plan covering eligible employees of Krystal Biotech Inc. (the Company). The Plan document is the governing instrument and should be referred to for a full description of the Plan and its provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Employees are eligible to participate after the first of the month following employment and after the attainment of age 21.

Employee Contributions – Participants may contribute pre-tax and Roth amounts as defined by the Plan, up to 100% of eligible compensation, in accordance with the Internal Revenue Code section 415 limits. Employees may also elect to make catch-up contributions provided they have reached age 50 by the end of the current calendar year. Participants may also contribute rollovers from other qualified plans. Eligible compensation is defined as wages and other compensation on Form W-2, with some exclusions including stock bonuses and severance pay, as further described in the Compensation Addendum, as last amended effective September 1, 2024. Eligible compensation is subject to annual limitations prescribed by the IRC.

Employer Contributions – The Company will contribute a Safe Harbor Matching contribution equal to 100% of the first 3% of employee compensation deferred and 50% of the next 2% of employee compensation deferred. Participants are immediately 100% vested in this contribution. The Company Safe Harbor Matching contribution for the year ended December 31, 2024 amounted to \$1,276,198.

The Company may also contribute discretionary matching or nonelective profit sharing amounts to the Plan. These amounts are decided annually by management and are allocated to all eligible participants. The Company did not elect to contribute discretionary matching or nonelective profit sharing contributions for 2024.

Participants may direct their own contributions, as well as the Company's employer contributions, into any of the investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the employee's contribution, the Company's matching and discretionary contributions, Plan earnings, and certain administrative fees, as appropriate.

Vesting - Participants are fully vested in the value of their contributions as well as all employer contributions made.

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to a maximum of 50% of the vested account balance or \$50,000, whichever is less. Loans, which bear interest at a rate of prime plus 2%, are collateralized by the vested portion of the participant's account and repayments are made through payroll deductions. Participant loans are considered assets of the Plan and are valued based on the unpaid principal balance plus accrued but unpaid interest.

Benefit Payments - Individual accounts can be distributed upon the death, disability, retirement, or termination of employment of the Plan participant. Participants may receive a distribution from their Rollover Contribution Account at any time. In-service distributions from other accounts are also available as long as the participant has attained the age of 59 ½. The Plan also permits a hardship withdrawal of a participant's account, other than from their qualified non-elective contribution account or matching contribution account, up to an amount required to alleviate the hardship. For terminating employees, distributions are mandatory in an amount of \$5,000 or less and participant consent is not required.

Termination - Although there is not a present intent to do so, the Company has reserved the right to terminate or partially terminate the Plan.

Note B - Summary of Significant Accounting Policies

The financial statements of the Plan have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America. The following are the significant accounting policies followed by the Plan.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

Contributions - Employee contributions and Company contributions are recognized as additions to Plan assets in the year designated by the employee and Company, respectively.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value except for the fully-benefit responsive investment contract, which is stated at contract value (Note F). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the Custodian of the Plan's assets. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on loans is recorded on the accrual basis. An allowance for notes receivable from participants has not been recorded as delinquent notes receivable from participants are recorded as a distribution and reduction of the participant loan balance based upon the terms of the plan document.

Benefit Payments - Benefits are recorded when paid.

Administrative Expenses - All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Employer.

Subsequent Events - Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note C - Tax Status

The Internal Revenue Service has determined by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and to recognize a tax benefit if it is more likely than not the tax position would be sustained upon examination by the applicable authorities. The remainder of the tax position is required to be recorded as a tax liability. The Plan's tax returns are subject to examination by the taxing authorities, generally for three years after they were filed. The Plan currently has no uncertain tax positions and, therefore, no liabilities have been recorded.

Note D - Information Certified by the Plan's Custodian

For the years ended December 31, 2024 and 2023, the plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the current trustee of the Plan, has certified to the completeness and accuracy of the investments reported in the statements of net assets available for benefits and the supplemental schedule as of December 31, 2024 and the related investment activity in the statement of changes in net assets available for benefits for the period from January 9, 2024 through December 31, 2024. Voya Retirement Insurance and Annuity Company, the previous custodian of the Plan, has certified to the completeness and accuracy of the investments reported in the statements of net assets available for benefits as of December 31, 2023 and the related investment activity in the statement of changes in net assets available for benefits for the period from January 1, 2024 through January 9, 2024.

Note E - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, "Fair Value Measurements and Disclosures," establishes a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs into three broad levels. Level 1 inputs are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are quoted prices for similar assets in active markets or inputs that are observable for the asset, either directly or indirectly through market corroboration, for substantially the full term of the asset. Level 3 inputs are unobservable and significant inputs developed by the plan sponsor based on the best information available about the assumptions market participants would use in pricing the asset. A financial asset's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used in measuring Plan assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be activity traded.

Note E - Fair Value Measurements (Continued)

Common Collective Trusts – Common collective trust funds represent investments with various investment managers. The fair value of these investments is valued at NAV, as reported by the sponsoring financial institution. The NAV is used as a practical expedient to estimate fair value. The NAV is determined by reference to the trusts’ underlying assets, which are principally comprised of equity and fixed income securities. Units held are valued as reported by investment managers, which represent the ownership share of the net asset values of the underlying assets. Participants may generally redeem fund units on a daily basis, subject to limitations. The stable value fund is composed primarily of fully benefit responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV of the stable value fund is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024. The objective of the common collective trust funds is to achieve long-term capital appreciation in diversified portfolios.

Pooled Separate Accounts - Pooled Separate Accounts (PSAs) invest in mutual funds and equity securities. PSAs are valued daily at their accumulation unit value multiplied by number of units held. The accumulation unit value is determined daily based on the net asset value of shares of the underlying fund as provided by the Custodian. The investment strategies of these pooled separate accounts vary among growth, income, and equity objectives. A prospectus describing each pooled separate account is available from the plan administrator.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F - Fully Benefit-Responsive Investment Contract

As of December 31, 2023, the Plan held a traditional fixed account investment fund with the custodian. This investment met the fully benefit-responsive investment criteria and therefore was reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus credited interest less participant withdrawals and fees. The account is credited with earnings based on the daily balance. There is no stated minimum or maximum interest rate for the investment choice.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different than the contract value. The issuer will terminate the contract under the following circumstances: (1) the Plan provides effective communication that the contract will be terminated; (2) the market value balance is not more than \$1,000 or the contract value difference is zero; (3) the issuer determines that it will not be able to continue to operate the agreement under its current terms following the Plan's establishment, activation, or material change to, any Plan investment fund; (4) the Plan fails to make the contributions required under the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

Note G - Party-in-Interest

Certain Plan investments may be managed by Fidelity Management Trust Company, current trustee of the Plan, or Voya Retirement Insurance and Annuity Company, the former custodian of the Plan, and therefore, these transactions would qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative expenses of the Plan may be paid by the Company and certain functions of the Plan may be performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
