Independent Auditor's Report

Note 1: Description of the Plan

The following description of Infomerge, LLC 401(k) Plan (the Plan) provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Infomerge, LLC (the Entity). This Entity was established as a professional employer organization and was created to provide benefits to orthopedic and other offices that were members of the entity. The Plan included three companies in 2024 and 2023 (the Companies). Employees are eligible to begin deferring contributions after attaining age 21 and completing one year of service. Employees eligible for participant deferrals are also eligible for company contributions but must be employed on the last day of the Plan year and have 1,000 hours for that Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Participating employees may elect to contribute a percentage of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred or after-tax basis. No less than 1% deferral can be made and participants can defer up to 75% of compensation subject to limitations in the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from other qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Companies may make a discretionary match contribution equal to 6% of participants compensation. The Companies have not elected a discretionary match for the years ending December 31, 2024 and 2023.

The Companies made safe-harbor contributions of 3% of the prior year compensation totaling \$286,908 and \$276,094 for the Plan years ended December 31, 2024 and 2023, respectively.

At the end of the Plan year, the Companies, at the discretion of their Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. The Companies have elected to make discretionary contributions for Plan years ended December 31, 2024 and 2023 of \$471,020 and \$463,162, respectively. Companies contributions are invested in the participant directed accounts in the same manner as the employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their deferral contributions and the employer safe harbor match. Companies discretionary contributions, plus actual earnings thereon are vested through a 6-year graded vesting plan. Participants must complete at least 1,000 hours during a vesting computation period to receive credit for that year. The schedule for vesting is 0-1 year at 0%, 2 years at 20%, 3 years at 40%, 4 years at 60%, 5 years at 80% and 6 years at 100%.

Participant Loans

Loans are not permitted under the Plan.

Payment of Benefits

Distributions are made upon death, disability, retirement, or termination of employment. The participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions are made in a lump sum or, if subject to required lifetime required minimum distribution payments, substantially equal payments. In-service distributions are permitted from the participant's account upon attaining age 59^{1/2}.

Forfeitures

Forfeitures of company matching contributions can be used to apply to employer contributions, pay Plan expenses or be directly allocated to participants accounts. Amounts forfeited during the years ended December 31, 2024 and 2023 were \$9,938 and \$28,921, respectively. During 2024, \$28,921 of forfeitures were used to offset employer contributions. During 2023, \$23,647 of forfeitures were used to offset employer contributions. Forfeiture balances at December 31, 2024 and 2023 were \$9,938 and \$28,921, respectively.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Companies are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023 the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Other expenses are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

Investment Valuation and Income Recognition

The Plan's investments are presented as determined and certified by Mid Atlantic Trust Company (the Custodian) as of the Plan's year end. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology include quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or other inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds and Money Market Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Related Party and Party in Interest Transactions

The Companies absorb the cost of audit fees related to the Plan, some administrative fees and the cost of fidelity bonds. Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. As the Plan does not reimburse for these costs, such services are not included in these financial statements.

Investment related expenses are reported as administrative expenses. Administrative functions are performed by officers and employees of the Companies. Additional party-in-interest transactions include audit fees paid to Varney and Associates, CPAs, LLC, investment advisor fees paid to Creative Planning, and third party administration fees paid to Allen, Gibbs & Houlik, LC. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time. The Companies may at any time, terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 6: Tax Status

The Companies adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
