Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of Community Action Nacogdoches, Inc. dba Greater East Texas Community Action Program 403(B) Thrift Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Community Action Nacogdoches, Inc. dba Greater East Texas Community Action Program 403(B) Thrift Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

GENERAL

The Plan is a 403(B) defined contribution thrift plan covering eligible employees of Community Action Nacogdoches, Inc. dba Greater East Texas Community Action Program (“Organization”). The Organization is the Plan Sponsor. Employees of the Organization, who are U.S. residents or resident aliens, are eligible to participate in the Plan on the entry date coinciding with, or immediately following, their date of hire. Plan entry dates are the first day of each calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

PLAN ADMINISTRATION

The Organization appoints the Plan Administrator and Plan Custodian. The Plan Administrator is an employee of the Organization. The Plan Custodian and third-party administrator is Mutual of America Life Insurance Company (“Mutual of America”). Mutual of America performs the Plan’s administrative duties such as preparation of the Form 5500, participant recordkeeping, compliance testing, if any, enrollment and transaction processing.

CONTRIBUTIONS

Participants may elect to contribute amounts on a pre-tax basis from eligible compensation not to exceed the limits of Internal Revenue Service (“IRS”) Code Section 403(B). Participants will automatically have 1% of their salary contributed to the Plan unless the participant elects out of automatic enrollment by written notice to the Plan Sponsor. The auto enrollment percentage increases by 1% per year up to a maximum of 6%. In addition, participants that reach age 50 before the close of the Plan year may make catch-up contributions. The Organization’s base contribution is equal to 1% of an eligible participant’s compensation received during the year, whether or not the employee made salary reduction contributions. Additionally, the Organization may make a discretionary matching contribution of up to 50% of the first 8% that a participant contributes to the Plan. The Organization made discretionary matching contributions of approximately \$55,000 for the year ended December 31, 2024.

PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contribution, the employer’s contributions, and Plan earnings. Allocations of Plan earnings and administrative expenses are based on participant account balances as defined in the Plan provisions. Interest income from individual participant loans is credited to the respective participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of the Organization’s base and matching contributions, plus earnings thereon, is upon completion of 3 years of service. All amounts credited to a participant’s account become fully vested upon the attainment of normal retirement age as defined by the Plan document.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant’s account and bear a reasonable rate of interest as determined by the Plan Administrator, which are commensurate with local prevailing rates as determined by local commercial banks for similar loans. Principal and interest are paid through payroll deductions.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive their vested benefit in a lump sum payment either in cash or as a direct rollover to a qualified individual retirement account or another tax-qualified plan. If the value of the participant’s vested account balance is less than \$1,000, the form of distribution will be a lump sum distribution. A participant must be age 59 ½ or have incurred a financial hardship, as defined in Plan provisions, to qualify for an in-service distribution.

NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

FORFEITURES

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$599 and \$3,472, respectively. These accounts may be used to reduce employer contributions or pay Plan expenses. Any remaining balance will be allocated to participants in the Plan at the end of the Plan year, based on Plan compensation. During the year ended December 31, 2024, \$2,873 forfeitures were allocated to participants and not used for employer contributions or towards Plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

USE OF ESTIMATES

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Participant loans are classified as notes receivable and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant fails to comply with the terms of a loan and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment, a deemed distribution, or a combination of the two.

CONTRIBUTIONS

Contributions from the Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds:

The accounts' investments consist solely of investments in mutual funds registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The mutual funds are considered Level 1 investments.

Gains and losses (realized and unrealized) included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

Investment in the Mutual of America Interest Accumulation Fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Custodian, represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. This contract is considered a traditional investment contract in which the Plan owns the contract and not the underlying assets.

The investment contract held by the Plan is a deposit administration account. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The credit rate is based on a formula established by the contract issuer and as promulgated by the National Association of Insurance Commissioner, may not fall below 1%. The crediting rate is reviewed on a monthly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the issuer's ability to meet its financial obligations which may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events that significantly affect the Plan's normal operations.

NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT – CONTINUED

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

NOTE 5 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024 was obtained from data that has been prepared and certified as complete and accurate by Mutual of America, the Custodian of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to related information included in the financial statements and supplemental schedules.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Mutual of America is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for asset charges and takeover fees totaled \$3,198 for the year ended December 31, 2024.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 – TAX STATUS

The IRS has determined and informed the Organization by a letter, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 8 – TAX STATUS - CONTINUED

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 – CORRECTION OF OPERATIONAL ERRORS AND ERISA VIOLATIONS

As allowed by the IRS and the Department of Labor (“DOL”), certain corrective actions are made available to Plan Sponsors via self-correction and Voluntary Fiduciary Correction Programs (“VFCP”). In the event of an operation error or ERISA violation, we first seek to self-correct findings, and if necessary, complete the appropriate VFCP procedures. The Plan, participants, and beneficiaries are intended to be restored to the condition that would have existed if the error or violation had not occurred. Management is not aware of any errors, violations, or corrective actions that need to be taken at this time, other than those included in the supplemental Schedule of Delinquent Participant Contributions.

NOTE 11 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.
