Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of University Support Services, LLC Cash or Deferred Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the University Support Services, LLC Cash or Deferred Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. On October 1, 2011, the Plan was restated pursuant to the Economic Growth Tax Relief Reconciliation Act.

General

The Plan is a defined contribution plan covering all full-time employees of University Support Services, LLC (the "Company") who have three consecutive months of service and have attained the age of 21. Employees may begin to make elective deferral contributions on the first day of the first month that is at least 90 days after commencing employment at the Company. Entry dates for employees are as of the first day of each month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Pension Administrative Services, Inc. serves as the Plan's third-party administrator to assist with the management of the Plan. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan documents.

Contributions

Each year, participants may contribute an amount up to the limits imposed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up deferral contributions. The maximum voluntary pre-tax contribution permitted by federal tax law was \$23,000 in 2024, and the maximum allowable catch-up contribution for 2024 was \$7,500, for a total maximum contribution of \$30,500 for eligible participants during 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans as rollover contributions. The employee deferral and rollover contributions are invested by John Hancock Life Insurance Company of New York ("John Hancock"), the trustee under the direction of the individual participant into the various investment options offered by the Plan. Employees who have completed at least 150 hours of service during the Plan year and are employed by the Company at the end of the year, are eligible for matching contributions at the discretion of the management of the Company.

The Plan allows for the application of Safe Harbor CODA Provisions for all employees and instituted an employer match program. The employer match is 100% on elective deferrals less than or equal to 3% and an additional 50% on elective deferrals greater than 3%, but less than or equal to 5%.

Participant Accounts

Each participant's account is credited with the participant's deferral, employer contributions, rollover contributions and an allocation of the Plan earnings, and charged with an allocation of the Plan's administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary deferral contributions and employer matching contributions, plus or minus the actual earnings (losses) thereon.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. A maximum of two loans are permitted at any one time, and the loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with the local prevailing interest rates as determined quarterly by the Plan administrator. As of December 31, 2024 and 2023, outstanding loans bear interest at 4.00% to 9.5%. Principal and interest are paid ratably through bi-weekly payroll deductions by the Company.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive the payment of benefits in the form of a: (i) qualified joint and 50% survivor annuity for married participants or a life annuity for unmarried participants; (ii) a lump-sum amount; or (iii) monthly, quarterly, semiannual or annual installments for a term certain or escalating payments over a period not to exceed the life expectancy of the participant or designated beneficiary, equal to the value of the participant's vested interest in his or her account. Employees are eligible at any time to request a rollover distribution as a lump-sum payment that must be made directly to another eligible retirement plan. If the employee's vested balance is \$1,000 or less, the payment of benefits will be in the form of a lump-sum amount.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value (see Note 4 for additional information). Interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable

Notes receivable are valued at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant loans are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - CERTIFIED INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, John Hancock, the trustee of the Plan, has certified that the following information in the accompanying financial statements and supplemental schedule is complete and accurate:

- Total investments and notes receivable, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total net investment income and interest income on notes receivable, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan follows guidance that establishes a single authoritative definition of fair value measurements used in financial statements, provides enhanced guidance for measuring the fair value of assets and liabilities and requires additional disclosures related to the extent to which assets and liabilities are measured at fair value, the information used to measure fair value, and the effect of fair value measurements on earnings. Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants exclusive of any transaction costs, and are determined by either the principal market or the most advantageous market. The principal market is the market with the greatest level of activity and volume for the asset or liability. Absent a principal market to measure fair value, the Plan would use the most advantageous market, which is the market that the Plan would receive the highest selling price for the asset or pay the lowest price to settle the liability, after considering transaction costs. However, when using the most advantageous market, transaction costs are only considered to determine which market is the most advantageous, and these costs are then excluded when applying a fair value measurement.

The guidance creates a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below, with Level 1 having the highest priority and Level 3 having the lowest:

- Level 1 - Valuations for assets and liabilities traded in active exchange markets, such as the New York Stock Exchange. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.
- Level 2 - Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third-party pricing services for identical or similar assets or liabilities.
- Level 3 - Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer, or broker-traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There are no changes in the methodologies used at December 31, 2024 and 2023:

Pooled separate accounts: Valued at the unit value at year end as determined by the issuer. These pooled separate accounts can be traded daily and are considered to have a readily determinable value (Level 1).

All of the Plan's investments are classified as Level 1 in the fair value hierarchy as of December 31, 2024 and 2023.

NOTE 5 - RELATED PARTY TRANSACTIONS

Certain plan investments are shares of pooled separate accounts managed by John Hancock which are affiliates of the Plan's trustee, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation of investments.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become fully vested in their employer contributions.

NOTE 7 - INCOME TAX STATUS

The underlying standardized prototype plan has received an opinion letter from the IRS dated March 31, 2014 stating that the written form of the underlying prototype document is qualified under Section 401(a) of the Internal Revenue Code (the "Code"). Any employer adopting this form of the Plan is considered to have a plan qualified under Section 401(a) of the Code. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore believes the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 14, 2025, the date these financial statements were available to be issued. There have been no subsequent events that required adjustment to or disclosure in the financial statements as of and for the year ended December 31, 2024.
