Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. Our opinion is not modified with respect to that matter.

NOTES TO FINANCIAL STATEMENTS (MODIFIED CASH BASIS) DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Nixon Peabody LLP Retirement Savings Plan I (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is an age-weighted profit sharing plan covering all non-attorney employees, Class 1 counsel, and partners of Nixon Peabody LLP (the Firm) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is sponsored by the Firm and is administered by the Pension Committee. Fidelity Management Trust Company (Fidelity) is the custodian and trustee of the Plan's assets. Fidelity Workplace Services, LLC (FWS) is the recordkeeper of the Plan's assets.

Eligibility

All non-attorney employees, Class 1 counsel, and partners of the Firm who meet certain eligibility requirements are eligible to participate with respect to participant contributions on the first day of the month coincident with or following the first day of active employment. With respect to Firm contributions, participation is allowed on January 1 or July 1 following the completion of one year of service.

Participant Contributions

Active participants may make voluntary pre-tax or after-tax contributions in the form of salary reductions up to 75% of their annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). In addition, any employee who has attained age 50 by the Plan year-end is eligible to make catch up contributions, subject to certain limitations of the IRC. Participants may direct the investment of their contributions and all Firm contributions and related earnings thereon into various investment options offered by the Plan, including self-directed brokerage accounts. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

Employer Profit Sharing Contributions

The Plan provides for a profit sharing contribution on behalf of the Firm to the accounts of active participants in an amount which corresponds to the participant's age and compensation level as follows:

1. DESCRIPTION OF PLAN (Continued)

Employer Matching Contributions

The Plan provides for an employer matching contribution to the accounts of eligible active participants. The amount of the employer matching contribution is equal to the lesser of 2% of compensation or 50% of the aggregate amount contributed by each participant during a plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Firm's contribution, and an allocation of the participant's share of the Plan's income/loss and administrative expenses. Allocations are based on participant earnings/losses, or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administrative Expenses

Certain administrative expenses associated with the Plan are paid by Plan participants by deduction from their accounts by a combination of allocation of expense based on percentage of assets and per participant charges. Fidelity provides for a revenue credit program whereby fees paid to Fidelity in excess of agreed upon totals may be added to eligible participant accounts. Such credits are reported as offsets to deductions for administrative expenses. Administrative expenses are shown net of revenue sharing credits on the statements of changes in net assets available for benefits (modified cash basis). Administrative expenses not paid by the Plan are paid by the Firm.

Vesting

Participants have a 100% vested interest in their entire account balance at all times.

Payment of Benefits

Upon termination of employment, death, disability, or retirement, a participant or his/her beneficiary may elect to receive either a lump sum amount equal to the value of the participant's total account balance or periodic payments.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from participant accounts. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Notes Receivable from Participants

Participants are allowed to borrow up to the lesser of 50% of their vested account balances or \$50,000 reduced by the excess of: (1) the participant's highest outstanding loan balance during the preceding one year period or (2) the participant's loan balance outstanding on the date of the loan. The loans bear interest at a rate determined by the Pension Committee, as defined by the Plan document. The period of repayment for loans may not exceed five years, unless the loan is used for the purchase of a principal residence, in which case the loan repayment term may be up to ten years.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Accounting principles generally accepted in the United States of America require accrual basis accounting for contributions, interest, dividends, and expenses (except for benefits paid to participants). The Plan records such items on a modified cash basis of accounting, however, the modified cash basis of accounting is an acceptable financial statement presentation method under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under the modified cash basis of accounting, contributions, interest, and dividends are recognized when received. Benefit payments and other expenses, such as trustee's fees, are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and proceeds from sales are recorded on a trade-date basis. Dividends and interest income are recorded when received.

Common collective trust investments are reported at fair value using net asset value (NAV) as a practical expedient. The common collective trust is invested in short-term bonds and other fixed income securities. The NAV of the fund is principally derived from the contractual terms of the underlying contracts. The fund purchases third-party wrap contracts designed to maintain a constant NAV and to provide for the payment of participant-directed withdrawals and exchanges at book value under most circumstances. The NAV of the fund is then calculated daily and posted by Fidelity.

Self-directed brokerage accounts are primarily invested in cash, money market funds, certificates of deposits, mutual funds, common stock, U.S. government and agency obligations, and corporate bonds. Cash and certificates of deposits are stated at fair value which approximates cost. Mutual funds, money market funds, common stocks, U.S. government and agency obligations, and real estate mutual funds are stated at fair value, based on quoted market prices. Corporate bonds are valued at fair value, determined by matrix pricing using known, observable inputs for similar assets, including interest rates and maturity dates.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement

Accounting Standards Codification (ASC 820) framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 Inputs - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

The Plan's investments in certificates of deposit, money market funds, mutual funds, common stocks, U.S. government and agency obligations, and real estate mutual funds are primarily valued utilizing Level 1 inputs. Investments in cash and certificates of deposit are valued at fair value which approximates cost.

- Level 2 Inputs - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

The Plan's investments in corporate bonds are primarily valued utilizing Level 2 inputs.

- Level 3 Inputs - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The Plan has certain other investments held outside of Fidelity, which are primarily valued utilizing Level 3 inputs.

Management determines the fair value measurement valuation policies and procedures, including those for Level 3 recurring and nonrecurring measurements. At least annually, management: (1) determines if the current valuation techniques used in fair value measurements are still appropriate, and (2) evaluates and adjusts the unobservable inputs used in the fair value measurements based on current market conditions and third-party information.

There were no changes in the valuation methodology used during 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Benefit Payments

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, currency, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

5. PARTY-IN-INTEREST TRANSACTIONS

Fidelity is the trustee and custodian of the Plan's assets and FWS is the recordkeeper of the Plan's assets. As such, transactions between Fidelity, FWS, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

6. TRANSFERS OF PLAN ASSETS

Participant accounts totaling \$3,657,134 and \$1,636,572 were transferred into the Plan from the Nixon Peabody LLP Retirement Savings Plan II and Nixon Peabody LLP Retirement Savings Plan for Associate Attorneys in 2024 and 2023, respectively. There were no amounts transferred from the plan in 2024 and 2023.

7. TAX STATUS

The Plan is exempt from Federal income taxes under the provisions of Section 501(a) of the IRC. The plan administrator received a favorable determination letter from the Internal Revenue Service dated August 27, 2013. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Firm has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will remain fully vested.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 15, 2025 which is the date the financial statements were available to be issued.
