### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ohio Transmission Holding LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Opinion

#### Note 1. Description of the Plan

The following description of Ohio Transmission Holding LLC 401(k) Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan sponsored by Ohio Transmission Holding LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was most recently amended effective January 1, 2023, to update the vesting schedule for the employer matching contributions.

All active employees of the Company are eligible to participate in the Plan on the first day of the next month following attainment of age 21 and completion of one month of service. To participate in the employer annual matching contribution, participants must have been credited for at least 1,000 hours of service during the plan year and be an active employee on the last day of the plan year, unless retired or deceased during the year. The Company amended the Plan, effective January 1, 2023, where all matching employer contributions vest 100% immediately.

**Contributions:** Each eligible employee may elect to contribute, through payroll deduction, 1% to 60% of their annual compensation, subject to Internal Revenue Code (IRC) limitations. Eligible employees are automatically enrolled in the Plan with an elective pretax deferral rate of 6% of compensation, unless the participant affirmatively elects out of the automatic deferral feature or elects a different deferral rate. Participants may change their contribution amount at any time and may also make Roth deferral contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Nondiscretionary employer matching contributions are 50% of 6% of the participant's eligible compensation contributed to the Plan.

The Company may also make additional matching and discretionary profit-sharing contributions. No additional matching or discretionary profit-sharing contributions were made during 2024.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of: (a) Company matching and profit-sharing contributions and (b) Plan earnings and losses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting and forfeitures:** Participants are immediately vested in their contributions and the Company's matching contributions plus actual earnings thereon. Employees become vested in the Company nonelective contributions at 20% per year of service and are fully vested at the end of five years. Participants who have attained normal retirement age or have terminated as a result of death or disability are immediately fully vested in Company matching contributions and additional discretionary amounts contributed by the Company, plus actual earnings thereon. Forfeitures are used to reduce Company matching contributions. The balance of forfeited non-vested accounts totaled approximately \$85,000 and \$299,000 at December 31, 2024 and 2023, respectively. Approximately \$60,000 of forfeitures were used to reduce employer contributions subsequent to December 31, 2024, in February 2025.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions in a variety of investment choices more fully described in the Plan's literature. Participants may change their investment options at any time.

#### Note 1. Description of the Plan (Continued)

**Participant notes receivable:** Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by the balance in the participant's account and bears interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. Participants are limited to one outstanding note at any given time. Principal and interest is paid ratably through payroll deductions. Interest rates on participant loans ranged from 4.25% and 9.50% as of December 31, 2024 and 2023, respectively.

**Payment of benefits:** Upon normal retirement at age 65, early retirement at age 60 and completion of 15 years of service, attainment of age 59½, total disability or termination of service, participants may elect to receive of a lump-sum payment, installment payments or partial withdrawals. Upon the death of a participant, the beneficiary shall be entitled to the full value of the accounts. Hardship withdrawals, as defined in the Plan, are also available to participants.

**Plan termination:** Although the Plan Sponsor has not indicated any intent to do so, it has a right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements have been prepared using the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest.

**Contributions:** Participant contributions are recognized when earned. Employer contributions are recognized when declared.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain administrative expenses are paid by the Company and are excluded from these financial statements. Certain fees related to administration, transactions or notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**Risk and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified by Fidelity Management Trust Company and Principal Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Fidelity Management Trust Company (Fidelity) and Principal Trust Company (Principal), the trustees of the Plan. The Plan Administrator has obtained certifications from the trustees that information provided to the Plan Administrator by the trustees related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets.

Fidelity and Principal also certified to the completeness and accuracy of \$15,797,680 of net appreciation in the fair value of investments, \$1,807,115 of interest and dividend income related to investments, and \$173,293 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 guidance are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Money market fund:** Valued at the closing price reported on the active market on which the individual security is traded.

**Mutual funds:** Valued at the net asset value (NAV) of shares held by the Plan at year-end.

**Shares of common/collective trusts:** The common/collective trusts are valued at the NAV of the units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

#### **Note 5. Tax Status**

The Plan has adopted a non standardized form of a preapproved plan. The preapproved plan provider, Fidelity, has received on June 30, 2020, an opinion letter from the Internal Revenue Service as to the preapproved plan's qualified status. The preapproved opinion letter has been relied upon by this plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2021.

#### **Note 6. Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity. Fidelity as one of the trustees defined by the Plan during the plan year, qualify as party-in-interest transactions. During 2024, the Plan paid administrative fees of approximately \$294,000 to Fidelity and their affiliates.
