INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wirt County Health Association, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Wirt County Health Association, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Wirt County Health Association, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

1 – DESCRIPTION OF PLAN

The following description of the Wirt County Health Association, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a tax sheltered annuity plan as described under the Internal Revenue Code section 401(k). The Plan is participant directed and covers all employees of the Wirt County Health Association, Inc. (the Association) within one year following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions

Each year, participants 18 years of age or older with one year of service may contribute up to 100% of their W-2 compensation on a pre-tax basis, subject to the maximum allowable amount as set forth in the Internal Revenue Code. Participant contributions may be pre-tax salary deferrals or after-tax Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows rollover contributions from other qualified plans. The Plan allows for matching contributions whereby the Plan sponsor matches 100% of the first 3% deferred by the participant and 50% of any amount in excess of 3% to a maximum of 5%. In no event will the matching contribution exceed 4% of the participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) The Plan's matching contributions (b) plan earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested in their contributions immediately. For non-elective contributions, participants vest according to the following schedule:

Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of services for other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's account balance. Participants are eligible for in-service benefits payments granted they are above normal retirement age of 59 ½. Participants may elect to distribute their rollover contributions while in-service however other in-service distributions under normal retirement age are not allowed unless the participant has demonstrated an undue financial hardship.

Notes Receivable from Participants

Loans will be permitted only from participant's elective deferral account. Participants may borrow from their account a maximum equal to \$50,000 of their account balance less the highest outstanding balance of loans in the past 12 months or one-half the present value of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the local prevailing rates. Principal and interest will be paid through payroll deduction consistent with the plan sponsor's normal payroll cycle.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,823 and \$6,664, respectively.

2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Administrative expenses paid by the Plan included investment fees and account withdrawal fees.

3 – INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Retirement (the custodian of the Plan).

4 – FAIR VALUE MEASUREMENTS

Authoritative guidance issued by the Financial Accounting Standards Board established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1: Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2: Inputs consist of observable inputs other than quoted prices for identical assets.

Level 3: Inputs consist of unobservable inputs and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Methodologies: The following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies: Valued using market quotations. Valued at closing accumulated unit value held by the Plan.

5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan's position in the Massachusetts Mutual Life Insurance Company Fixed Account as of December 31, 2024 and 2023 is a traditional investment contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on an annual basis for resetting. The contract has no scheduled maturity date. The crediting rate at December 31, 2024 and December 31, 2023 was 2.90% and 2.80%, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic conditions and regulatory changes.

Certain events may limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401 (a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501 (a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes in the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestiture or spinoffs of a subsidiary) that significantly affect the Plan's normal operation.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligations under the contract.
3. A material misrepresentation.
4. A material amendment to the agreement without the consent of the issuer.

The contract value of the fixed account was \$397,245 and \$387,631 as of the year ended December 31, 2024 and 2023, respectively.

6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distribution of participant accounts will be made as permitted under federal law.

7 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan Administrator by a letter dated March 31, 2014, that the prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

9 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Plan Sponsor, and certain others. During the years ended December 31, 2024 and December 31, 2023, transactions with parties-in-interest primarily included certain administrative functions performed by the Plan Sponsor and employees of the Plan Sponsor at no cost to the Plan. Certain investments of the Plan include accounts invested with the custodian.

10 – SUBSEQUENT EVENTS

The Plan's management has evaluated events and transactions occurring after December 31, 2024 through the date of the Auditors' report, which is the date the financial statements were available to be issued.



