## Independent Auditor's Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the East Valley Tourist Development Authority dba Fantasy Springs Resort Casino 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **NOTE 1 - PLAN DESCRIPTION**

The following description of the East Valley Tourist Development Authority dba Fantasy Springs Resort Casino 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Cabazon Band of Cahuilla Indians and East Valley Tourist Development Authority dba Fantasy Springs Resorts Casino, Inc. (the "Employer") who have completed four months of service and attained the age of 18. The Trustee of the Plan is Empower Annuity Insurance Company of America ("Empower"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Eligibility**

Employees who complete four months of service and have attained the age of 18 are eligible to participate.

#### **Contributions**

Each year, the participants may elect to defer a percent of pre-tax annual compensation as defined by the Plan. The total deferral may not exceed the maximum dollar limit allowed by the Internal Revenue Code ("IRC") of \$23,000, plus \$7,500 if the employee is age 50 or older for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Employer may contribute a matching amount equal to or up to 100% of the salary that the participant elects to defer. This contribution by the Employer is discretionary and determined yearly. Contributions are subject to certain limitations. For the year ended December 31, 2024, the Employer's matching contribution was 25% of the employee contributions to the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Employer's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE 1 - PLAN DESCRIPTION (Continued)

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The vesting percentage in the participants' accounts for Employer's matching contribution is determined under the following schedule and is based on vesting years of service as defined by the Plan. Vesting is at 100 percent at normal retirement age, early retirement age, or if a participant incurs a severance from employment as a result of death or disability.

#### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the vested interest in the participant's account or installments over a period of not more than the assumed life expectancy of the participant or the beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Additionally, under certain circumstances of financial hardship or qualified reservist, the participant is allowed to withdraw funds from the Plan. Benefits are recorded when paid.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made, or 50% of their vested account balance reduced by any outstanding loan balance. The numbers of outstanding loans are limited to two and a maximum of two loan initiations within a Plan year. The loans are secured by the balance in the participant's account and may be repaid in level payments through payroll deductions or through additional direct payment to the Plan over a five-year period, except for the purchase of a principal residence, the loans for which are repaid over a reasonable period of time that may not exceed five years. The loans bear interest rates that are based on the U.S. Federal Reserve bank prime rate plus 1%, and currently range from 4.25% to 9.5%. No allowance was considered necessary as of December 31, 2024 or 2023.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 or 2023. Notes receivable outstanding on December 31, 2024 and 2023 were \$1,629,515 and \$1,374,858, respectively.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

#### **Use of Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition:**

The Plan’s investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

#### **Payment of Benefits:**

Benefits are recorded when paid.

#### **Administrative Expenses:**

Plan administrative expenses are paid by the Plan, unless paid by the Company.

#### **Forfeited and Plan Expense Accounts:**

Forfeitures resulting from the nonvested portions of participants’ accounts that terminate prior to being fully vested are generally used first to pay the administrative expenses of the Plan, and any remaining amounts may be used to reduce future Employer’s contributions. The outstanding balances for forfeiture and plan expense accounts at December 31, 2024 and 2023 were \$154,207 and \$140,763, respectively. The Plan used \$21,310 to pay administrative expenses for the year ended December 31, 2024.

Accordingly, as permitted under such election, Empower Annuity Insurance Company of America ("Empower") for the years ended December 31, 2024 and 2023, has certified that the following data included in the accompanying financial statements, the related investment activity and supplemental schedule is complete and accurate.

### NOTE 4 - FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurement* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

### NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques must maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### *Mutual Funds*

Mutual funds are valued at their daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily quoted net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Plan's investments in mutual funds were classified as Level 1 investments at December 31, 2024 and 2023.

#### *Pooled separate accounts*

The fair value of the Plan's investments in pooled separate accounts is measured using NAV as a practical expedient. NAV of these investments is based on the value of the underlying assets owned by the fund, minus liabilities, and then divided by the number of units outstanding.

#### *Funds Held in Insurance Company General Account*

The funds held in insurance company general account are valued based on the NAV per unit of participation in the fund and has no unfunded commitments. The NAV as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such transfers, the transfer is reported at the beginning of the reporting period. The significance of transfers between levels is based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers between levels for the years ended December 31, 2024 and 2023.

### NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds and funds held in the Plan insurance company general account managed by Empower. Empower is the trustee as defined by the Plan and therefore these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the earnings on each fund.

### NOTE 6 - PLAN TERMINATION

Although no intent to terminate the Plan has been expressed, the Employer has the right to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in the Employer contribution portion of their accounts.

### NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 8 - TAX STATUS

The United States Department of Treasury, Internal Revenue Service (“IRS”) has determined and informed the Employer that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The related trust, therefore, is not subject to tax under present income tax law.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Employer has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is also subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
