Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Del Lago Resort & Casino 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to the Financial Statements

1. Description of the Plan

The following description of the Del Lago Resort & Casino 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established under Section 401(a) of the Internal Revenue Code (IRC). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective September 1, 2018, and covers all eligible employees of Del Lago Resort & Casino (the Company, Sponsor and Plan Administrator). During 2022, Churchill Downs Inc. acquired the Sponsor through a purchase agreement with Peninsula Pacific Entertainment LLC.

In November 2024, the Plan changed custodians (see Note 3) and transferred all of its assets to Fidelity Investments (Fidelity).

Eligibility

All employees that have worked a minimum of six months of service and reached 21 years of age are eligible to participate in the Plan. Eligible participants can enter the Plan on the first day of the month subsequent to meeting the eligibility requirements.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the IRC. Eligible participants are permitted to elect to have a percentage, limited by plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Sponsor may, at its discretion, elect to make a qualified matching contribution to the Plan. For the years ended December 31, 2024 and 2023, the Sponsor did not offer a matching contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations determined by Internal Revenue Service (IRS) regulations.

Participant Accounts

Each participant's account is credited with the participant's and the Sponsor's contributions and allocations of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of the Plan, continued

Investment Options

Participants may, upon enrollment in the Plan, elect to invest their contributions and the Sponsor's contributions in 1% increments in any of the various investment options currently offered by the Plan. Periodic transfers among funds of certain accumulated account balances and directions of future employee deferral and Sponsor contributions are permitted.

Vesting

Participants are immediately vested in their contributions, plus actual earnings (losses) thereon. Vesting in the Sponsor matching contributions portion of their accounts, plus actual earnings (losses) thereon, is based on credited years of service. A participant vests 20% per year after the first year of service, and is 100% vested after five years of credited service. If a participant dies or becomes disabled, he or she is automatically 100% vested in all accounts.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's fully vested interest in his or her account. Participants may also request distributions at any time upon attainment of normal retirement age of 65 or due to the occurrence of hardships (as defined by the Plan document).

Forfeited Accounts

All forfeitures are applied to Plan expenses and Plan Sponsor contributions. There are no forfeited nonvested accounts as of December 31, 2024 and 2023. No forfeitures were used to reduce plan expenses for the year ended December 31, 2024.

Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive insurance contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for fully benefit-responsive insurance contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for disclosures related to the fair value of investments. The Plan's 401(k) Committee determined the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the participant compensation is earned.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023, there were no outstanding payments to persons electing to withdraw from the Plan.

Administrative Expenses

The Plan is responsible for its administrative expenses unless paid by the Sponsor.

Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 14, 2025, the date that the financial statements were available to be issued.

3. Information Certified or Provided by the Custodians

Effective November 1, 2024, Fidelity replaced Principal Trust Company (Principal) as custodian to the Plan. The Plan's investment information included in this note and throughout the Plan's financial statements and the supplemental schedules was prepared by or derived from information provided by Fidelity, the current custodian of the Plan, and Principal, the former custodian of the Plan, and furnished to the Plan Administrator. The assets of the Plan were transferred from Principal to Fidelity during 2024. The Plan Administrator has obtained certifications from Fidelity from November 1, 2024 to December 31, 2024 and as of December 31, 2024 and from Principal from January 1, 2024 to October 31, 2024 and as of October 31, 2024 and December 31, 2023 that investment information provided to the Plan Administrator by the current and former custodians related to the investment information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and ERISA-required supplemental schedules.

The current and former custodians also certified to the completeness and accuracy of \$186,663 of net realized and unrealized appreciation in the fair value of investments and \$47,906 of interest and dividends related to the investments for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements, continued

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: Valued based on the NAV of units of the collective trust. The NAV, as provided by the custodians, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

The collective trusts invest in a stable value fund which includes investment contracts issued by insurance companies, cash equivalents, and separate account investment contracts. Investments in this category can be redeemed immediately upon request. The fair value of investments in this category has been estimated using the NAV of the units of Participation in the fund.

5. Investment Contracts with Insurance Company

The Plan has a fully benefit-responsive insurance contract with Standard Insurance Company (Standard). Standard maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor event (e.g., divestures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rate was 3.70% as of December 31, 2024. Such interest rates are reviewed on a quarterly basis for resetting. The average yield for the year ended December 31, 2024 was 3.70%.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the custodians of the Plan, Fidelity and Principal. Investments in these accounts qualify as party-in-interest transactions. Administrative expenses of \$10,381 for the year ended December 31, 2024 are comprised of fees paid by the Plan to Fidelity and Principal for recordkeeping services, investment management services and withdrawal charges.

Additionally, indirect fees are paid to Fidelity and Principal based on investment account values. These fees range from 0.02% to 0.68% of the investment account value. The fees reduce net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

7. Tax Status

The Plan uses a prototype Plan document sponsored by Fidelity. Fidelity received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

8. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Prohibited Transactions

During the year ended December 31, 2024, participant withholdings in the amount of \$22,140 were not remitted within the appropriate time period by the Plan Sponsor. These transactions constitute prohibited transactions as defined by ERISA. The Plan Sponsor is aware of the occurrences and has taken the appropriate steps to correct the situation by implementing procedures to ensure all future remittances are completed within the prescribed time period. These transactions were fully corrected during the year ended December 31, 2024.
