INDEPENDENT AUDITOR'S REPORT

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO THE FINANCIAL STATEMENTS

NOTE 1—DESCRIPTION OF PLAN

The following description of the Libertas Copper, LLC Hourly Employees Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan, effective November 1, 1986, which is available to any hourly employee of Libertas Copper, LLC (“Company”) who is a maintenance or production employee, is represented by the United Steelworkers of America (“USW”), and has completed the probationary period specified in the agreement between the Company and the USW or, alternatively, has completed at least 1,000 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company acquired the assets and certain of the liabilities of the previous Plan sponsor, Hussey Copper, Ltd., in 2011. The Plan’s name was changed, but the Plan continued operating without any other changes.

Ascensus Trust Company serves as trustee of the Plan. The Vanguard Group, Inc. serves as custodian and holds all Plan assets, invests cash received in accordance with participant direction, receives and records interest and dividend income, and makes distributions to participants.

Contributions – Participants may elect to contribute up to the maximum percentage of eligible compensation as defined by the Plan agreement, subject to IRS dollar limitations. The Plan includes an automatic contribution provision for employees. If a participant fails to elect an alternative contribution amount or fails to elect not to contribute, the Company will automatically defer 3% of the participant’s compensation beginning on the participant’s eligibility date; there is no automatic escalation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual fund investment options for participants. Contributions are subject to certain limitations as defined in the Plan agreement and as limited by statute.

The Company may make discretionary matching contributions to the Plan at the option of the Company’s Board of Directors. If made, discretionary contributions are allocated in a nondiscriminatory manner based upon each contributing participant’s elective deferrals.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and (b) Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, with at least 1,000 hours of service required to be credited for a year of service. Vesting accrues as follows:

Participants who have attained the age of 65 while employed by the Company and those who have died or become disabled before termination of employment are 100% vested.

Notes Receivable from Participants – Effective October 26, 2018, the Plan was amended to allow participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant may only have one outstanding note at a time. The notes are secured by the balance in the participant's account and bear interest at a fixed rate of interest of one percent (1%) above the prime interest rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – Upon termination or disability, participants are eligible to receive a distribution equal to the value of the participant's vested interest in his or her account. Distributions are generally payable via either a lump-sum cash payment or cash installments. A participant's account may be distributed as soon as practicable after the end of any calendar month following his or her termination or disability. Distribution of a participant's account may not be postponed beyond December 31 following his or her 65th birthday, unless the participant elects otherwise with the consent of the Plan administrator. The Plan allows for automatic distributions of such participant account balances that do not exceed \$5,000.

Pre-Retirement Distributions – Hardship distributions are allowed by the Plan.

Forfeited Accounts – Any portion of a participant's account which is not vested is forfeited upon the participant's termination of service. Amounts forfeited can be reallocated to the remaining active participants to reduce the Company's matching contributions or to pay administrative expenses. During 2024 and 2023, no forfeitures were reallocated. At December 31, 2024 and 2023, the forfeiture account balances for future reallocation were \$57,818 and \$51,792, respectively.

Investment Options – Upon enrollment in the Plan, a participant directs the investment of his or her contributions and Company contributions into various investment options offered by the Plan. Participants may change their investment selections for future contributions or may transfer funds among these options on any business day.

Administrative Expenses – Administrative expenses, except for certain custodial expenses of the Plan, are paid by the Company or paid by forfeiture credits.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that could affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Net appreciation or depreciation in fair value of investments includes realized gains and losses on investments sold during the year as well as the current year change in unrealized appreciation and depreciation of investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded as earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

The Plan has adopted a prototype non-standardized profit-sharing plan document sponsored by Ascensus Trust Company. The IRS has determined by a letter dated June 30, 2020 that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is a qualified plan as described in Section 401(a) of the IRC and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's purpose would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 3—INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The trustee of the Plan has certified that certain information disclosed in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023, in accordance with DOL Regulation 2520.103-5. Such information includes the composition, cost and current value of all investments and notes receivable from participants held as of December 31, 2024 and 2023, as reported in the statement of net assets available for benefits and supplemental schedule, and the interest, dividends, and net appreciation (depreciation) in fair value

of investments and interest from notes receivable from participants, as reported in the statement of changes in net assets available for benefits for the years then ended.

NOTE 4—FAIR VALUE MEASUREMENTS (UNAUDITED, SEE NOTE 3)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted Prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (including Money Market Mutual Funds): Shares of registered investment companies (mutual funds) are reported at fair value based on the quoted market price of the fund which represents the net asset value of the investments held by the fund at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5—PLAN AMENDMENT AND TERMINATION

It is the intention of the Company to continue the Plan indefinitely and to make contributions as herein provided. The Company reserves the right, in its sole discretion, by written action of the Plan Committee, to amend the plan, terminate the plan, or to reduce or cease contributions at any time. Notwithstanding any other provision of this Plan, no action to amend or terminate the Plan may have the effect of decreasing, denying or otherwise adversely affecting any benefit to a participant that is a "protected benefit" within the meaning of Code Section 411(d)(6) and the Treasury Regulations thereunder. In the event of Plan termination, participants will become 100% vested in amounts attributed to the Company's contributions.

The Plan was last amended and restated effective January 1, 2024.

NOTE 6—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others.

Notes receivable from Plan participants qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

Certain Plan investments are shares of mutual funds managed by The Vanguard Group, Inc., the custodian of Plan assets. Therefore, these transactions qualify as party-in-interest transactions.

During the years ended December 31, 2024 and 2023, administrative fees of \$45,320 and \$25,736, respectively, were paid by the Plan to the trustee, which qualify as party-in-interest transactions. Additionally, The Plan sponsor also pays certain fees and expenses of the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8—SUBSEQUENT EVENTS

Management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements as of the date of the independent auditor's report, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures, as stated herein.
