Opinion

NOTE 1 - PLAN DESCRIPTION

The following brief description of the Vance Outdoors Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for complete information.

Vance Outdoors, Inc. (the Sponsor or Company) established the Plan effective as of January 1, 2020, and operates as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an Administrative Committee comprised of three persons appointed by the Company's Board of Directors.

Eligibility

Employees of the Company, who have reached 21 years of age, are generally eligible to participate in the Plan after one year of service providing they worked at least 1,000 hours during such Plan year. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

Employer Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans, if any, and to pay retirement benefits in accordance with Plan provisions.

Payment of Benefits

Distributions on account of death, disability, retirement or separation of service are made in a lump sum or equal installments over a period not to exceed five years. Distributions are made as soon as practicable but no later than the Plan year following the event. The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Distributions are made in cash or a direct rollover to an individual retirement account or individual retirement annuity and recorded when paid.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the majority of the administrative expenses for the Plan.

Voting Rights

The Plan Administrator has the right to direct the Trustee as to the voting of allocated Company stock on any matter upon which any other shareholders of the Company have a right to vote except that participants have the right to direct the Trustee regarding any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all Company assets, or any similar matter.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's points relative to total eligible points. Participants receive one allocation point for each \$1,000 of compensation earned during the Plan year and one allocation point for each year of service earned as of the last day of the Plan year. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company as follows:

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify may receive a cash distribution, transfer the proceeds to another qualified plan maintained by the Company, or elect a direct rollover to an individual retirement account.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's allocation points to total allocation points for the Plan year. During 2024, 2,252.8653 shares were forfeited from participant accounts. A total of 344.5577 shares were used to reinstate the accounts of five participants, the remaining shares were reallocated to participants based upon the eligible points. Forfeited cash balances of terminated non-vested accounts allocated to remaining participants during the plan year December 31, 2024 totaled \$0.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Cash and Cash Equivalents

The Plan considers all short-term investments with an original maturity of three months or less to be cash equivalents.

Investment Valuation and Income Recognition

The shares of Company common stock are valued at fair value. See Note 6 for discussion of fair value measurements. Dividend income, if any, is accrued on the ex-dividend date.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - TAX STATUS

The Plan has received a determination letter from the Internal Revenue Services dated August 31, 2022, stating that the Plan is qualified, under the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has not been amended since receiving the determination letter. The Plan Administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, The Plan Administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

NOTE 3 - TAX STATUS - CONTINUED

Accounting principles generally accepted in the United States of America require management of the Plan to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. There are currently no audits for any tax periods in progress.

NOTE 4 - ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of Vance Outdoors, Inc., common shares, are held by the Trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on loans, if any.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

NOTE 6 - FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 6 - FAIR VALUE MEASUREMENTS - CONTINUED

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023:

The Sponsor Company common stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques. Unobservable inputs consist of EBITDA, net income, weighted average cost of capital, discount rate, discount for lack of marketability, comparable public companies, revenue multiple, and EBITDA multiple.

The valuation process involves Plan Trustee's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with the Trustee, reviews in detail, discusses, and approves. The results of this process are documented in minutes of the Plan.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 - LOAN PAYABLE

In August 2021, the Plan entered into a \$43,001,696 term loan agreement with the Company. The proceeds of the loan were used to purchase 477,282 shares of Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. In 2024, \$24,616,123 of the outstanding balance on the loan was forgiven, effectively reducing the original purchase price.

The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year scheduled payments divided by the total of this year's scheduled payments, plus all future years' principal and interest payments. This resulted in 9,573 and 9,573 shares being released and allocated for the years ended December 31, 2024 and 2023, respectively.

The loan agreements provide for the loans to be repaid over 50 years with fixed interest rates of 1.89%. The balance of the note payable as of December 31, 2024 and 2023, was \$15,914,945 and \$41,079,472, respectively.

NOTE 8 - RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock and has indebtedness to the Company. These are related party and party-in-interest transactions. As described in Note 1, the Company has historically paid the administrative expenses for the Plan. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 10 - PLAN TERMINATION

Although it has not expressed any intent to do so, under ERISA, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Administrative Committee directs the Trustee to pay all liabilities and expenses of the Plan and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loans. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

NOTE 11 - PARTIAL FORGIVENESS OF ESOP LOAN

In 2024, the ESOP Plan received partial forgiveness of the outstanding loan principal. The amount of principal forgiven was \$24,616,123. The primary purpose of the forgiveness was to enhance the financial stability of the Plan. The remaining loan balance as of December 31, 2024 was \$15,914,945, which will be repaid according to the original terms as adjusted for the principal reduction.
