### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Castlelake, LP Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(c) audit]. Notes to the Financial Statements

December 31, 2024 and 2023

## 1. Description of Plan

The following brief description of the Castlelake, LP Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the Internal Revenue Code ("IRC"). The Plan Sponsor, Administrator, and Employer is Castlelake, LP (the "Company"). The Plan was formed January 1, 1993 and was amended effective April 29, 2024 by adopting the material modification of provisions of the Castlelake, LP Retirement Savings Plan. The Custodian of the Plan is Empower (the "Custodian").

### **Eligibility**

Substantially all full-time employees who have reached 21 years of age and completed one month of service are eligible to participate in the Plan, unless their employment is governed by a union contract or they are nonresident aliens or leased employees. Long-term part-time (LTPT) employees with 500 or more hours of service for 3 consecutive years are eligible to participate in the Plan as well. Eligible employees may enter the Plan on the first day of the month coinciding with or following the date the requirements are met.

### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan. Additionally, participants may elect Roth 401(k) contributions of up to 100% of after-tax compensation. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to annual limitations prescribed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution equal to a discretionary percentage or dollar amount of elective deferrals. Each year, the Company will determine the discretionary matching contribution. During the year ended December 31, 2024, the Company matched 100% of participant elective deferrals, dollar for dollar, up to a maximum of 5%.

The Company may make a discretionary nonelective profit sharing contribution annually to the Plan. This contribution is allocated to a participant's accounts according to a formula based on compensation. There were no nonelective profit sharing contributions for the year ended December 31, 2024.

### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions are subject to a graded vesting schedule and are fully vested after five years of service. Participants become immediately vested in Company contributions upon death or disability.

### **Participant Accounts**

Each participant's account is credited with the participant's elective deferrals, rollover contributions, the Company's matching contributions, the Company's profit sharing contributions, and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined, by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses and administrative costs incurred in connection with the general administration of the Plan are paid out of Plan assets.

## 1. Description of Plan (Continued)

### **Forfeited Accounts**

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to pay Plan expenses or to reduce Employer contributions to the Plan. Forfeited amounts that were used to pay Plan expenses totaled approximately \$300 for the year ended December 31, 2024. Forfeited amounts that were used to reduce Employer contributions to the Plan totaled approximately \$174,000 for the year ended December 31, 2024. As of December 31, 2024 and 2023, there was approximately \$129,000 and \$192,000, respectively, of forfeited nonvested account totals in the Plan.

### **Notes Receivable From Participants**

Participants are permitted to borrow up to 50% of their vested account balance, with a minimum of \$1,000 up to a maximum loan amount of \$50,000 or 50% of their vested account balance. Participants are allowed to have one outstanding loan for the purchase of a primary residence and one loan for other purposes at any time. Notes receivable from participants have a term of five years or less, except for the purchase of a principal residence as permitted by IRS regulations and in accordance with the Plan provisions. The loans are secured by the balance in the participant's account and bear interest at a fixed rate determined by the Plan Administrator based on the terms described within the plan document. As of December 31, 2024, the notes bear interest at 4.25% to 10.50% and mature at various dates through 2051. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

Distributions to terminated, disabled, or retired participants are made in the form of a single lump sum, installment payments, or partial withdrawals to the participant (or in the case of death, to the participant's beneficiary) equal to the value of the participant's vested account. Distributions may also be made in the form of hardship withdrawals that may be subject to early withdrawal penalties. In-service distributions are allowed under the Plan upon attainment of age 59½. Certain mandatory distribution provisions may apply for smaller account balances of terminated employees. The distribution will be in the form of a lump sum payment if the participant's vested benefit is \$5,000 or less, unless the participant elects a direct rollover or distribution of their vested account balance.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

### **Accounting Estimates**

The preparation of the Plan's financial statements in conformity with US GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and the changes therein, and when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### 2. Summary of Significant Accounting Policies (Continued)

#### Investment Valuation and Income Recognition

The Plan's investments are measured at fair value on a recurring basis. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented in the net appreciation or depreciation in fair value of investments.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Administrative Expenses

Plan administration expenses that have not been paid by the Company are paid first from the forfeitures account and secondly by the participants of the Plan on a pro-rata basis, based on account balances or the number of participants.

Other fees charged for participant loan activity and for transactions in the self-directed accounts are paid by the participant or charged directly to the participant's account. These fees are included in the net appreciation or depreciation in fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued.

### 3. Certification of Investment Information

At December 31, 2024, the Plan's investments were held by Empower (the "Custodian"). The Plan's investments were transferred to Empower from the Minnesota Life Insurance Company (the "Prior Custodian") on January 17, 2024, as the Plan had elected to change providers. At December 31, 2023, the Plan's investments were held by the Prior Custodian. The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian and Prior Custodian have certified that the following data included in the accompanying statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the direction of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 4. Fair Value Measurements

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Pooled separate accounts are measured at fair value using the net asset value practical expedient as determined by the Prior Custodian based on the fair value of the underlying investments of each pooled separate account, which is generally obtained by using quoted prices for similar assets in active markets, and include dividends and capital gains declared. The valuation of underlying investments of each pooled separate account depends on the type of investments held by the pooled separate account and may be based on inputs other than quoted market.

### **5. Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds and common/collective trust fund managed by the custodian and trustee of the Plan or by affiliates of the custodian and trustee. Therefore, these are party-in-interest transactions. Fees paid by the Plan for investment management services amounted to approximately \$2,000 for the year ended December 31, 2024.

### **6. Risks and Uncertainties**

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions, and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

### **7. SECURE 2.0**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2020 CARES Act. Provisions will continue to become effective beyond 2024, and since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect. As of December 31, 2024, the Plan Administrator has elected to adopt provisions that allow long-term part-time (LTPT) employees with 500 or more hours of service performed for 3 consecutive years to participate in the Plan as well as expand the qualifying hardship reasons accepted by the Plan to include federally declared disasters.

### **8. Tax Status**

The Plan adopted a non-standardized pre-approved plan. The Plan received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022 stating that it is in compliance with IRS requirements. The Plan was amended since the receipt of the opinion letter. However, the Plan's Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Plan Termination**

Although the Plan has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.
