Independent Auditors' Report

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of STG Family of Companies, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS

### STG FAMILY OF COMPANIES, LLC 401(k) PROFIT SHARING PLAN

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of STG Family of Companies, LLC 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined-contribution plan covering all employees of the subsidiaries of STG Family of Companies, including STG Communication Services, LLC; STG Electric Services, LLC; STG Construction, LLC; and Advanced Underground Solutions, LLC. Employees who are 18 years old and have completed 3 months of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Amendment** - Effective October 1, 2024, the Plan was restated and amended. The Plan provisions are as of December 31, 2024.

**Contributions** - Under the Plan's provisions, each participant may contribute an amount equal to a dollar amount or percentage of annual pre-tax compensation not to exceed 100% of compensation as defined in the Plan. Participants may also roll over amounts representing distributions from other qualified defined-benefit or contribution plans. The Company may elect to make employer-matching, nonelective or safe harbor contributions. Upon enrollment in the Plan, a participant may direct employee and employer contributions to any of the available investment options. Participants may change their investment options at their discretion. All of the balances of the Plan represent participant-directed investments.

The Company elected to make matching contributions of 50% of the employee deferral up to 6% of eligible wages for the years ended December 31, 2024 and 2023.

**Participant accounts** - Each participant's account is credited with the participant's contribution, as well as allocations of the Company's employer-matching, nonelective or safe harbor contributions and Plan earnings (losses), as defined. Participant accounts are charged with specific participant transaction fees. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

**Vesting** - Vesting in participants' accounts relating to the employer-matching contributions are based on years of continuous service. A participant is vested in employer-matching contributions based on the following graded schedule: 20% after two years; 40% after three years; 60% after four years; 80% after five years; and 100% after six years of credited service. Participants are immediately vested in their deferrals and contributions rolled over from other qualified defined-benefit or contribution plans, plus actual earnings thereon. Each 12-month period for which the employee has at least 1,000 hours of service is treated as a year of service for vesting purposes.

**Notes receivable from participants** - Participants may borrow from their account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. In addition, each participant is limited to one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at fixed rates which are determined by adding 1% to the prime interest rate on the first day of the month that the loan is issued. The participant has the option to repay principal and interest ratably through payroll deductions based on payroll frequency or quarterly payments.

#### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

**Payment of benefits** - Upon termination of service, a participant will be entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

**Forfeited accounts** - For the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,117 and \$64, respectively. Company contributions which are forfeited may be allocated to participants, used to pay administrative expenses, restore amounts previously forfeited by former participants who have resumed participation in the Plan or reduce Company contributions. During the years ended December 31, 2024 and 2023, Company contributions were reduced by \$0 and \$815, respectively. In addition, during the years ended December 31, 2024 and 2023, Plan expenses of \$0 and \$2,427 were paid from the forfeiture account, respectively.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting** - The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Estimates and subsequent events** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates. In preparing the financial statements, including estimates and disclosures, the Plan Administrator has considered the effects of subsequent events through October 14, 2025—the date the financial statements were available to be issued.

**Allowance for credit losses** - The Plan is exposed to credit losses primarily through employer contributions receivable. However, the Plan has not experienced credit loss since inception and, accordingly, has not estimated an allowance for credit losses.

**Investment valuation and income recognition** - The Plan's investments are stated at fair value as of December 31, 2024 and 2023. The shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants and the measurement date. See NOTE D for a discussion of fair value. Common collective trusts are valued at the net asset value as a practical expedient of the units held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's realized gains and losses on investments sold, and unrealized losses on investments held during the year. Dividends are recorded on the ex-dividend date and are included in net appreciation in fair value of investments.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent participant loans are reclassified as distributions based upon the terms set forth in the Plan document.

#### **NOTE C - CONTRIBUTIONS RECEIVABLE**

Contributions receivable totaled \$8,504 and \$0 at December 31, 2024 and 2023, respectively, which represents true-up contributions as a result of ADP/ACP testing performed by the third-party administrator. The true-up represents additional employer-matching contributions owed to the Plan to ensure that all eligible participants receive matching contributions in accordance with the Plan's provisions.

#### **NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 inputs consist of significant observable inputs other than quoted prices for identical assets.
- Level 3 inputs consist of significant unobservable inputs that are not corroborated by market data and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were used.

##### ***Level 1 Fair Value Measurements***

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

##### ***Investments Measured at Net Asset Value (NAV) as a Practical Expedient Common/Collective trust - Reliance Trust Stable Value MetLife Series 25053 Fund***

During the year ended December 31, 2024, the Plan transferred its investments from Matrix Trust Company to Fidelity Management Trust Company, at which time the balance in the Reliance Trust Stable Value MetLife Series 25053 Fund was transferred to other investments at Fidelity Management Trust Company.

This investment was valued at the net asset value of the units held by the Plan at year end. The NAV was used as a practical expedient to estimate fair value. There were no unfunded commitments at December 31, 2024 and 2023.

The Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company is the custodian; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

STG Family of Companies, LLC provides to the Plan certain accounting and administrative services for which no fees are charged. Other administrative expenses are paid directly by STG Family of Companies, LLC or are paid directly from Plan assets. Investment-related expenses are included in net appreciation in fair value of investments on the accompanying statements of changes in net assets available for benefits. Participants' distribution and loan fees are paid by the respective participant.

#### **NOTE G - TAX STATUS**

The Plan has not applied for a determination letter; however, the Non-Standardized Plan Document has received an acceptable opinion letter dated June 30, 2020, from the Internal Revenue Service. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
