## Independent Auditors' Report

As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the December 31, 2023, financial statements to the liquidation basis of accounting used in presenting the December 31, 2024 financial statements. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ### **1. Description of Plan**

The following description of the Employee Benefit Plan of Eger Lutheran Homes and Services, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

Effective September 23, 2024, the Board of Directors approved a resolution to terminate the Plan. Effective December 31, 2024, all contributions to the Plan will be frozen. The assets are in process of being distributed or transferred to ArchCare Unified Retirement Plan.

#### ***General***

The Plan was a defined contribution plan covering all eligible employees of Eger Health Care and Rehabilitation Center, Eger Lutheran Homes and Services, Inc., and Eger Harbor House, Inc. (the "Plan Sponsor" or "Employer"). It was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Employees become eligible for the Plan upon completing one (1) year of service, provided the employee has worked at least 1,000 hours for any year, has attained 21 years of age and is not covered under a collective bargaining agreement, a leased employee, non resident alien or an employee of the Employer making contributions to another pension plan. The Plan administrator was responsible for oversight of the Plan, determining appropriateness of investment offerings and monitoring investment performance.

#### ***Assets Held for Investment***

All Plan assets were held with Lincoln Financial Group Trust Company, Inc. ("Lincoln" or the "Trustee"). Among other duties, Lincoln was responsible for the custody of the Plan's assets and for the payment of benefits to eligible participants. Plan contributions are invested in certain funds offered by Lincoln as designated by the Plan participants.

#### ***Contributions***

Eligible employees participating in the Plan may annually contribute through payroll deductions, limits as determined by the Internal Revenue Service ("IRS"), may contribute amounts representing distributions from other qualified plans, and can make contributions after tax. Eligible employees are automatically enrolled with a 1% of pre-tax salary deferral. Employees must opt-out of the automatic enrollment if they do not wish to participate, or they may change their election percentage. Any participant, age 50 or over, may make an additional "catch-up" contribution limit as determined by the IRS. Participants direct the investment of their contributions into various investment options offered by the Plan. A participant may suspend contributions and increase or decrease their participation at any time. Participants were permitted to make Roth or after-tax contributions.

The Employer makes base contributions. Eligible base contributions consist of a monthly allocation equal to 3% of that participant's eligible compensation for that month, whether or not he or she is an employee on the last day of the calendar month. Such Employer base contribution shall be made whether or not the participant is making employee contributions.

#### **Contributions *(continued)***

Notwithstanding the Employer base contribution described above, any employee who was a participant in the Eger Retirement Income Plan on or before September 1, 1997 shall receive an employer base increase contribution, which shall be effective on the pay period following his or her attainment of the age referenced in the following schedule:

<u>Attained Year of Age</u>	<u>Employer Increase Contribution Percentage</u>
Less than 50	3%
At age 50-54	5%
At age 55-59	6%
At age 60 or older	8%

For purposes of determining the employer base increase contribution payable for each complete pay period as provided herein, age is defined as completed year of age as of the last day of the payroll period for which an Employer contribution is made.

The Employer may make Employer discretionary contributions during the Plan year. Employees are eligible for Employer base contributions and employer discretionary contributions upon achieving one year of service and attainment of 21 years of age.

For the year ended December 31, 2024, the Employer made base contributions of \$142,301 and no discretionary contributions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### 1. Description of Plan (*continued*)

#### ***Vesting***

A participant is fully vested in the portion of his/her account attributable to participant contributions plus actual earnings thereon. All Employer contributions and matching contributions made to a Participant's account shall be 100% vested if the Participant's original employment commencement date is prior to January 1, 2018 and all "Transferred Employer Contributions" are 100% vested. The Employer contributions are 100% vested after the completion of six years of continuous service based upon the following schedule:

#### ***Payment of Benefits***

Prior to age 59 ½, distributions and withdrawals are not permitted from the Plan except in the instances of death, disability, hardships, or termination of employment. After attaining age 59 ½, participants may elect to withdraw an amount not to exceed 100% of the participants vested account balance for any reason. In the event of the termination of employment, a participant shall receive their participant contributions and earnings thereon in the form of a single-sum payment, partial payments, installment payments. For termination of service for other reasons, a participant will receive the value of his or her interest in his or her account as a lump-sum distribution.

#### ***Notes Receivable from Participants***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants, which are secured by the participants' vested account balances, bear interest from 4.25% to 9.50% during the year ended December 31, 2024, which is 1% plus the quarterly prime interest rate, and are paid ratably through monthly payroll withholding deductions. Notes receivable from participants have various repayment terms limited to 60 months except in limited circumstances such as for the purchase of a primary residence.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions into one or a combination of the investment options offered by the Plan. Participants may transfer money from one investment alternative to another or change the allocation of future contributions.

#### ***Forfeitures***

When a participant terminates, the nonvested portion of their account, as defined by the Plan document, is forfeited. Forfeited non-vested accounts are used to reduce future Plan Sponsor contributions and pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24,069 and \$12,083. During 2024, no forfeitures were used to reduce Employer contributions or pay Plan expenses.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The Employer approved to terminate the Plan effective September 23, 2024. As a result, the Plan has changed its basis of accounting for periods starting January 1, 2024, from the accrual basis to the liquidation basis.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") required management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value based on quoted market prices except for the fixed income annuity accounts, which are stated at contract value. The mutual funds are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded.

The fixed annuity contract was valued at contract value, which represented contributions plus credited interest less participant withdrawals and fees. Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

### **2. Summary of Significant Accounting Policies (*continued*)**

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis and related fees are recorded as administrative expenses and expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expense Charges***

Certain administrative fees are charged against participant accounts by the Plan Trustee on a monthly basis for services provided. The expenses necessary to administer the Plan include, but are not limited to, retaining necessary professional assistance from an attorney, an accountant, or an investment advisor, and are paid by the Employer. All expenses, except for account maintenance fees, transaction fees and investment fund management fees, have been paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Employees are charged service fees for any loan and distribution transactions they request. In addition, certain investment related expenses have been reflected as an offset of net investment income and are not readily determinable.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., a qualified institution.

### 4. Investments

The Lincoln Stable Value Fund is recorded at contract value on the statements of net assets available for benefits, which amounted to \$2,007,245 and \$2,330,174 at December 31, 2024 and 2023.

### 5. Fixed Annuity Contract with Insurance Company

The Plan invests in a fully benefit-responsive fixed annuity contract with Lincoln Life & Annuity Company of New York ("LLACNY"). LLACNY maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value. The fully benefit-responsive contract is reported to the Plan by LLACNY at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate is based on a formula agreed upon with the issuer, which cannot be less than 0%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) the Plan is no longer qualified under the IRC, (2) an uncured violation of the Plan's investment guidelines, (3) a breach of material obligation under the contract, (4) a material misrepresentation and (5) a material amendment to the agreement without the consent of the issuer.

### 5. Fixed Annuity Contract with Insurance Company (*continued*)

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The Plan has the right to terminate participation in the contract after twelve months and then withdraw the full balance without penalty within twenty-four months depending on contract liquidity and the interest rate environment.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (A+ as of July 2024), Moody's Investors (A2 as of September 2024), A.M. Best (A as of February 2025) and Fitch Ratings (A+ as of July 2024).

The Lincoln Stable Value Fund represents approximately 20% and 18% of the net assets available for benefits as of December 31, 2024 and 2023.

### 6. Party-in-Interest

The fixed income annuity investment is managed by LLACNY. LLACNY is related to the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for administrative expenses amounted to \$64,849 for the year ended December 31, 2024.

Participants who are active employees may borrow from their accounts and such loans qualify as party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Plan Sponsor, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

### 7. Income Tax Status

The Internal Revenue Service has determined and informed the plan document preparer by a letter dated June 30, 2020, that the Plan and its amendments are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

### 8. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
