INDEPENDENT AUDITORS' REPORT

NOTE 1 - DESCRIPTION OF PLAN

Crown Laboratories, Inc. (the “Company”) established the Crown Laboratories, Inc. 401(k) Profit Sharing Plan (the “Plan”) on July 1, 2002. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have reached the age of 21 with no minimum service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the plan document, and in accordance with applicable sections of the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a fixed account and several pooled separate accounts as investment options for participants.

Participants who have completed one year of service will receive a safe harbor matching contribution equal to 100% of the participant’s elective deferral up to 4% of the participant’s eligible compensation. The Company may, at its discretion, make employer discretionary contributions. The Company did not make any discretionary contributions during fiscal years 2024 and 2023. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of the Company’s contribution and Plan earnings and charged with an allocation of administrative expenses (if paid by the Plan’s Trust). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their own contributions and safe harbor matching employer contributions plus actual earnings thereon. Vesting in the Company’s discretionary contributions is based on years of service, according to a five-year graded vesting schedule (20% per year, starting with one year of vesting service).

Forfeitures

Forfeitures may be used to reduce the Company's contributions or to pay administrative expenses of the Plan. Unallocated forfeitures were \$1,720 and \$8,672 as of December 31, 2024 and 2023. During 2024 and 2023, \$9,380 and \$13,119 in forfeitures were used to pay administrative expenses and employer matching contributions of the plan, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, with a \$1,000 minimum. Loan terms are a maximum of five years; however, terms for loans used for the purchase of a home may be extended, subject to certain limitations. The loans are secured by the balance in the participant's account. Delinquent loans are reclassified as distributions in accordance with the Plan document.

Payment of Benefits

On termination of service, due to termination, death, disability, or retirement, a participant may elect to receive a lump-sum amount, or a rollover amount equal to the value of the participant's vested interest in his or her account. Participants who have met certain age requirements may receive benefits while still employed. Additionally, hardship distributions are permitted if the participant meets certain hardship criteria.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to a benefit-responsive investment contract because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Benefits Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are absorbed by the Company to the extent they are not paid by the Plan.

NOTE 3 - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets.

Level 2

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of units held by the Plan at year-end. The NAV is based on the value of the underlying assets owned by the fund, minus liabilities, and then divided by the number of shares outstanding. Fair value is considered readily determinable, and therefore, has been included in the fair value hierarchy below.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan offers a guaranteed interest account as an investment option. This account is a traditional fully benefit-responsive investment contract provided through a group annuity contract between the Plan and Empower Annuity Insurance Company of America (Empower).

Because the guaranteed account with Empower is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributed to the guaranteed account. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus credited interest, less participant withdrawals, and administrative fees. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

Under this group annuity contract with Empower, a crediting rate is established for a specified period of time and contributions invested in the guaranteed account are credited with that rate. Empower typically reestablishes the guaranteed rate semiannually.

NOTE 4 - INVESTMENT CONTRACTS WITH INSURANCE COMPANIES (CONTINUED)

Certain events may limit the ability for the Plan to transact at contract value with the contract issuers, such as premature termination of the contracts and Plan termination or merger. In addition, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value, such as an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contracts, a material misrepresentation, and a material amendment to the agreements without the consent of the issuers.

NOTE 5 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by Empower, the certifying entity of the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan to parties-in-interest for plan services amounted to \$24,736 and \$21,450 for the year ended December 31, 2024 and 2023, respectively.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 8 - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, complied with the applicable requirements of the Internal Revenue Code.

NOTE 8 - TAX STATUS (CONTINUED)

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - CERTIFICATION

The following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule that were prepared or derived from information prepared by Empower, the certifying entity of the Plan, and furnished to the plan administrator. The plan administrator has obtained a certification from Empower that such information is complete and accurate.

Statements of Net Assets Available for Benefits – all items and amounts, except for receivables and liabilities.

Statements of Changes in Net Assets Available for Benefits – all items and amounts, except for contributions, other income, benefits paid to participants, transfers from other plans, and administrative expenses.

Supplemental Schedule – all items and amounts.

NOTE 10 - EXCESS CONTRIBUTIONS REFUNDABLE

Contributions received from participants are net of any excess contributions. Pursuant to the nondiscrimination provisions of the Internal Revenue Code, excess contributions for the years ended December 31, 2024 and 2023 were \$17,535 and \$7,883, respectively, and are recorded for amounts refundable by the Plan to highly compensated employees.

NOTE 11 - PLAN MERGER AND TRANSFER OF ASSETS

On September 18, 2024, the Plan received assets totaling \$8,153,459 from a merged plan, Strivectin Operating Company Inc. 401(k) Profit Sharing Plan. These transferred assets were reconciled and allocated to participant accounts. These assets represented participant balances from the merging plan that were temporarily held until participant-level information could be verified.

The allocation of the transferred assets to participant accounts was completed on October 2, 2024. This temporary unallocated balance did not affect the total net assets available for benefits as of December 31, 2024, and individual participant account balances were updated upon allocation.

NOTE 12 - SETTING EVERY COMMUNITY UP FOR RETIREMENT ACT (SECURE 2.0)

In December 2022 SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective in the year following December 31, 2024 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

NOTE 13 - SUBSEQUENT EVENTS

The Company evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.
