### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **403(b) Thrift Plan for Employees of Southwest Oklahoma Community Action Group, Inc.** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements December 31, 2024 and 2023

### **NOTE 1: DESCRIPTION OF PLAN**

The following description of the 403(b) Thrift Plan for Employees of Southwest Oklahoma Community Action Group, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that operates as a Section 403(b) retirement plan for the benefit of eligible employees of Southwest Oklahoma Community Action Group, Inc. (the Employer). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

All non-excluded employees are eligible to make elective deferrals to the Plan beginning on their date of hire. All non-excluded employees are eligible to participate in Employer contributions once they have completed one year of service in which at least 1,000 hours of service are earned.

#### **Contributions**

Each year, participants may contribute a portion of their pre-tax compensation, subject to certain limitations as defined in the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Employer's matching contribution is equal to 100% of the participant's contribution, up to a maximum of 10% of participant's compensation, as defined.

#### **Investment Options**

Upon enrollment in the Plan, participants may direct their contributions among the various investment options offered by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's salary deferral contributions, his or her allocation of the Employer's contributions, and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. The Employer's matching contributions vest at 20% per year after one year of service and are fully vested after five years of service. Participants are automatically 100% vested at upon reaching normal retirement age, upon death, and upon disability.

### **Forfeitures**

Forfeitures are used to reduce Employer matching contributions. No forfeitures were used to reduce Employer contributions during the year ended December 31, 2024. Unallocated forfeitures amount to \$2,865 and \$1,557 as of December 31, 2024 and 2023, respectively.

### **Payment of Benefits**

Upon termination of service, a participant may elect to receive the value of the vested interest in his or her account either in a lump-sum payment, in an annuity, or, under certain circumstances, in installment payments. The Plan also allows for in-service withdrawals for participants meeting certain age, service, or hardship requirements.

See Note 10 for specific disclosures related to the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

## ***NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### **Payment of Benefits**

Benefit payments are recorded when paid. There were no amounts allocated to withdrawing participants' accounts for distributions payable on or before December 31, 2024 and 2023 but not yet paid as of those dates.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain activity based fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### **Expense Offset Arrangements**

Fees incurred by the Plan for the investment management services or recordkeeping are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the insurance company. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Loans to Participants

Plan loans are made by Mutual of America to the participant from the general assets of Mutual of America, not Plan assets. The amount borrowed plus a loan reserve (20% of the loan amount) is secured against the guaranteed interest account. Participants may borrow a minimum of \$1,000. The maximum amount that may be used to secure a loan is the lesser of (i) 50% of the participant's vested account balance and (ii) \$50,000 minus any plan loan amount repaid during the prior year. Because the loan must be secured by 120% of the amount borrowed, in accordance with Department of Labor (DOL) regulations, the maximum loan amount cannot exceed forty one and two thirds percent (41⅔%) of the participant's total account balance minus any current outstanding loans, not to exceed \$50,000. A participant's Roth account balance cannot be used to secure a loan. The maximum loan term is five years unless the loan is used to acquire the principal residence for the participant. If a loan is not fully repaid when it becomes due, the loan will be considered to be in default. If at the time of the default, the participant is not eligible for a distribution from the Plan, a deemed distribution will occur which is a taxable event to the participant. Interest and penalties will continue to accrue until the participant is eligible for a distribution (such as when the participant terminates service, attains age 59½, etc.). At which time the amount of the defaulted loan plus interest and penalties will be deducted from the participant's account. The loans are subject to a commercially reasonable rate of interest. At December 31, 2024 and 2023, interest rates on outstanding loans ranged from 3.25% to 5.85%.

The amount borrowed plus a loan reserve (20% of the loan amount) must be reserved in the participant's Mutual of America interest accumulation account. As loan repayments are made, amounts securing the loan are reduced. The participant may then request a transfer of these amounts from his or her Mutual of America interest accumulation account to any of the other investment options offered by the Plan. As of December 31, 2024 and 2023, approximately \$143,000 and \$102,000, respectively, of participant account balances were pledged as collateral against outstanding loans totaling \$119,362 and \$85,133, respectively.

### **NOTE 3: INFORMATION CERTIFIED BY THE PLAN'S INSURANCE COMPANY**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023,
- Net appreciation in fair value of investments and interest income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and
- The Schedule of Assets Held at End of Year as of December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Codification Topic *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB Codification Topic *Fair Value Measurements and Disclosures* are described as:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Variable annuities in pooled separate accounts:* Valued at the net asset value (NAV) of the units of the pooled separate account. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily.

*Interest accumulation account:* Valued at contract value (contributions and interest less expenses and withdrawals), which approximates fair value, as provided by Mutual of America.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. In accordance with the FASB Codification Topic, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

Each portfolio included in the variable annuities in pooled separate accounts has different investment objectives and risks. The portfolio prospectuses contain more detailed information on each portfolio's investment strategy. Generally, there are portfolios that seek a high level of income, long-term capital appreciation, and combinations of each. A large portion of the portfolios seek to achieve current income and capital appreciation appropriate for the asset allocation associated with the approximate target year of retirement.

#### **NOTE 5: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their accounts.

### **NOTE 6: RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by Mutual of America. Mutual of America is the insurance company of the Plan. As a result, these investments and the related investment transactions qualify as party-in-interest transactions. Certain Mutual of America fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. To the extent that revenue sharing is insufficient to cover these fees, they will be deducted pro rata from the participant's account.

The Plan incurs expenses related to general administration and record keeping. The Employer pays a portion of these and other Plan expenses. The Employer also performs certain administrative functions at no cost to the Plan. The Employer does not expect reimbursement for these expenses.

The Plan is charged fees and expenses through expense ratios charged by Mutual of America to the Plan's various pooled separate accounts. The investment expense ratios vary by fund and are reflected in the value of the investments held by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

### **NOTE 7: TAX STATUS AND UNCERTAIN TAX POSITIONS**

The Plan has adopted a prototype plan document offered through Mutual of America. Mutual of America obtained an opinion letter on the above referenced prototype plan from the Internal Revenue Service dated March 31, 2017 which indicated that the prototype plan is accepted under section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

The Plan accounts for uncertain tax positions in accordance with the provisions of the FASB Codification Topic *Income Taxes*. FASB Codification Topic *Income Taxes* clarifies the accounting for uncertainty in income taxes and requires the Plan to recognize in their financial statements the impact of a tax position taken or expected to be taken in a tax return, if that position is more likely than not to be sustained under audit, based on the technical merits of the position. The Plan administrator has assessed the tax positions taken by the Plan, and determined that no positions exist that require adjustment or disclosure under the provisions of FASB Codification Topic *Income Taxes*.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### **NOTE 8: RISKS AND UNCERTAINTIES**

The Plan provides for investments in various income securities, which in general are exposed to certain risks, such as interest rate, credit, and overall market volatility risks. Certain investment options may invest in foreign securities. There are certain additional risks involved when investing in funds with underlying foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Plan's financial statements.

## ***NOTE 10: CARES ACT DISTRIBUTIONS AND PARTICIPANT LOANS***

In response to the financial hardship faced by many individuals as a result of the COVID-19 pandemic, Congress enacted the CARES Act that allowed for certain temporary changes to 403(b) Plan distributions and loans to participants. Qualified individuals could take up to \$100,000 from their retirement accounts. These distributions were not subject to the usual 20% withholdings for federal taxes, age requirements, or notice rules. The tax burden for these distributions can be spread over three years, and the distributions can be repaid over three years. Qualified individuals could take larger loans from their retirement accounts. The maximum loan limit was increased to \$100,000. Loan repayments could be delayed for up to one year. Also, participants do not have to take required minimum distributions for 2020. Plan amendments for adoption of provisions of the CARES Act are required to be made by December 31, 2025. The Plan has not yet been amended; however, it is Plan management's intent to amend the Plan prior to the due date.

## ***NOTE 11: SUBSEQUENT EVENTS***

Plan management has evaluated subsequent events through October 15, 2025, the date that the financial statements were available to be issued.
