## INDEPENDENT AUDITORS' REPORT

### Opinion

We have audited the accompanying financial statements of the Associated General Contractors Health Benefit Trust – Alaska Washington Chapters (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules of assets held for investment and administrative expenses are presented for purposes of additional analysis. The supplemental schedule of assets held for investment is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule of assets held for investment, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole. The form and content of the supplemental schedule of assets held for investment is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

### Note 1 – Description of the Plan

The following description of the Associated General Contractors Health Benefit Trust – Alaska Washington Chapters (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

- a. **General** – The Plan became effective June 1, 1954, and is maintained pursuant to an agreement between the AGC of Washington, Inc., and the AGC of Alaska chapters of The Associated General Contractors of America, Inc., for the benefit of the employees of their members. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
- b. **Benefits** – The Plan provides medical, dental, vision, life, prescription drug, and accidental death and dismemberment benefits through group insurance policies for eligible members as specified in the Plan. Each contributing employer elects the eligibility provisions for their employees from pre-defined options at annual contract renewal.
- c. **Contributions** – The Plan requires participating employers to remit contributions, which may include a combination of employer and employee monies, to provide medical, dental, vision, life, prescription drug, and accidental death and dismemberment insurance benefits for participants. Participants also contribute to the Plan under the provisions of the Consolidated Omnibus Budget Reconciliation Act (COBRA).

### Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.
- b. **Valuation of investments** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Board of Trustees determines the Plan’s valuation policies utilizing information provided by the investment advisers and custodians. See Note 7 for a discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- c. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

## Note 2 – Summary of Significant Accounting Policies (Continued)

- d. **Benefit obligations** – Participating employers may elect to contribute dollars in excess of those necessary to provide current insurance coverage. Such contributions are held in a dollar bank for the employee and are used to provide continuing coverage under the Plan when the employee’s hours counted for eligibility to receive coverage fall below the level required for coverage paid with current employer contributions. These future benefits can be accumulated for each employee for up to a maximum of 18 months of health insurance coverage.

If no additions to or withdrawals from an individual dollar bank are made within a six-month period, the balance of the dollar bank shall be forfeited to the Plan. There were no employers participating in the Washington or Alaska dollar bank for the years ended December 31, 2024 and 2023. The Plan does not provide postretirement benefits.

- e. **Premiums** – Premiums are recorded when paid.
- f. **Administrative expenses** – All expenses of maintaining the Plan are paid by the Plan.
- g. **Subsequent events** – Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

## Note 3 – Federal Tax Status

The Plan obtained an exemption letter dated March 31, 2016, in which the Internal Revenue Service (IRS) stated the Plan qualified under Section 501(c)(9) of the Internal Revenue Code (IRC) and, therefore, is not subject to tax under present income tax laws. The Plan’s administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. They believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date; therefore, no provision for income tax has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan’s tax-exempt status; however, there are currently no audits for any tax periods in progress.

## **Note 4 – Plan Termination**

Although it has not expressed any intention to do so, the Board of Trustees has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Board of Trustees or be used for purposes other than for the exclusive benefit of the Plan's participants.

## **Note 5 – Party-in-interest Transactions**

Certain transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

## **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term, and those changes could materially affect the amounts reported in the statements of net assets available for benefits and benefit obligations.

The Plan's cash balances are held at one financial institution. Accounts at this institution are insured by a government agency up to \$250,000. At times, the balances in these accounts may exceed the insured limit.

## **Note 7 – Fair Value Measurements**

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

## Note 7 – Fair Value Measurements (Continued)

The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Level 1* – The mutual fund is valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open-ended mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

*Level 2* – The Plan had no investments that are classified as Level 2 for either year ended December 31, 2024 or 2023.

*Level 3* – The Plan had no investments that are classified as Level 3 for either year ended December 31, 2024 or 2023.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 9 – Alaska Medical Travel Reimbursement**

Effective June 1, 2017, the Plan adopted a medical travel reimbursement program for the Alaska chapter. This program offers participating employees and dependents reimbursement for certain covered expenses if these expenses are incurred traveling from Alaska to the lower 48 continental states for inpatient medical care or outpatient surgeries. Covered expenses include certain transportation and lodging expenses beginning June 1, 2017.

To request reimbursement for covered expenses, participants must submit a claim form to the Trust Administration Office for review and approval. The Plan held medical travel reimbursements payable of \$257 for the years ended December 31, 2024 and 2023.
