### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Canon Medical Systems USA, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Canon Medical Systems USA, Inc. 401(k) Savings Plan (the “Plan”), established on March 17, 2016, is a defined contribution plan that covers substantially all employees of Canon Medical Systems USA, Inc. and its subsidiaries (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The assets of the Plan are held in a trust by T. Rowe Price Trust Company. The Plan document includes detailed rules for each situation. Participants and other interested parties should refer to the plan document and any amendments for specific plan provisions.

**A. Participation**

Company employees are eligible to participate in the Plan after having completed thirty days of service and attaining age 21.

**B. Benefits**

Benefits under the Plan begin when a participant retires, becomes disabled, dies or ceases to be an employee. Normal retirement age is 65. Financial hardship and age 59½ withdrawals are permitted.

**C. Vesting**

A participant is fully vested immediately as to voluntary contributions, rollover contributions, and related earnings. Company contributions are vested as follows:

**D. Contributions**

Each year, participants may elect to defer up to 75% of annual compensation, as defined in the Plan, subject to Internal Revenue Code limitations. The Company may provide matching contributions. In 2024, the Company matched 50% of participants' deferrals of up to 8% of compensation.

**E. Notes Receivable from Participants**

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of the vested account balance. The minimum loan is \$1,000. Only one loan may be outstanding at any one time. Interest on loans is charged at the prime rate plus one percent. Loans must be repaid within five years, except loans for the purchase of a principal residence in which case the repayment period may be extended. Notes Receivable at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with maturities through July 2043.

**F. Forfeitures**

Any portion of a participant's account that is not vested shall be forfeited upon distribution of the vested portion. Forfeitures are used to offset Company contributions; \$298,474 were used in 2024; \$5,303 and \$104 were available for future use as of December 31, 2024 and 2023, respectively.

**G. Administrative Expenses**

Most administrative expenses are paid by the Plan and from revenue sharing paid to the Plan. In 2024, expenses comprised the following:

**H. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, employer matching contributions and the participant's share of investment earnings or losses and expenses. Plan assets are invested based on participant directions. Participants may elect to establish a self-directed brokerage account, effective October 1, 2024, in which they may invest in any investment security approved by the Company.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Investments at Fair Value**

Participants select how their share of plan assets will be invested among those investment vehicles made available.

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable

Investments in common/collective trusts are measured at net asset value per share (NAV) as a practical expedient in accordance with ASC 820. Such investments are not required to be categorized within the fair value hierarchy. The investment objectives of these funds are apparent from their names. Shares may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares.

**D. Stable Return Fund**

The Galliard Stable Return Fund seeks safety of principal and consistency of returns while attempting to maintain minimal volatility. It comprises primarily of fixed income portfolios wrapped by stable value contracts. The fund pays a floating rate. As of December 31, 2024, the crediting rate was 3.18%. The stable return fund meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**E. Risks and Uncertainties**

The Plan invests in various investments, which are exposed to various risks and such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE 3 - INCOME TAX STATUS**

The IRS has determined and informed the Company by a letter dated November 17, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date, which will be treated as the valuation date.

**NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan.

**NOTE 6 - RELATED PARTY TRANSACTIONS**

Certain investments held by the Plan are managed by T. Rowe Price Trust Company, an affiliate of the trustee. Transactions related to these investments qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.

**NOTE 7 - AMENDMENTS**

Effective August 1, 2023, Canon Healthcare USA became a participating employer in the Plan.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
