## INDEPENDENT AUDITOR'S REPORT

To the Plan Committee of the  
Quinn Emanuel Urquhart & Sullivan, LLP 401(k) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Quinn Emanuel Urquhart & Sullivan, LLP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information and to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that were identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## 1. PLAN DESCRIPTION

The following description of the Quinn Emanuel Urquhart & Sullivan, LLP 401(k) Plan (the "Plan") provides only general information. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all partners and eligible employees (excluding associates, "of counsel" attorneys, and contract attorneys) who have been employed by Quinn Emanuel Urquhart & Sullivan, LLP (the "Firm" or "Employer" and the "Plan Sponsor") for six months and have attained 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**Contributions** - Each year, participants may make pre-tax and Roth contributions of up to 60 percent of eligible compensation, as defined in the Plan and subject to certain limitations under the Internal Revenue Code ("IRC"). Effective January 1, 2024, the Plan was amended to allow participants to make voluntary, after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for discretionary profit sharing contributions at the option of the Firm's partners. To be eligible for the profit sharing contribution, a participant must have been employed for at least three months and completed over 500 hours of service during the Plan year and, if the participant is a partner in the Firm, they must also be employed on the last day of the Plan year. The Firm may designate all or a portion of the profit sharing contribution for a Plan year as qualified non-elective contributions and allocate them to non-highly compensated employees to assist the Firm in passing one or more annually required IRC nondiscrimination tests. For the year ended December 31, 2024, the Firm's profit sharing contribution was \$15,389,267.

**Transfers To/From Another Employer Sponsored Plan** - The Firm also sponsors another defined contribution plan which allows participation by associates, "of counsel", and hourly (contract) attorneys of the Firm (the "Associates Plan"). If participants in the Associates Plan become partners of the Firm or participants of this Plan become associates of the Firm, their account balances are transferred into the corresponding plan.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, as well as allocations of the Firm's profit sharing contribution and Plan earnings, and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. The Firm's profit sharing contributions are credited to the participant's account according to the formula defined in the Plan document and allocated according to the participant's deferral elections. Other allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their contributions and the Firm's contributions plus actual earnings thereon.

**Forfeitures** - Forfeitures arise from the corrections of excess Firm contributions and may be used to reduce future Firm contributions, pay Plan administrative expenses, or be reallocated to participants and total \$39,708 and \$36,932 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were utilized.

**Payment of Benefits** - On termination of service for any reason, a participant or their beneficiaries, as applicable, may receive the value of the vested interest in their account as a lump-sum distribution. The Plan provides for a mandatory cash-out following severance of employment for account balances less than \$5,000.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** - Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments are valued daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Administrative Expenses** - Certain administrative expenses incidental to the administration of the Plan may be paid by the Plan, unless otherwise paid by the Firm. Administrative expenses paid by the Firm are excluded from these financial statements.

Most investment options have fees which reduce the overall return on assets. The net appreciation of investments is reflected net of these fees.

**Benefits Payable to Participants** - Benefits are recorded when paid.

**Subsequent Events** - The Firm has evaluated subsequent events through October 15, 2025, which is the date that the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements.

## 3. FAIR VALUE

The Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are the following:

- Level 1 – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 – Inputs to the valuation that are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – This category consists of publicly traded funds of registered investment companies. The net asset value of the mutual fund's shares is quoted on the exchange where the fund is traded and therefore classified as Level 1 within the valuation hierarchy.

*Interest-bearing Cash* – This category consist of certificates of deposits, money market funds, and cash accounts which are stated at par and, therefore, classified as Level 1 within the valuation hierarchy.

All of the Plan's investments are Level 1 and the following table sets forth the Plan's investments at fair value:

## 4. FINANCIAL DATA CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America, N.A., (the "Trustee"), and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Noninterest-bearing cash, investments, at fair value, and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- b. Net appreciation of investments, interest and dividend income on investments, and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c. Investments and participant loans as listed in the accompanying Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

## 5. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the prior 12 months or 50 percent of their vested account balance. Loans are generally issued with a maturity of up to five years, except when taken for the purpose of a principal residence purchase. The loan interest rate is set at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

## 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 7. PLAN TERMINATION

The Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

## 8. TAX STATUS

The Firm adopted a non-standardized pre-approved profit sharing plan which is the subject of a favorable opinion letter from the IRS dated June 30, 2020. The plan administrator believes the Plan is currently being operated in accordance with the applicable provisions of the IRC and, accordingly, the plan administrator believes that the Plan is exempt from income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Firm has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 10. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

According to the Fee Schedule Agreement between the Firm and the Trustee, the Trustee is required to make contributions to a Service Based Pricing Account ("SBPA"). The funds in the SBPA may be used to pay Plan administrative expenses or may be allocated to participants at the discretion of the Firm and total \$490,355 and \$448,986 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Trustee contributed \$33,171 to the SBPA, which is included in net appreciation of investments in the statement of changes in net assets available for benefits, and \$16,660 was utilized to pay Plan administrative expenses. No amount was allocated to participants during the year ended December 31, 2024.

Certain Plan investments are managed by an affiliate of the Trustee (the "Affiliate"). Transactions with the Trustee and the Affiliate qualify as party in interest transactions for which exemptions exist. The Affiliate received \$104,062 for administration fees which were paid by the participants through the Plan. The Plan's independent qualified public accountant received direct compensation of \$20,010 for the 2023 and 2022 Plan years' audit services, of which \$16,660 was paid through the SBPA and the remainder was paid by participants through the plan. In addition, the Affiliate received indirect compensation from investments.
