#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Intersection Parent Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering all eligible full-time employees of Intersection Parent Inc. (the "Company") who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Effective February 1, 2016, the Plan was amended and eligible employees are now able to participate in the Plan immediately after hire. Prior to February 1, 2016, an employee was eligible to participate in the Plan after completing six months of service. Effective January 1, 2017, the Plan was amended to allow for automatic enrollment of eligible participants. Effective January 1, 2019, the Plan was amended to allow eligible employees who are members of the International Union Painters and Allied Trades, Painters District Council 14/ Sign Painters Local 830 Union to participate in the Plan.

The 401(k) Committee is responsible for oversight of the Plan. The Plan's investment advisors determine the appropriateness of the Plan's investment offerings and monitors investment performance.

##### **Contributions**

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

The Company may contribute matching contributions at the option of the Company's Board of Directors. The Company contributed 25% of participant deferrals, not to exceed 8% of compensation. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors. During the year ended December 31, 2024, the Company made no profit sharing contributions to the Plan. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Effective February 1, 2016, the Plan was amended to allow for 100% vesting after three years of credited service, as defined. Prior to February 1, 2016, a participant became 100% vested after four years of credited service, as defined.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their total vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined. For the year ended December 31, 2024, the interest rate ranged from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions. Fees to administer the loans are paid by the participant. Participants may have a maximum of two loans outstanding at a time.

***Payment of Benefits***

On termination of service due to death, disability, retirement, or other reasons, a participant with a vested account balance of more than \$5,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or their investments will remain in the Plan. If a participant's vested balance is \$5,000 or less, a lump-sum distribution equal to the value of the vested interest in his or her account will be made automatically within a reasonable amount of time after termination of service. The Plan also allows for in service withdrawals due to hardship or upon attainment of age 59 ½. Required minimum distributions in accordance with the Internal Revenue Code also apply.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,944 and \$7, respectively. These accounts will be used to reduce future employer contributions to the Plan or pay Plan expenses. In 2024, \$39,244 of forfeitures were used to offset employer contributions.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. There are no subsequent events requiring recognition or disclosure in the financial statements.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Standards Accounting Board Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023:

*Mutual Funds and Money Market Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds:* Valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There is no redemption notice period or unfunded commitments. The funds file U.S. Department of Labor Form 5500 as a direct filing entity. Therefore, disclosure of the investment strategy is not required.

*Pooled Separate Account:* Valued using the NAV, which is based on the fair value of the underlying assets of the account. The NAV is used as a practical expedient to estimate fair value.

**NOTE 4 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by John Hancock Trust Company, LLC, the Custodian as defined by the Plan, or New York Life Insurance Company, and, therefore, these transactions qualify as party-in-interest transactions.

John Hancock Retirement Plan Services, LLC (“JHRPS”) provides certain administrative services to the Plan pursuant to an agreement between the Company and JHRPS. JHRPS receives revenue from relevant investment contract service providers for services JHRPS provides to the funds. This revenue is used to offset certain amounts owed to JHRPS for its administrative services to the Plan.

If the revenue received by JHRPS from such investment contract service providers exceeds the amount under the agreement, JHRPS remits the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan sponsor may make a payment to JHRPS for administrative expenses not covered by revenue sharing. Notes receivable from participants also qualify as party-in-interest transactions and are also exempt from the prohibited transaction rules.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 6 - TAX STATUS**

The Plan uses a volume submitter plan and received an opinion letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Code. The Plan has been amended since receiving the letter. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - CERTIFIED INVESTMENTS**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company, LLC and New York Life Insurance Company have certified that the following information in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 9 - NONEXEMPT TRANSACTIONS**

As reported on Schedule H, line 4a - supplemental schedule of delinquent participant contributions, certain Plan contributions were not remitted to the custodian within the time frame specified by the DOL's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company for the years ended December 31, 2024 and 2023 in the amount of \$120,483 and \$911, respectively. In November 2023, the Company self-corrected delinquent participant contributions of \$911 for the year ended December 31, 2023.
