## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
of Southeastern Printing Company, Inc. 401(k) Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Southeastern Printing Company, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**DECEMBER 31, 2024 AND 2023**

**1. DESCRIPTION OF PLAN**

The following description of the Southeastern Printing Company, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General -

The Plan was originally established with an effective date of January 1, 1997 by Southeastern Printing Company, Inc. (the “Company”). The Plan is a defined contribution 401(k) plan covering substantially all employees of the Company and another affiliated company who are at least twenty-one years of age and have completed two months of service. Eligible employees are permitted to make elective deferrals and are eligible for any Company discretionary matching contributions beginning the first day of the month following the month in which the eligibility requirements were met. Participants are eligible for any Company discretionary nonelective profit sharing contribution as long as they are employed on the last day of the Plan year and have completed at least 501 hours of service during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Administration -

The Company serves as Plan administrator (the “Administrator”) and is solely responsible for the general administration of the Plan and carrying out Plan provisions.

Newport Trust Company, LLC (“NTC”) serves as the custodian of the Plan’s assets.

As of December 31, 2023 and for the period January 1, 2024 to November 13, 2024, Newport Group, Inc. provided third-party recordkeeping services for the Plan. As of November 14, 2024, Ascensus, LLC provides third-party recordkeeping services for the Plan. Newport Group, Inc. is an affiliated entity of Ascensus, LLC.

HBK Source Advisory LLC, d/b/a HBKS Wealth Advisors provides investment advisory services to the Plan.

Contributions -

Participants may elect to contribute up to 100% of their eligible compensation to the Plan, subject to the maximum amount allowed under the Internal Revenue Code (the “Code”). Deferral limits under the Code were \$23,000 for the year ended December 31, 2024. In addition, participants age fifty and over at the end of the Plan year could elect to contribute a “catch-up” contribution of \$7,500 during the year ended December 31, 2024.

The Plan provides for the Company to make safe harbor matching contributions equal to a percentage of the participant's elective deferrals. In applying the safe harbor matching contributions, the Company contributes 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's eligible compensation, plus 50% of the amount of participant's elective deferrals that exceed 3% of the participant's eligible compensation but do not exceed 5% of the participant's eligible compensation. This results in a maximum safe harbor matching contribution of 4%. The Company's safe harbor matching contributions totaled \$331,087 during the year ended December 31, 2024.

The Plan also provides for discretionary nonelective profit sharing and discretionary matching contributions. The Company elected not to make discretionary nonelective profit sharing or discretionary matching contributions during the year ended December 31, 2024.

Participants are allowed to make rollover contributions from other qualified plans into the Plan in accordance with regulations under the Code. Further, participants are allowed to make Roth elective deferrals into the Plan.

The Plan provides for automatic participant enrollment after eligibility to participate in the Plan. The initial elective deferral rate is equal to 3% of the participant's eligible compensation and does not automatically escalate.

#### Participant accounts -

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary nonelective profit sharing, discretionary matching, and safe harbor matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, if not paid by the Company. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting -

Participants are immediately vested in their elective deferrals, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective profit sharing and discretionary matching contribution portions of their account plus earnings is based on years of continuous service as follows:

<u>Years of service</u>	<u>Percentage</u>
Less than one	0%
At least one but less than two	20%
At least two but less than three	40%
At least three but less than four	60%
At least four but less than five	80%
Five or more	100%

#### Investment options -

Participants direct the investment of their account into various investment options offered by the Plan. The Plan offers a number of investment options including mutual funds and a guaranteed investment contract (the "GIC") as selected by the Administrator.

#### Notes receivable from participants -

Participants may borrow a minimum of \$1,000, up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Note repayment terms range up to a maximum of five years, unless used for the purpose of purchasing a participant's principal residence, with interest at the prime rate plus 1% at the date of the loan and are collateralized by the individual participant's account. Principal and interest is paid ratably through payroll deductions.

#### Payment of benefits -

Amounts contributed through payroll deductions may be withdrawn by, or distributed to, a participant only upon termination of employment or attaining the age of 59 ½. Withdrawals prior to attaining the age of 59 ½ are not permitted, except in the event of retirement or as a hardship distribution. Upon proof, to the satisfaction of the Administrator, amounts contributed may be withdrawn for a hardship purpose. Upon termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the vested value of his or her account or periodic installments.

If upon termination of service, a participant does not attain normal retirement age and the participant's vested account balance is greater than \$5,000, the participant may elect to receive a lump-sum amount, a direct rollover to a qualified plan under the Code, a direct rollover to a qualified Individual Retirement Account equal to the value of his or her vested account balance, or may elect to keep their investments in the Plan. If the vested account balance is less than \$5,000, the balance will be distributed to the participant as soon as administratively feasible.

#### Forfeitures -

Participants whose employment with the Company has been terminated and who receive a distribution of the vested percentage of their account shall forfeit any amounts which are in excess of their vested interest as of the date of distribution. The non-vested portion will be restored to the participant's account in the event the employee returns to employment before five consecutive one-year breaks in service and pays back the distribution received from the Plan. After restoration of any of these benefits, the remaining forfeitures may be used to pay administrative expenses or reduce the Company's contributions.

During the year ended December 31, 2024, the Company utilized \$7,396 of forfeitures to reduce the Company's safe harbor matching contributions. The cumulative balance of forfeitures available to offset future administrative expenses and Company contributions totaled \$180 at December 31, 2024.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of accounting -

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

### Use of estimates -

The preparation of financial statements in conformity with GAAP requires the Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Significant estimates include, but are not limited to, the valuation of investments and notes receivable from participants. Actual results may differ from those estimates.

### Investment valuation and income recognition -

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrator determines the Plan’s valuation policies utilizing information provided by NTC. See Note 4 for a discussion of fair value measurements.

The GIC is stated at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The accompanying statement of changes in net assets available for benefits is prepared using the contract value basis for the fully benefit-responsive investment contracts. The contract value represents contributions plus earnings, less participant withdrawals and administrative expenses (see Note 5).

Contributions are recorded by the Plan when withheld from participants. Interest income is recorded by the Plan as earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Administrator deems the participant’s note receivable to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits -

Benefit payments to participants are recorded when paid.

Expenses -

Certain expenses of maintaining the Plan, including audit fees, are paid directly by the Company and are excluded from these financial statements. Administrative expenses include third-party recordkeeping and investment advisory fees. Participants are also charged administrative expenses for specific transactions within the Plan. Administrative expenses charged to the Plan totaled \$60,431 for the year ended December 31, 2024.

Investment related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

Subsequent events -

The Administrator has evaluated subsequent events through October 15, 2025, which is the date the accompanying financial statements were available to be issued.

### 3. FINANCIAL INFORMATION PREPARED AND CERTIFIED BY NTC

The Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investment information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared by, or derived from, information provided by NTC and furnished to the Administrator.

The Administrator has obtained certifications from NTC that the information below is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are as follows:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the net asset value ("NAV") of shares held by the Plan at year end. NAV is derived from the quoted prices in active markets of the underlying investments. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

The fair value of mutual fund investments measured on a recurring basis using Level 1 inputs is \$8,342,401 and \$8,039,505 at December 31, 2024 and 2023, respectively.

#### 5. GUARANTEED INVESTMENT CONTRACT

The Plan has entered into a GIC with MetLife, Inc. ("MetLife"). The GIC is a traditional fully benefit-responsive investment contract, managed by Reliance Trust Company, and is reported in the accompanying financial statements at contract value. MetLife maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC's value, as reported by NTC, is \$297,618 and \$404,588 at December 31, 2024 and 2023, respectively.

MetLife is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest rate provided to the Plan is guaranteed to be no less than 0% on an annual basis.

Participants may direct the withdrawal of all or a portion of their investment in the GIC at contract value. Participants may transfer all or a portion of their investment in the GIC on a daily basis, which may be subject to a market valuation adjustment which is determined at the time of transfer.

The Plan's ability to receive amounts due in accordance with the GIC is dependent on MetLife's ability to meet its financial obligations. MetLife's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Although they are not probable of occurring, certain events may limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to, the following:

- The Plan's failure to be operated in compliance with the applicable requirements of the Code (see Note 7).
- Premature termination of the contract by the Plan.
- Termination or merger of the Plan.
- Bankruptcy of the Company or other events that significantly affect the Plan's normal operations.

In addition, certain events allow MetLife to terminate the contract with the Plan and settle at an amount different from the contract value.

MetLife has the option to terminate the contract at any time following 90 days written notice and pay out the contract value to the Plan, or settle at an amount other than contract value by converting the contract assets to another contract upon the approval of certain fiduciaries of the Plan.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

NTC serves as custodian of the Plan's assets. All transactions between the Plan and NTC qualify as exempt party-in-interest transactions. Transactions involving notes receivable from participants also qualify as exempt party-in-interest transactions. The Plan also allows for transactions with certain parties who may perform services or have fiduciary responsibilities for the Plan, including the Company.

## **7. TAX STATUS**

The Company adopted a non-standardized pre-approved profit sharing/money purchase/cash or deferred arrangement plan sponsored by Newport Group, Inc. that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The opinion letter stated that the Plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements for the year ended December 31, 2024.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, the Company failed to remit certain employee contributions totaling \$11,668 to the Plan within the time frame required by the Department of Labor under the plan asset rules. These contributions were remitted to the Plan prior to December 31, 2024. Delays in remitting contributions to the custodian were due to administrative errors. The Company will make contributions, subsequent to December 31, 2024, to the affected participants' accounts to compensate them for potential lost income due to the delays.

## **9. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company discretionary nonelective profit sharing and discretionary matching contribution account balances as of the date of termination.

## **10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the accompanying statements of net assets available for benefits.
