Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Southwest Ohio ENT Specialists, Inc. 401(k) Retirement Plan and Trust (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rates, market and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances reported in the statement of net assets available for benefits.

Payments of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets during the reporting period. Actual results may differ from those estimates.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Related Party Transactions / Expenses

Certain administrative functions are performed by the officers or employees of Southwest Ohio ENT Specialists, Inc. (the "Plan Sponsor" and "Company"). These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees to the Plan. All fees and expenses of the Plan, to the extent not paid by the Company, are paid by the Plan. Certain investment related expenses are included in the net appreciation of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Subsequent Events

The Plan has evaluated events subsequent to the balance sheet date through October 6, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company. The Plan trustees oversee the governance of the Plan. Reliance Trust Company, Transamerica Trust Company and Transamerica Life Insurance Company Inc. are the custodians of the Plan assets and certain third-party administrative functions to the Plan are performed by Transamerica Retirement Solutions, LLC. Everhart Advisors serves as the investment advisor for the Plan and is considered a fiduciary as defined by ERISA section 3(21)(A(ii)). Employees become eligible to make elective deferral contributions and enter the Plan after meeting the minimum requirements of 18 years of age and one year of service in which the employee has worked 1,000 hours or more. Eligibility to receive employer contributions coincides with the participation eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Contributions

With respect to employee contributions, participants may contribute up to 100% of compensation, as defined by the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 for 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations (\$7,500 for 2024). The Plan Sponsor will withhold an automatic deferral percentage of 6% of eligible compensation each payroll period unless a participant makes an affirmative salary deferral election. Each year, all eligible participants have their deferral percentage automatically increase by 1%, up to 10%, unless a participant makes a different escalation election. Participants designate the percentage of their contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

The Company is required to make a qualified nonelective contribution of 3% of pretax compensation for all participants. The Company may, but is not required to, make discretionary matching contributions and discretionary profit sharing contributions to the Plan in an amount determined annually by the Board of Directors. Company qualified non-elective contributions were \$299,806 in 2024. Discretionary profit-sharing contributions were \$578,360 in 2024. The Company did not make any discretionary matching contributions in 2024.

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant's Account

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company qualified nonelective contributions plus earnings thereon. Participants' vested interests in all other Company contributions plus earnings thereon increase from 20% after the first year of service to 100% after the fifth year of service.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit in a lump sum, equal installments, or partial withdrawals.

In-service distributions are permissible for participants that have attained the age of 59½. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits.

In conditions of "financial hardship" a participant may apply to the Plan administrator for approval to withdraw that portion of their account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Unallocated Accounts

Forfeitures of the Plan are intended to pay plan expenses or reduce future employer contributions to the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,293 and \$14,747, respectively. During 2024, \$20,014 of forfeitures were used to reduce employer contributions. The expense budget account is intended to pay plan expenses. As of December 31, 2024 and 2023, this account totaled \$12,519 and \$11,248, respectively. During 2024, \$45,208 of the expense budget account was used to pay plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers between an investment fund and the loan fund. Loans must be repaid within five years except loans used for the purchase of a principal residence must be repaid within 30 years. Each loan is secured by the vested account balance in the participant's account and bears a rate of interest commensurate with the local prevailing rates as set by the plan administrator. Interest rates range from 4.25% to 9.50% at December 31, 2024. Principal and interest is paid ratably through biweekly automatic payroll deductions.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued using quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the United States Securities and Exchange Commission. These funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks within brokerage account: Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

Reliance Trust Company was the custodian of the Plan until June 30, 2024. On July 1, 2024, Transamerica no longer outsourced custodial functions to Reliance Trust Company. Transamerica Trust Company and Transamerica Life Insurance Company Inc. were the custodians of the Plan beginning on July 1, 2024. The following information provided by Reliance Trust Company, Transamerica Trust Company and Transamerica Life Insurance Company Inc., the custodians of the Plan, for the years ended December 31, 2024 and 2023 was certified by them to be complete and accurate with respect to the following:

- (a) The assets held at December 31, 2024 and 2023, as well as the transactions involving these assets for the year ended December 31, 2024.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) for the year ended December 31, 2024.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 6 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion from the Internal Revenue Service ("IRS") dated June 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. Both the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related Plan was tax exempt as of the financial statement date.

NOTE 7 FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a fully benefit-responsive guaranteed investment contract ("FBRIC") with Transamerica Life Insurance Company Inc. for the Stable Value Core Option Fund. Transamerica Life Insurance Company Inc. maintains the contributions in a general account. The account is credited with earnings on the underlying investments in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

Under certain circumstances Transamerica Life Insurance Company Inc. may terminate the contract, causing a loss of interest adjustment that would limit the Plan's ability to transact at contract value. Those events include: 1) the Plan is changed so as to significantly affect the obligations under the contract; 2) the contract holder, except by unintentional omission, fails to give the information needed under the contract or provide a copy of amendments to the Plan; 3) the contract holder fails to comply with the requirements of the contract; or 4) the Plan is terminated. The Plan administrator does not believe that the occurrence of any such event is probable.
