**(1) DESCRIPTION OF PLAN**

The following description of the A.T. Kearney, Inc. 401(k) and Profit Sharing Retirement Plan (“the Plan”) provides only general information. Participants should refer to the plan document as restated and amended for a more complete description of the Plan’s provisions. The Plan was established on January 1, 2005.

**(a) General**

The Plan is a defined contribution plan covering all eligible employees of A.T. Kearney, Inc. (“the Company”). An employee becomes eligible to participate in the Plan upon commencement of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The assets of the Plan are held and invested by T. Rowe Price Trust Company (“T. Rowe Price” or the “Plan Trustee”). T. Rowe Price acts as record-keeper for the Plan.

**(b) Contributions**

**Employer Contributions**

The Company’s Non-Elective contribution to the Plan is determined on an annual basis by the Board of Directors of the Company. For the year ended December 31, 2024, the Company Non-Elective contribution was \$18,210,936, net of forfeiture. The annual contribution may not exceed the maximum amount deductible by the Company for that year for federal income tax purposes. Participants may direct the investment of the Company’s contributions, as well as their employee contributions described below, to any of the investment options available under the Plan. No contribution is required to the Plan if the Company does not meet planned goals.

For each plan year, the Company will contribute for each participant a matching contribution equal to 25% of the participant’s eligible contributions as defined in the Plan (“Eligible Contribution”). A participant’s Eligible Contribution equals the amount of the participant’s elective deferrals for the Plan year, which do not exceed 6% of the participant’s compensation for the Plan year. The Plan allocates matching contributions to participants’ matching contribution accounts.

**Employee Contributions**

Employees may elect to participate in the 401(k), with the ability to make both pre-tax and after-tax contributions, and/or Roth feature(s) of the Plan. Eligible employees hired or rehired by the Company on or after January 1, 2016 are automatically enrolled at a 6% deferral rate 90 days after their date of hire or rehire and they may elect to change or discontinue deferrals at any time. Participants in the 401(k) may elect to defer from 1% to 75% of their annual compensation and combined 401(k) and after-tax contributions cannot exceed 40% of their annual compensation, subject to an overall annual limit of \$23,000 in 2024, as defined in the Plan, which would otherwise be paid to them by the Company. In addition, participants who have attained the age of 50 may contribute an additional \$7,500, by December 31, 2024. The amounts contributed under this election are not subject to federal income tax until they are distributed from the Plan. A participant may not make withdrawals from an elective account until reaching age 59½, except in the event of death, total and permanent disability, retirement, termination of employment, or proven hardship. A participant may elect to borrow funds from the participant’s vested account balance. Repayments of amounts borrowed from a vested account balance are deposited into such participant’s account.

In addition to the employee contributions referred to above, participants in the Plan may make a rollover contribution from another qualified plan as defined by the Internal Revenue Code ("IRC").

**(c) Participant Accounts**

Each participant's account is divided into the following sub-accounts, if applicable: an Employer Non-Elective Contribution Account, an After-Tax Contribution Account, a 401(k) Contribution Account, a Roth Contribution Account, a Rollover Account, an Employer Matching Account, a PPA Choice Allocation Account, and an Electronic Data Systems Corporation (EDS) Stock Dividend Account. Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, based upon a percentage of the participant's eligible compensation, and the Plan's earnings (losses) based on the investment funds selected, and is reduced by his or her withdrawals and an allocation of administrative expenses.

The participants' contributions are invested in accordance with the individual's investment elections. The benefit to which a participant is entitled is that which can be provided from the participant's vested account balance.

**(d) Vesting**

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's Non-Elective Contribution Account and the Employer Matching Account plus actual earnings thereon is based on years of continuous service. A participant will become 40% vested in his or her Non-Elective Contribution Account and Employer Matching Account after completing two years of service (as defined in the plan document as amended and restated) with the Company, and 20% for each year of service thereafter.

If a participant previously was a participant in the EDS 401(k) Plan and their account in that plan was transferred to the Plan, any "Choice Allocation" amounts that were included in the transfer will be held under this Plan in a PPA Choice Allocation Account and will vest 100% when the participant attains five or more years of service, based on date of hire. A participant is entitled to 100% of his or her account balance upon attaining age 55, death, disability or having at least 5 years of service.

**(e) Investment Options**

A trust fund has been established to hold the assets of the Plan. To provide for the investment of the Plan assets, the Plan Trustee maintains accounts in several investment alternatives. Upon enrollment in the Plan, a participant may direct employee contributions to any of the investment options available under the Plan selected by the Investment Committee. Participants may change their investment allocations on a daily basis.

**(f) Notes Receivable from Participants**

Participants may borrow from their accounts the lesser of 50% of the vested portion or \$50,000 reduced by the highest outstanding balance of all of the participant's loans from the Plan during the period beginning twelve months plus one day prior to the day the amount is to be borrowed and ending on the day such amount is to be borrowed. Loan transactions are treated as a transfer on a pro rata basis to (from) the participant's investment sub-account from (to) an individual loan sub-account. Loan terms range from one to five years, or up to 20 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate as published in the *Wall Street Journal* for the last business day of the month preceding the effective date of the loan, plus two percent.

**(g) *Payment of Benefits***

Terminated participants, age 55 or older, may elect to receive his or her vested account balance either in the form of cash installment payments or a lump-sum payment. All other terminated participants must receive their distribution in a lump-sum payment.

A terminated participant also may elect to leave the entire balance of his or her account in the Plan, provided the amount exceeds \$5,000, until the participant elects to receive a distribution, but in no event later than the date of any required minimum distribution. A participant may request that the entire balance of his account be distributed to him or her in a lump-sum while the individual is still employed by the Company after attaining age 59½.

**(h) *Forfeited Accounts***

Forfeitures, as defined in the plan document, occur at the earlier of the distribution date or the date at which a five-year break in service occurs. Forfeitures reduce the annual amount the Company contributes to the Plan or, in the case a contribution is not made, the forfeited amounts are reallocated to eligible participants based on the ratio of each individual participant's compensation to the total compensation of all eligible participants for that plan year.

**(2) SUMMARY OF ACCOUNTING POLICIES**

**(a) *Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

**(b) *Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective trusts:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. For the T. Rowe Price Equity Income Trust and the T. Rowe Price Retirement Trusts, trust units are issued and redeemed only on a valuation date and at the net asset value per unit computed on that date. Unit holders are required to provide a 30-day advance written notice to the trustee prior to redemption of trust units for the T. Rowe Price Equity Income Trust. Unit holders of the T. Rowe Price Retirement Trusts may be required to provide 30 day advance written notice to the trustee prior to redemption of trust units. For both the T. Rowe Price Equity Income Trust and the T. Rowe Price Retirement Trusts, the notice period may be shortened or waived by the trustee in its sole discretion. Trust units of the T. Rowe Price Stable Value Fund N may be redeemed on a daily basis to meet benefit payments and other participant initiated withdrawals permitted by retirement plans invested in the trust. Under the terms of the Declaration of Trust, retirement plans invested in the trust are required to provide 12 or 30 months' advance notice written notice to the trustee prior to redemption of trust units; the notice period may be shortened or waived by the trustee in its sole discretion. The remaining collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(c) Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

**(d) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**(e) *Risks and Uncertainties***

The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks as well as the risks associated with global events and international conflicts. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**(f) *Payment of Benefits***

Benefits are recorded when paid.

**(3) CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompany financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation of fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as completed and accurate by T. Rowe Price Trust Company (the trustee of the Plan).

**(4) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

**(5) PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of collective trusts operated by T. Rowe Price Trust Company. T. Rowe Price Trust Company is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to T. Rowe Price Trust Company qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**(6) TAX STATUS**

Effective January 1, 2022, the Plan sponsor has adopted a non-standardized prototype plan that has received an opinion letter from the Internal Revenue Service (“IRS”) dated August 19, 2020, stating that the form of the Plan is qualified under Section 401 of the IRC. The Plan sponsor has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan sponsor believes the Plan, as amended, is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**(7) ADMINISTRATIVE AND INVESTMENT MANAGEMENT EXPENSES**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

**(8) SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.
