Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of David Evans Enterprises, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of David Evans Enterprises, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of David Evans Enterprises, Inc. Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about David Evans Enterprises, Inc. Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of the David Evans Enterprises, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a defined contribution plan covering substantially all employees of David Evans Enterprises, Inc. (DEEI) and its wholly owned subsidiaries that have adopted the Plan, except those who are residents of Puerto Rico or are nonresident aliens. The Plan consists of a salary deferral and profit-sharing feature (401(k)) and an employee stock ownership feature (ESOP). Employees covered by the collective bargaining agreement with Operating Engineers Trust Fund Local #3 or Operating Engineers Trust Fund Local #12 and contractors hired by Flux Resources LLC are only eligible to participate in the 401(k) feature of the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). DEEI (the Company) is the Plan's sponsor and serves as Plan administrator.

The Plan was restated effective January 1, 2023, to integrate Amendment Nos 1 through 12 to the 2011 Restatement into a restated plan document for ease of administration, to amend the Plan to provide the terms on which the Company is redeeming all of the shares of Stock of the Company held in the matching contribution aspect of the Plan, to make certain other changes related to the design of the Plan, and to make related editorial, administrative and technical changes, and amplifications.

The Plan entered into a redemption agreement on June 30, 2023, for the Company to purchase 595,774.9559 shares, held in the matching contribution aspect of the Plan, for the benefit of current and former employees at the purchase price of \$53.00 per share. The participants, beneficiaries of deceased participants, and alternate payees received the cash proceeds into the 401k feature of the Plan and had the right to direct the investment of such proceeds among any of the available investment options.

Eligibility – Eligible employees of the Company will participate in the ESOP and profit-sharing portions of the Plan immediately upon hire. Participants must complete at least one month of service to be eligible to participate in the 401(k) portion of the Plan. The participant will enter the Plan on the first of the month following completion of one month of service.

Contributions

Participant contributions – Each year, participants may contribute between 1% and 85% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, deferrals are automatically increased, after year two, on an annual basis by 1%, up to a maximum auto-deferral of 15%.

Employer profit-sharing contributions – The Company may elect to make discretionary profit-sharing contributions to the Plan. The participant must be employed on the last day of the Plan year and completed more than 1,000 hours of service during the year to receive a profit-sharing contribution. The profit-sharing contributions are allocated to active participants in the same proportion as a participant's compensation bears to the total of all active participants' compensation. There were no profit-sharing contributions for the years ended December 31, 2024 and 2023.

Employer matching contributions – The Company may elect to make discretionary matching contributions to the Plan. The matching contribution may be made in the form of DEEI common stock or cash. The matching contribution will be allocated based on each participant's salary reduction contribution during the Plan year. The participant must be employed on the last day of the Plan year to receive a matching contribution. For the years ended December 31, 2024 and 2023, the matching contribution is calculated as 50% of employee contributions, up to 6% of eligible compensation deferred to the Plan. The matching contribution in the form of cash for the years ended December 31, 2024 and 2023, was \$2,920,847 and \$2,712,588.

ESOP contributions – The Company may also make discretionary ESOP contributions. The ESOP contribution may be in the form of DEEI common stock or cash. Cash contributions will be used to purchase DEEI common stock with the exception of the contribution for the year ending December 31, 2024. The participant must be employed on the last day of the Plan year and completed more than 1,000 hours of service during the year to receive the ESOP contribution. The ESOP contribution is allocated to active participants in the same proportion as a participants' compensation bears to the total of all active participants' compensation. The ESOP contribution in the form of cash for the year ended December 31, 2024 was \$2,071,888. The ESOP contribution in the form of stock for the year ended December 31, 2023 was \$1,857,614.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing and ESOP contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions and the Company’s matching and profit-sharing contributions plus actual earnings thereon. Vesting in the Company’s ESOP contributions portion of their accounts is based on years of continuous service. Participants vest in the Company’s ESOP contributions based on the following schedule:

Notes receivable from participants – Participants may borrow from the 401(k) portion of their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time determined by the Plan administrator. Under the terms of the Plan agreement, Plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. As of December 31, 2024 and 2023, the rates of interest on outstanding loans ranged from 5.25% to 10.50%, with various maturities through February 2034.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a participant’s account balance exceeds \$5,000, the participant may elect to receive their vested account balance in a lump-sum payment or defer distributions of the vested account until they reach age 62. Vested account balances less than \$5,000 will be distributed as soon as practicable, without the participant’s consent, following termination of employment.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Plan, must be used in the subsequent year, and will be used to restore a participant’s account, pay the Plan’s administrative expenses, or be allocated to active participants. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$122,277 and \$82,356, respectively. For the years ended December 31, 2024 and 2023, the Company allocated \$85,646 and \$106,171 of forfeitures to active participants, respectively.

Voting rights – Each participant is entitled to exercise voting rights attributable to his or her account as provided for in the Plan and is notified by the trustees of the Plan prior to the time that such rights are to be exercised. The trustees shall vote in its own discretion any shares of the stock with respect to which it has not received, prior to the date specified by the Plan administrator, written instructions on the prescribed form from participants who are entitled to direct the voting of such shares, and any unallocated shares and those held in suspense.

Put option – Under federal income tax regulations, DEEI common stock held by the Plan and its participants is not readily tradable on an established market and is subject to trading limitations. However, any participant who is otherwise entitled to a distribution from the Plan has the right (Put Option) to require the Company to repurchase the stock. The Put Option is a right to demand the Company buy any shares of stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can, at its option, pay for the purchase with interest over a period of five years. The purpose of the Put Option is to ensure the participant has the ability to ultimately obtain cash upon retirement or separation.

Diversification – Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in DEEI common stock into investments that are more diversified. Participants who are at least age 55 with 10 years of participation in the ESOP may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of his or her account, less any amount to which a prior election applies. In the case of the last year to which an election applies, 50% shall be substituted for 25%. Participants who elect to diversify may invest in three investment options or receive a cash distribution.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are stated at fair value. The Plan's trustee, Principal Trust Company, certifies the fair value of the registered investment companies and collective trusts.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Payment of benefits – Benefits are recorded when paid.

Expenses – Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund’s prospectus. All such fees are charged directly against the fund’s investment performance; thus, they are not separately disclosed in the accompanying financial statements. Participants are assessed separate fees for the administration of loans and repayments thereof, as well as investment advisory services, and such fees are separately disclosed in the financial statements. All other administrative expenses related to the Plan are paid by the Plan sponsor.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued. See Note 13 for discussion of subsequent events.

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

DEEI common stock – The fair value is based on an independent appraisal. The appraisal was based upon a combination of the market and income valuation methods consistent with prior years. The appraiser took into account historical and projected cash flow, net income, return on assets, return on equity, market comparability, and negotiated enterprise value related to a letter of intent in place on December 31, 2024.

Collective trust – Units held in a collective trust (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The CT transactions are processed daily. Withdrawals from the CT for benefit payments and participant transfers to noncompeting options shall be made within 30 days after written notification has been received and other withdrawals require a 12-month advance written notice.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated May 22, 2012, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. The value of the DEEI common stock is exposed to additional risks such as valuation assumptions based on future earnings, cash flows and/or other such techniques. It is reasonably possible, given the level of risk associated with the common stock and other investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 8 – Certified Investment Information

Note 9 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by Principal Life Insurance Company. Principal Trust Company is the custodian of the Plan and an affiliate of Principal Life Insurance Company and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

As of December 31, 2024 and 2023, the Plan held 520,899 and 564,982 shares of DEEI common stock. As the Plan sponsor, the Company is a party-in-interest with respect to the Plan.

Note 10 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 13 – Subsequent Events

On April 11, 2025, Atkins US Holdings, Inc. acquired 70% of the Company's issued and outstanding shares including all of the shares of the ESOP. The ESOP received payment of approximately \$91.4 million on the closing date based on the amounts specified in the Share Purchase Agreement. The Company is in the process of reconciling the final purchase price to determine the final share price. Any additional proceeds will be allocated as specified in the Share Purchase Agreement with Atkins US Holdings, Inc. Shares in participant accounts were converted on the closing date and have become part of the remaining profit-sharing portion of the Plan. The ESOP component of the Plan was terminated as of April 11, 2025.

As part of the transaction, the Plan was restated to (i) remove all ESOP-related provisions and prohibit future investments in qualifying employer securities, (ii) add provisions addressing the treatment of amounts attributable to the ESOP under the remaining profit-sharing portion of the Plan, (iii) provide for full vesting of certain participant accounts in connection with the termination and conversion of the ESOP component, and (iv) incorporate certain discretionary design, editorial, administrative, and technical changes.
