### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kutak Rock LLP 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

## **Basis for Opinion**

## **Note 1 - Description of the Plan**

The following brief description of the Kutak Rock LLP 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution and profit sharing plan covering substantially all partners, associates, of counsel attorneys, transition partners and employees of Kutak Rock LLP (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Advisory Committee is responsible for oversight of the Plan.

The Advisory Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### **Eligibility**

The Plan has no age or service requirements to make elective deferrals, but participation in the profit-sharing feature requires participants to have 1) two years of service, 2) be employed by the Employer on the last day of the Plan year, and 3) complete at least 1,000 hours of service during the Plan year, other than for those participants who are disabled, die or retire. Leased employees, union members, independent contractors and non-resident aliens are not eligible to participate in the Plan. Of counsel attorneys are not eligible to receive the profit-sharing contribution.

### **Entry Date**

For the purpose of employee contributions, an employee may enter the Plan as soon as administratively feasible after the employee commences employment with the Employer.

### **Contributions**

The Plan offers a salary reduction program where participants can elect to contribute up to 85% of pretax or after tax annual compensation, as defined by the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Employer may contribute a percentage of participant annual compensation to the Plan for each Plan year out of net profits. The amount of the contribution (10% for eligible staff and 4.5% for associates and staff attorneys in 2024), if any, is determined by the Executive Committee.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution (including rollovers) and allocations of (a) the Employer's contribution and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment to the Plan, a participant may direct deferrals, rollovers, and Employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### **Vesting**

Participants are vested immediately in their contributions (including rollovers) and any Employer contribution plus actual earnings thereon.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of either (a) \$50,000, reduced by the highest outstanding loan balance in the prior 12 month period, or (b) 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest rates which are equal to the Wall Street Journal Prime Rate plus 1%. Principal and interest is paid ratably through regular payroll deductions over a period not to exceed five years, unless the purpose of the loan is to acquire the primary residence of the participant, in which case the repayment period shall not exceed ten years. A participant may have no more than one outstanding note at any one time.

### **Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated participant with a balance of \$1,000 or less may be automatically paid out by the Plan upon termination. Any terminated participants with a balance that exceeds \$1,000 but is not more than \$7,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account, unless the participant elects another form of distribution within the 60 day notice period. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½.

### **Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Advisory Committee determines the Plan's valuation policies utilizing information provided by investment advisers, the trustee and recordkeeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions and Employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Expenses**

The Plan's expenses are paid by either the Plan or the Employer, as provided by the Plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee received compensation from the Plan.

**Subsequent Events**

The Plan Sponsor has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued.

**Note 3 - Certified Information**

Other than the self-directed brokerage accounts and the related interest income and net appreciation in fair value of investments, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company (the trustee of the Plan). Investments of \$95,985,758 and \$82,270,464 as of December 31, 2024 and 2023, respectively, and interest and dividend income and net appreciation in fair value of investments of \$3,046,800 and \$10,175,713, respectively, for the year ended December 31, 2024 were not certified by the trustee.

**Note 4 - Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts – Valued at fair value based on the NAV of the units held in the account. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the account less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Self-directed brokerage accounts – Accounts primarily consist of cash equivalents whose cost approximates fair value due to their short term nature, common stock valued at the closing price reported on the active market on which the individual securities are traded and mutual funds valued at the net asset value of shares held by the Plan at year end. Accounts also include corporate bonds and government securities which are valued using third party pricing services using active market data.

**Note 6 - Tax Status**

The IRS has determined and informed the Employer by a letter dated August 7, 2014, that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code (IRC).

Subsequent to the issuance of this determination letter, the Plan was amended. However, the Employer and plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Party-in-Interest Transactions**

Certain Plan investments consist of a pooled separate account managed by Voya Institutional Trust Company, the trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 - Plan Amendments**

In connection with the SECURE 2.0 Act, the Plan has adopted certain provisions to comply with recent legislative and regulatory changes, including increasing the mandatory distribution limit from \$5,000 to \$7,000 as of January 1, 2024 and allowing increased catch-up contributions for eligible participants as of January 1, 2025. However, as allowed by those regulations, the Plan has not been formally amended as of December 31, 2024.
