Basis for Opinion

1. Description of Plan

The following brief description of the Caven Enterprises 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for complete information.

General

The Plan is a defined contribution plan available to all eligible employees of Caven Enterprises, Incorporated (the “Company”) who are age twenty-one (21) or older, completing one year and 1000 hours of service. The Plan was formed on January 1, 1999, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is defined by Section 401(k) of the Internal Revenue Code (“IRC”).

Eligibility

An employee is eligible to become a participant in the Plan on the first day of the month coinciding with or the next following date he or she completes one year and 1,000 hours of service and who is twenty-one (21) years of age.

Employee Salary Reduction Election

A participant may elect to defer up to one hundred percent (100%) of his or her compensation each year instead of receiving that amount in cash. However, total deferred compensation may not exceed the limits set by Internal Revenue Code (IRC) Sections 401(k), 404, and 415. In addition, participants who are age fifty (50) or over before the close of the plan year are eligible to make catch-up contributions subject to the limitation imposed by the IRC.

Contributions

Elective Contribution

The Company must contribute the amount of the total employee salary reduction elections of all participants made during the Plan year. Elective contributions must be paid by the Company to the Plan’s trustee as soon as they can be segregated from its general assets but, no later than the fifteenth (15th) business day after the month of receipt of the elective contribution.

Employer Non-Elective Contributions

The Company may make a discretionary matching contribution in amounts to be determined by the Company.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their elective contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous services. The vesting for the Company account is as follows:

Years of Service With the Company	Percent of Nonforfeitable Accrued Benefits
Less than 2 years	None
2 Years, but less than 3	20%
3 Years, but less than 4	40%
4 Years, but less than 5	60%
5 Years or more	100%

Forfeited Accounts

Forfeitures represent the portion of non-vested employer contributions remaining in the Plan for terminated employees and may be used to reduce the employer matching contribution and to cover the costs of administration of the Plan. Forfeited account balances at December 31, 2024 and 2023 were \$0. There were no forfeitures applied toward employer contributions for the year ended December 31, 2024.

Distribution of Benefits

Upon Retirement

Distributions may be made to a participant who has not separated from service when he or she attains age fifty-nine and one-half (59 ½). Payment may be in the form of a lump-sum distribution in cash.

Upon Termination of Employment

A participant may elect to have his or her account balance distributed as soon as administratively feasible following termination of employment. If the value of the vested account balance does not exceed \$1,000, then a distribution will be made in cash. However, if the value of the vested account balance is more than \$1,000 but less than \$7,000, he or she may elect to receive distribution in cash or to roll over to an IRA or a qualified plan of his or her new employer.

Distribution of Benefits (continued)

Hardship Distributions

A participant may withdraw money for financial hardship if he or she satisfies certain conditions. Hardship distributions can only be made from salary deferral and rollover accounts which are fully vested and a participant must be employed with the Employer at the time of the hardship distribution.

Upon Disability

A participant's account is distributable upon a participant's disability. Payment may be in the form of a lump-sum distribution or partial withdrawal.

Upon Death

Upon the death of a participant, a distribution of the vested account balance be made to his or her designated beneficiary in a single lump-sum payment.

Administrative Fees

Distribution and loan fees are charged directly to the requesting participant's account. The Company absorbs the majority of all other administrative fees of the Plan. If expenses paid by the Plan are allocated to participants, expenses are either proportionately based on the value of the account balances or as an equal dollar amount based on the number of the participants in the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct all of his or her accounts to a variety of investments. Participant's accounts are segregated for purpose of determining the earnings or losses on their investment options.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value except for GIC, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits payments are recorded when paid.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds for which a quoted market price is available on an active market. Review the Fair Value Methodology section of the fund's Annual Report for the types of investments included in the portfolio and the valuation methods used in pricing those investments.

Pooled Separate Account

Pooled separate account ("PSA") invests mainly in domestic stocks or mutual funds. The majority of the underlying securities have observable level 1 quoted pricing inputs. The net asset value ("NAV") of the pooled separate account is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date.

4. Investments at Contract Value

The Plan invests in a Guaranteed Investment Contract (“GIC”). This GIC is considered a fully benefit-responsive investment contract (“FBRIC”) and should be reflected at contract value within net assets available for benefits (see ASC 962-10, "Plan Accounting - Defined Contribution Pension Plans" on what defines a FBRIC). ASU 2015-12 states that FBRICs should be measured, presented, and disclosed only at contract value and fair value information is not required. Investment contract balances at December 31, 2024 and 2023 were \$345,489 and \$448,029, respectively.

5. Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company (“Principal”), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required Supplemental Schedules is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required Supplemental Schedules.

6. Related-Party Transactions and Party in Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$99,008 of administration and recordkeeping fees to Principal and \$4,425 of management advisory fees paid to UBS Financial Services Inc. during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

8. Contingencies, Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

On March 7, 2024, the Plan received additional proceeds of \$299,604 from the tax escrow accounts as part of the stock purchase agreement dated September 14, 2021. These additional proceeds are reported as other investment income in 2024.

9. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Company and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

11. Correction of Deferral Contribution Errors

In 2023, the Plan Sponsor identified deferral contribution errors affecting the 2022 and 2023 plan years. These errors involved missed or incorrect employee deferrals. On February 28, 2024, the Plan corrected the errors by receiving additional employer contributions totaling \$10,341, along with \$1,225 in lost earnings. The total correction amount of \$11,566 was made through Qualified Nonelective Contributions (QNECs), in accordance with IRS guidelines under the Employee Plans Compliance Resolution System (EPCRS).

As these contributions were not recorded in prior years and the impact was not material to the financial statements, beginning net assets were not restated. The correction is reflected in the 2024's financial statements.

12. Date of Management's Review

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
