Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements (modified cash basis) of the Nissan North America, Inc. Welfare Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and the statements of plan's benefit obligations as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits and statement of changes in plan's benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to these financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

1. DESCRIPTION OF PLAN

The following description of the Nissan North America, Inc. Welfare Plan (the “Plan”) provides for general information only. Participants should refer to the Plan agreement for more complete information.

Organization of the Plan—The Plan is a voluntary employee benefits plan sponsored by Nissan North America, Inc. Plan participants include employees and retirees of Nissan North America, Inc., Nissan Extended Services North America, and Nissan Motor Acceptance Corporation (collectively, the “Plan Sponsor” or the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

General—The Plan was established by Nissan North America, Inc. and subsidiaries on November 1, 1993 to provide medical, dental, vision, prescription drug, legal, life insurance, disability, and death benefits in addition to health care and dependent care flexible spending accounts for certain eligible employees and dependents of those employees of the Plan Sponsor or any of the employers who adopt one or more of the benefit programs under the Plan. Employees hired after January 1, 2011 are not eligible to receive retiree health coverage. Those employees continue to receive medical benefits until they retire or are no longer employed by the Company. Eligible retirees may participate until covered by Medicare at age 65. In certain circumstances, an eligible retiree’s spouse is eligible to participate until covered by Medicare or 10 years after the retiree’s date of retirement, whichever occurs first. All full-time employees working at least 30 hours per week who are not exempted by a collective bargaining agreement and are not enrolled in any of the other Plan Sponsor medical or dental plans are eligible for the Plan. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act. (“COBRA”).

The Plan fully insures long-term disability, accidental death, and life insurance benefits, and premiums are paid from the assets of the Plan. All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan.

The Plan offers Flexible Spending Accounts (FSA) that are funded through participant contributions. The accounts allow eligible participants to be reimbursed tax free for qualified medical expenses or dependent care services subject to a specified ceiling. Any unused funds in excess of the Internal Revenue Service (“IRS”) carryover limit not claimed by March 31 of the following plan year are forfeited. The accounts cannot be used for anything other than reimbursements for qualified medical expenses or dependent care services; and remaining amounts are not portable upon termination once the employee leaves the employer.

The Plan offers Health Savings Accounts (HSA) that are funded through participant contributions. The accounts allow eligible participants to be reimbursed tax free for qualified medical expenses. Unused funds are rolled over from year to year; and remaining amounts are portable upon termination. The participant owns the account and is responsible for substantiating distributions from his or her account, thus amounts related to HSAs are excluded from the financial statements.

Contributions—Contributions to provide benefits under the Plan are made by the Plan Sponsor, retirees, employees and former employees. The Plan Sponsor’s funding policy is to have the participating companies and individuals make cash contributions to the Plan in amounts computed by the Plan’s actuary to cover expected benefits along with administrative costs. Retiree participant contributions for the years ended December 31, 2024 and 2023 were as follows:

The contribution rates for the medical coverage are determined annually by the Plan’s actuary. The cost of active and retiree medical benefits paid, to the extent not provided by contributions from eligible participating employees, is provided by the Plan Sponsor. Benefits paid by the active and retiree medical portions of the Plan are based on provisions set forth in the applicable Plan documents. The Plan is funded through a voluntary employee beneficiary association (“VEBA”) trust account held by a trustee.

The Northern Trust Company is the trustee of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation — The financial statements are presented on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, certain Plan assets and additions to assets are recognized when received rather than earned, and deductions to certain Plan assets are recognized when paid rather than when the obligations are incurred. In addition, investments are adjusted to fair value. The Statements of Plan’s Benefit Obligations and the Statement of Changes in Plan’s Benefit Obligations include actuarially determined amounts as described in *Postretirement Benefits*.

Use of Estimates — The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual amounts could differ from those estimates.

Valuation of Investments — Investments in the Northern Institutional Government Select Portfolio are stated at fair value as determined by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Interest income is recorded when received. Purchases and sales of securities are recorded on a trade date basis.

Expenses — Certain administrative functions are performed by employees of the Plan Sponsor. No officer or employee receives compensation from the Plan. Administrative expenses for actuary fees, auditor fees, trustee fees and claim administrator fees are paid directly by the Plan.

Postretirement Benefits — The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to the date of the financial statements. Postretirement benefits include future benefits to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date. The Statements of Plan's Benefit Obligations and the Statement of Changes in Plan's Benefit Obligations are presented in accordance with Financial Accounting Standards Board Accounting Standards Codification ("ASC") 965, *Plan Accounting – Health and Welfare Benefit Plans*.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is that amount which results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, health care cost trend rates were assumed to approximate 6.8% for 2025 and gradually decrease to 4.4% in the year 2040. The following are other significant assumptions used in the valuation as of December 31, 2024 and 2023:

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Payment of Benefits — Benefit payments are recorded upon distribution.

Other Plan Benefits — The cost of Plan benefits includes the liability for benefit obligations for incurred claims not reported within the Statements of Plan's Benefit Obligation. The incurred claims not reported have been estimated by the Plan's actuary in accordance with accepted actuarial principles.

Risks and Uncertainties — The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan values assets in accordance with the fair value standard. The standard clarifies the definition of fair value, establishes a framework for measuring fair value and expands the disclosures for fair value measurement. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Short-term investment fund*: Valued at cost, which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsor has the right to modify the benefits provided to participants, to discontinue its contributions and to terminate the Plan at any time, subject to provisions set forth in ERISA. If the Plan is terminated, the rights of the participants and/or dependents are limited to the expenses incurred before termination.

5. FEDERAL INCOME TAX STATUS

The VEBA trust received an exemption letter from the IRS dated March 16, 1994, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income. In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt. The Plan is subject to routine audits by tax authorities, however, there are currently no audits for any tax periods in progress.

6. BENEFIT OBLIGATIONS

The Plan's deficiency of benefit obligations over net assets at December 31, 2024 and 2023, relates primarily to the postretirement benefit obligation. It is expected that the deficiency will be funded through future contributions.

The weighted-average health care cost trend rate assumptions (see Note 2) have a significant effect on the amounts reported in the accompanying financial statements. If the weighted-average health care cost trend rate increased by 1%, the service and interest cost increase to the Plan would be \$1,737,848 and the accumulated postretirement plan benefit obligation would increase by \$17,416,157 as of December 31, 2024. Likewise if the rate decreased by 1% the service and interest cost decrease to the Plan would be \$1,558,998, and the accumulated postretirement plan benefit obligation would decrease by \$15,886,811 as of December 31, 2024.

The Plan is primarily self-insured, and health costs incurred by participants and their beneficiaries and dependents are covered by the Plan's assets. The Plan Sponsor is not permitted under present tax law to deduct amounts for future benefits (beyond one year).

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's short-term investment fund is in the Northern Institutional U.S. Government Select Portfolio. The Northern Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions.

8. UNTIMELY REMITTANCE OF PARTICIPANT CONTRIBUTIONS

The Plan Sponsor is required by Department of Labor regulation to remit participant contributions to the Plan or pay related insurance premiums within ninety days from the date the amounts were withheld from wages. For certain contributions withheld in 2024, the funds were not remitted to pay the related insurance premiums timely.

9. SUBSEQUENT EVENTS

The Plan's management has evaluated events and transactions that occurred between December 31, 2024 and October 15, 2025, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.
