### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Astera Health Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Astera Health Employee Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 DESCRIPTION OF PLAN**

The following description of the Astera Health Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established January 1, 1987. The Plan provides for its employees a tax deferred annuity arrangement intended to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan has been amended and restated throughout the years to comply with tax legislation.

The Plan covers all employees of Astera Health (Employer). The Plan excludes PRNs and temporary employees hired on or after February 20, 2017 from the Employer matching contributions. The Plan is subject to ERISA. The Board of Directors is responsible for the oversight of the Plan.

Subsequent to year end, effective January 1, 2025, the Plan was amended to modify the definition of excluded employees.

**Eligibility**

Employees are eligible to participate immediately upon their date of hire in the salary deferral arrangement. Employees who are age 18 or older are eligible for discretionary Employer matching contributions.

**Contributions**

Participants may elect to make pre-tax or after-tax Roth salary reduction contributions up to 100% of their compensation, subject to Plan provisions. Participants are automatically enrolled at 4% unless they elect otherwise. The Plan has an automatic increase provision whereby participants automatically enrolled will have their deferral rate increased by 1% annually up to 10%. The Plan allows participants age 50 and older to make catch-up contributions.

The Plan allows for discretionary Employer matching contributions. For the years ended December 31, 2024 and 2023, the Employer authorized a 2% matching contribution per payroll period on eligible compensation deferred for participants deferring 4%. Matching contributions are prorated if the participant defers less than 4%. There are no allocation conditions required to receive the discretionary matching contribution given each pay period.

The Plan allows the Employer to authorize an additional discretionary Employer matching contribution to be applied to each plan year for participants deferring at 4%. The additional matching contributions are prorated if the participant deferring less than 4%. Participants must be employed on the last day of the Plan year in order to share in Employer additional matching contributions unless termination is due to death, disability, or retirement. For the years ended December 31, 2024 and 2023, the Employer did not authorized an additional annual matching contribution.

**Contributions (Continued)**

Participants may also contribute distributions from other qualified plans. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan also permits qualified organization catch-up contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's deferral contributions, the Employer's discretionary matching contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their deferral contributions plus actual earnings thereon. Employer discretionary matching contributions, plus actual earnings thereon, are subject to a two-year cliff vesting, whereby a participant is 100% vested following the completion of two years of credited service. Notwithstanding the above, participants shall become 100% vested in their account upon attaining normal retirement age (65), death, or becoming totally or permanently disabled.

**Forfeited Accounts**

Forfeited nonvested accounts may be used to reduce Employee contributions or to pay Plan administrative expenses. Forfeited nonvested accounts totaled \$564 and \$41,927 on December 31, 2024 and 2023, respectively. There were \$90,942 and \$-0- of forfeitures used to reduce the Employer matching contributions for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note transactions are treated as a transfer to (from) the investment fund (to) from the notes receivable funds. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over 30 years. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1% (prime rate plus 2% prior to May 6, 2024). Principal and interest is paid ratably through payroll deductions or ACH transfer.

**Benefit Payments**

Upon termination of service, death, disability, or retirement, a participant may receive the value of the vested interest in their account in the form of a lump-sum payment, installments or a partial distribution. If a participant terminates employment and the participant's account balance is not greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan requires all mandatory distributions between \$1,000 and \$5,000 to be rolled over into an individual retirement account if no other election is made by the participant. The Plan allows participants to receive in-service distributions of their employee elective deferral balance upon the attainment of age 59½, subject to Plan provisions. The Plan allows for hardship distributions subject to Plan provisions.

Subsequent to year end, effective January 1, 2025, the mandatory distribution limit was increased from \$5,000 to \$7,000.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value (except for fully benefit-responsive investment contracts which are valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisor, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Contributions**

Contributions from participants and employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Fees related to administration of the Plan and asset-based investment advisory are allocated to participant accounts and included in administrative expenses. Investment related expenses including revenue sharing credits are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustee and insurance company of the Plan, respectively, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information presented on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan does have a remaining American United Life Insurance (AUL) fixed interest account which is not certified therefore, the fixed interest account of \$13,017 and \$12,517 on the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively, and related interest income of \$500 and \$481 reported on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively, is not certified.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed Interest Account:* Valued at fair value. Fair value is determined by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

**NOTE 5 INVESTMENT CONTRACTS WITH INSURANCE COMPANIES**

The Plan entered into a fully benefit-responsive guaranteed investment contract, the Great-West Investments Fixed Account – Series VI, with Empower Annuity Insurance Company of America (insurance company). Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

The Plan also has an insurance contract with AUL. As part of the contract, AUL maintains a portion of the contributions in "fixed interest account." The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by AUL. The fixed interest account is included in the financial statements at fair value because it is nonbenefit-responsive. Upon termination of the investment contract, the lump sum liquidation value of the general account portion of the portion of the participant's accumulation value shall be equal to the product of (a) the participant's general account accumulation value on the liquidation date, reduced by the liquidation charge applicable on the liquidation date and (b) a market value adjustment percentage.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions.

**NOTE 8 PLAN TAX STATUS**

The Plan Sponsor adopted a 403(b) volume submitter document and the Plan is placing reliance on an opinion letter received from the IRS indicating that the 403(b) volume submitter plan is qualified under Section 403(b) of the IRC and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodian and insurance company, respectively. Therefore, these transactions qualify as party-in-interest. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
