Independent Auditor's Report

To the Participants and Plan Administrator of
Shell USA, Inc. Health & Wellbeing Plan

Opinion

We have audited the financial statements of Shell USA, Inc. Health & Wellbeing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and statement of changes in benefit obligations for the year ended December 31, 2024, and the related notes to financial statements (collectively, financial statements).

1. DESCRIPTION OF THE PLAN

The following description of the Shell USA, Inc. Health & Wellbeing Plan (formerly known as the Shell Oil Company Comprehensive Welfare Benefits Plan) (“the Plan”) provides only general information about the Plan’s provisions. Participants should refer to the Plan Instrument, Component Program documents and respective Trust Agreements for a complete description of the Plan’s provisions, copies of which may be obtained from the Plan Administrator.

General

The Shell Medical Plan was amended and restated as of January 1, 2008, and became the Shell Oil Company Comprehensive Welfare Benefits Plan, Plan No. 501, in which the prior plans were consolidated into a single comprehensive welfare benefits plan.

Each prior plan was merged into the Plan and became a “Component Program” under the Plan. The prior plans previously established for the benefit of its employees and which were consolidated are the following: Shell Medical Plan; Shell Dental Assistance Plan; Shell Vision Care Plan; Cafeteria Plan; Shell Flexible Spending Account Plan; Income Protection Insurance Plan; Shell Long-Term Disability Plan; Survivor Benefit Plan of Shell Oil Company; Shell Occupational Accidental Death Benefit Plan; Shell Long-Term Care Plan; Group Life Insurance Plan of Shell Oil Company; Shell Voluntary Personal Accident Insurance Plan; Business Travel Accident Insurance Plan; The Group Legal Plan; Employee Assistance Program; and The Back Up Care Advantage Program.

Effective March 1, 2022, the name of the Plan was changed from “Shell Oil Company Comprehensive Welfare Benefits Plan” to the “Shell USA, Inc. Health & Wellbeing Plan” following the Plan Sponsor’s name change from Shell Oil Company to Shell USA, Inc. (“the Company” or “Plan Sponsor”)

The Plan is a welfare benefit plan which provides medical, dental and vision care, as well as other welfare programs. The participants are regular full-time employees, regular part-time employees and eligible retirees of participating companies, referred to as the “Employer” or collectively the “Employers”, who satisfied the associated eligibility requirements.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, and is described more fully in the Plan Instrument, Component Program documents and respective Trust Agreements.

Effective January 1, 2017, the Plan was amended to exclude eligibility for post-retirement medical benefits for those employees hired on or after January 1, 2017, unless they met the Plan’s retirement eligibility requirements prior to January 1, 2017.

Effective January 1, 2022, the Plan was amended to exclude eligibility for post-retirement life benefits for participants not enrolled prior to January 1, 2022.

The Trusts established to hold plan assets and fund associated benefits under the Plan were terminated effective June 28, 2024. The trustee was directed to use the remaining assets of the Trusts to pay associated benefits and plan expenses, after which the Plan is funded through general assets of the Plan Sponsor, participant contributions, and insurance.

Administration

The Plan Sponsor has designated a Plan Administrator to perform the general administration of the Plan. For purposes of ERISA, the Plan Administrator is the administrator and the named fiduciary with respect to the general administration of the Plan. The Plan Administrator has all powers necessary to properly administer the Plan and to discharge its duties under the Plan and has full and absolute discretion in exercise thereof. Principal Bank is the trustee for the Plan. Fidelity Workplace Services (Fidelity) is the Plan's recordkeeper.

Contributions

Medical Benefit Program (MBP)

Employers and participants contribute to the program on a monthly basis. Contributions are intended to approximate the total anticipated annual costs and expenses of the program as estimated by the Company and the Plan Administrator. Employers and participant contributions are revised annually based on program experience. Active participant contributions are made on a pre-tax basis. Contributions for domestic partner and retiree coverage are made on an after-tax basis. The MBP is funded by a trust, by insurance and by general assets of the Plan Sponsor. It consists of both fully insured and self-insured options.

Dental Benefit Program (DBP)

Employers and participants contribute fixed amounts to the program on a monthly basis. Contributions are intended to approximate the total anticipated annual costs and expenses of the program as estimated by the Company and the Plan Administrator. Employers and participant contributions are revised annually based on program experience. Active participant contributions are made on a pre-tax basis. Contributions for domestic partner coverage and retiree coverage are made on an after-tax basis. This program is funded by a trust, by insurance and by general assets of the Plan Sponsor. It consists of both fully insured and self-insured options.

Vision Benefit Program (VBP)

Participants contribute 100% of the cost of the program through monthly pre-tax payroll deductions. Contributions for domestic partner and retiree coverage are made on an after-tax basis. This program is funded by insurance and fully insured.

Health Care and Dependent Care Account Programs (HCDCA)

The HCDCA program is funded by participant contributions. Participants elect to have monthly contributions deducted from their compensation on a pre-tax basis and paid into a Health Care or Dependent Care Account under the program. Each participant's contribution to a Health Care or Dependent Care Account may be used to reimburse the participant for certain qualifying health care and dependent care expenses, respectively. Such reimbursements may not exceed the participant's annual election for Health Care Account (HCA) or the balance in the participant's Dependent Care Account (DCA). For Health Care participants, the program will reimburse eligible expenses incurred through December 31 of the Plan Year. Participants may utilize the current balance in their DCA at any point during the Plan Year for reimbursement of qualifying expenses incurred during the Plan Year and up to the date reimbursement is requested. Any contribution remaining in the program after reimbursement of permitted participant health care and dependent care expenses and after payment of applicable program administrative costs are forfeited.

Income Protection Insurance Program (IPI)

Participants may elect to purchase additional insurance to supplement any pay they receive under the Disability Benefit Plan when they are unable to work because of a nonoccupational disability. Participants contribute 100% of the cost of the program through after-tax monthly payroll deductions and may purchase coverage at one of two benefit levels: half (50%) pay and quarter (25%) pay. This program is funded by insurance and fully insured.

Long-Term Disability Program (LTD)

Participants contribute 100% for the cost of the program through after-tax monthly payroll deductions. Participant's maximum monthly LTD benefit is based upon 60% of pre-disability earnings not to exceed a monthly maximum of \$10,250, with the minimum monthly LTD benefit not less than 5% of basic monthly earnings. This program is funded by insurance and fully insured.

Survivor Benefit Program (SBP) and Occupational Accidental Death Benefit Program (OADBP)

Employer contributes 100% for the cost of the programs. The Survivor Benefit is term life insurance for the participant equal to two times the participant's annual base salary. The OADBP provides a benefit of \$500,000 for participants who die as a direct result of an accident while at work. This program is funded by insurance and fully insured.

Long-Term Care Program (LTC)

Effective January 1, 2012, new enrollments into the LTC Program were suspended. Participants previously enrolled pay the entire cost of coverage directly to John Hancock. The cost of coverage is based upon the participant's coverage selections, the state in which the participant resides, and the age of the participant when coverage takes effect. The LTC provides long-term care benefits in the event of a loss of functional capacity or cognitive impairment. This program is funded by insurance and is not open to new participants.

Group Life Insurance Program (GLI)

Participants may elect to contribute 100% of the cost for coverage on an after-tax basis. Active participants may purchase active group life insurance coverage for themselves equal to one to seven times their annual base pay, in half-pay increments up to a maximum benefit of \$4 million. They may also purchase life insurance for their eligible dependents. This program is funded by insurance and fully insured.

Voluntary Personal Accident Insurance Program (VPAI)

Participants may elect to contribute 100% of the cost for coverage through monthly pre-tax payroll deductions. Contributions for domestic partner coverage are made by payroll deduction on an after-tax basis. The VPAI provides a benefit in the event of accidental death, dismemberment, or paralysis. Participants may select a benefit amount up to ten times their annual base pay to a maximum benefit of \$1,000,000. This program is funded by insurance and fully insured.

Business Travel Accident Insurance Program (BTAI)

Employer contributes 100% for the cost of the program for eligible employees, spouse, domestic partner, children and guests for the purposes of business travel. The BTAI benefit equals one times the participant's annual base pay but not less than \$50,000. The maximum benefit amount is \$300,000. This program is funded by insurance and fully insured.

Group Legal Program (GLP)

Participants may elect to contribute 100% of the cost for coverage for themselves and family members through monthly after-tax payroll deductions. The GLP provides coverage for certain personal legal services. This program is funded by insurance and fully insured.

Employee Assistance Program (EAP)

Employer contributes 100% for the cost of the program for eligible employees and their families. The EAP offers access to lifestyle and behavioral health resources and referral services. This program is funded by insurance and fully insured.

Back-Up Care Advantage Program (BAP)

BAP is a voluntary benefit available to provide temporary solutions when normal care arrangements are unavailable for eligible employees and their dependents. Eligible employees can receive a maximum of 15 uses of center-based or in-home care each calendar year. The employee pays subsidized co-payments of \$6 per hour for up to three persons for in-home care. This program is funded by general assets of the Plan Sponsor and participant funds.

Retiree Contributions

Contributions from retirees are collected by Fidelity through monthly pension deductions, automatic bank withdrawal, or by the retired participant mailing a check to Fidelity.

Eligibility

Participants are eligible for enrollment in the Plan if they are a regular full-time or regular part-time employee of a participating Employer. Participants who enroll in the Plan can enroll their eligible dependents in certain of the welfare programs offered under the Plan. Retirees can participate in the Plan if they have met certain retiree coverage eligibility criteria as summarized in the Summary Plan Description.

Participants/Retirees and their eligible dependents are able to elect Consolidated Omnibus Budget Reconciliation Act (COBRA) continuation coverage for MBP, DBP, VBP, Health Care Account and EAP upon a qualifying loss of coverage.

Participants are eligible for enrollment in IPI if they are a regular full-time or regular part-time employee of a participating company unless they are covered by an applicable state disability law.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not recorded, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Claims payments are recorded when paid by claims processors. Amounts due to the claims administrator for claims that have been paid but not yet reimbursed by the Plan are recorded as payable to claims administrator in the accompanying statements of net assets available for benefit. Rebates due from the Plan's pharmacy benefits manager are recorded when received. Pharmacy rebates totaling \$34,756,262 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Certain premiums and claims are paid from the general assets of the Company; however, all premiums and claims are recorded in the accompanying statement of changes in net assets available for benefits, regardless of whether they were paid from plan assets or from the general assets of the Company.

Investment Valuation and Income Recognition

Investments are reported at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies and procedures utilizing information provided by the trustee. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. See Note 5 for a discussion of fair value measurements.

Administrative Expenses

Administrative expenses consist mainly of fees for processing benefit claims, insurance carrier administrative fees, trustee administrative fees and professional services. Certain other administrative expenses are paid by the Company on behalf of the Plan.

3. BENEFIT OBLIGATIONS

Benefit obligations of the Plan include claims reported but not paid, claims incurred but not reported and postretirement obligations.

The benefit obligations for health and welfare benefit plan is a standardized disclosure measure of the actuarial present value of postretirement benefits. The estimated liability for incurred but not reported claims of active participants and dependents is calculated based on historical claim experience.

Actuarial Present Value of Accumulated Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributable by the terms of the Plan to employee service rendered through the year ended December 31, 2024, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company and from plan assets until the termination of the Trust. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service with the Employer rendered through the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

At December 31, 2024 and 2023, the Plan had a deficit of net assets over benefit obligations. It is expected that the deficiency will be funded through future contributions from the Plan Sponsor and Plan participants. In 2024 and 2023, retired plan participants paid \$35,755,875 and \$37,440,661, respectively, in medical premiums.

For measurement purposes, a weighted-average annual rate of increase in the average per capita cost of covered health care benefits was assumed to be 8.57% pre-Medicare, 9.89% post-Medicare (non-MAPD), and 13.95% post-Medicare (MAPD) for the period 2025; the rate was assumed to decrease gradually reaching 5% for the period 2033 and to remain at that level thereafter.

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by 1 percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023, by \$255 million and \$250 million, respectively.

Assumptions used to determine the postretirement benefit obligation include a discount rate of 5.60% and 4.90% as of December 31, 2024 and 2023, respectively. Changes in actuarial assumptions included: (a) \$111,865,000 increase for updates to the healthcare trend rates; (b) \$203,541,000 decrease for the change in interest rate, and (c) \$8,368,000 decrease for change in medical plan election rates. Other changes component represents the normal operation of the postretirement welfare plan, which consisted of the increase due to benefits earned by active employees and increases or decreases due to plan experience. Some medical options changed effective January 1, 2024, like MAPPO changing to MAPD, which included fully insuring prescription drug for the Medicare Complementary option. Health claims incurred by retired participants but not reported at year end are included in the post-retirement benefit obligation.

Other significant assumptions used to determine the actuarial present value of accumulated Plan benefits at December 31, 2024 and 2023, were (a) mortality (Pri-2012 white collar amounts - weighted employee mortality table for non-annuitants and Pri-2012 white collar non-disabled annuitants table adjusted with projection scale MP-2021 to a base year of 2019 for annuitants); and (b) retirement age (age graded rates ranging from 6 percent at age 50 to 100 percent at age 70).

The Plan Sponsor transitioned to a self-funded Employer Group Waiver Plan (“EGWP”), beginning with the 2013 plan year, to provide its prescription drug coverage for Medicare-eligible retirees in the Plan. The impact of the transition has previously been reflected in the December 31, 2011, post-retirement benefit obligation and the Federal subsidy with the Social Security Act (“Act”) was no longer applicable for this Plan once the Plan Sponsor moved to EGWP in 2013. EGWP is a Medicare Part D prescription drug plan. Employers partner with a pharmacy benefit manager that has contracted directly with Medicare to be a Part D provider. The EGWP provides the standard Medicare part D prescription drug coverage only to Medicare-eligible retirees and dependents of the sponsoring employer. An EGWP is not open to the individual market. It is a specific plan available to employer plans. The EGWP has been included in the post-retirement benefit obligation and is reflected in the claims cost and retiree contribution assumptions. The data used to develop the claims cost assumptions utilizes actual paid claims and subsidy experience related to the EGWP plan. Effective January 1, 2023, the EGWP plan was terminated with prescription drugs for Medicare-eligible retirees provided through a fully-insured arrangement.

Effective September 7, 2021, the Plan Sponsor entered into a group insurance contract with Metropolitan Life Insurance Company (“MetLife”) to settle a portion of the retiree life obligation. Under the agreement, life insurance benefits for generally all eligible retirees who had satisfied the premium requirements were transferred to MetLife with a lump sum payment from a life insurance funding account.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the benefit obligations.

4. RESTRICTED CASH

Under agreements among the Plan Administrator, the trustee and certain claims administrators, the Plan is required to maintain a minimum cash balance with insurance carriers on which benefit payments are drawn. In the event the balances of the designated accounts fall below the minimum funding level, the trustee transfers the necessary Plan funds to restore the accounts to the minimum balance the following day.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 (ASC 820) defines fair value as the price that would be received to sell an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 established a three-level fair value hierarchy that prioritizes the inputs used to measure fair value.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset and liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used or levels at December 31, 2024 and 2023, nor have there been transfers between levels.

Money Market Fund

Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish their daily net asset value (“NAV”) and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. INCOME TAX STATUS

Prior to the consolidation, the Internal Revenue Service (IRS) had determined and informed the Company by letters dated August 20, 1982, and December 13, 1982, for the Dental and Medical Benefit Plans, respectively, that the Trusts, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since the Trusts received the determination letters. The Plan Administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Company believes that the Trusts continue to qualify and to operate as designed. Therefore, no provision for income taxes has been included in the Plan’s financial statements. The Trusts established to hold plan assets and fund associated benefits under the Plan were terminated effective June 28, 2024.

Certain aspects of the Plan are intended to be a cafeteria plan under Section 125 of the IRC with respect to the cafeteria component program benefits. The taxable income or loss of the HCDCA’s custodian account is reflected in the Employers’ income tax returns.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years that are open.

7. TERMINATION OF THE PLAN

Although it has not expressed an intention to do so, the Company reserves the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA and the Code. Effective June 28, 2024, the Plan Sponsor, acting through the Plan Administrator, resolved to terminate the Trusts established to hold plan assets and fund associated benefits under the Plan, after which the Plan is funded through general assets of the Plan Sponsor, participant contributions, and insurance.

8. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

The Company and its affiliates, the trustee, the Plan Administrator and certain other Plan service providers qualify as parties-in-interest. Transactions with these parties-in-interest qualify for exemptions from the prohibited transaction rules.

9. RISKS AND UNCERTAINTIES

The Plan invests in a short-term money market investment. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan's contribution amounts and benefit obligations are based on certain assumptions pertaining to interest rates, healthcare inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

11. SUBSEQUENT EVENTS

Events and transactions subsequent to the statement of net assets available for benefits date have been evaluated through October 15, 2025, the date these financial statements were issued, for potential recognition or disclosure in the financial statements.

Effective January 1, 2025, the employee-paid Income Protection Insurance (IPI) program and employee-paid Long-Term Disability program were discontinued. Participants on disability leave as of December 31, 2024, remain on the terms of the IPI and LTD programs until they return from leave and/or they no longer meet the definition of eligible under the terms of the program.

Effective January 1, 2025, the Core Long-Term Disability (LTD) program offers coverage of 50% of pay (limits apply) at no cost to employees. Employees can elect to "buy up" to LTD coverage of 60% of pay (limits apply).
