Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Roman 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Roman 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Roman Health Ventures, Inc. (Plan Sponsor or the Company) and Roman Health Medical, LLC and Roman Health Pharmacy, LLC (Participating Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: An employee is eligible to participate in the Plan upon attainment of age 21 and is immediately eligible upon hire. The Plan excludes interns, nonresident aliens and union employees. Employees must be scheduled to work over 1,000 hours during a year to be eligible.

Contributions: Eligible participants may elect to contribute to the Plan up to the maximum allowable under the Internal Revenue Code (the IRC or Code), which is \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions subject to a maximum amount permitted by the Code of \$7,500 for the year ended December 31, 2024. A participant may make a rollover contribution to the Plan of amounts which were received from other qualified plans.

The Plan includes a Roth 401(k) contribution option which allows participants to contribute after-tax dollars into a Roth 401(k) account within the Plan and allows for tax-free earnings on those contributions if subsequent distributions are qualified under the Code.

During 2024, the Company made a discretionary employer matching contribution of 100% of the first 4% of employee deferrals.

Participants may elect to have their contributions and matching contributions invested in a variety of investment funds. Participants may change their investment allocation daily and may change their contribution percentage on a pay-period basis. The Plan currently offers mutual funds as investment options for participants.

Participant accounts: Each participant's account is credited with: (a) the participant's contributions and Company matching contributions and (b) an allocation of the Plan earnings. Allocations are based on participants' account balances.

Vesting: Participants are vested immediately in all contributions plus actual earnings thereon.

Notes receivable from participants: The Plan allows participants to borrow from their vested account balance a minimum of \$1,000 up to a maximum not to exceed the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the fixed rate of the prime rate plus 1%, and are repaid over a period up to five years. Principal and interest are paid ratably through periodic payroll deductions. The maximum number of loans outstanding at any one time is one. At December 31, 2024, the interest rate on outstanding loans ranged from 4.25% to 9.50%, maturing on various dates through June 2029.

Note 1. Description of Plan (Continued)

Payment of benefits: A participant may receive a benefit payment through reaching normal retirement age of 65, hardship withdrawal, termination withdrawal, minimum required distribution, or related to death or total disability. Each benefit payment type has eligibility criteria as defined in the Plan adoption agreement.

Administrative fees: Administrative fees, which include custodial and certain recordkeeping fees, are paid by the Plan.

Note 2. Summary of Significant Accounting Policies

The Plan's significant accounting policies are as follows:

Basis of accounting: The Plan's financial statements have been prepared on the accrual basis of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits: Benefits are recorded when paid.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes are treated as distributions based upon terms of the Plan document.

Subsequent events: The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by Matrix Trust Company (Matrix Trust), the former custodian, and Charles Schwab Corporation (Charles Schwab), the current custodian, and furnished by the plan administrator. The Plan Administrator has obtained certifications from Matrix Trust for the year ended December 31, 2023, and for the period from January 1, 2024 through December 13, 2024, and Charles Schwab for the period December 14, 2024 through December 31, 2024, that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets at December 31:

Matrix Trust & Charles Schwab also certified to the completeness and accuracy of \$5,268,403 of net appreciation in fair value of investments, \$563,577 of interest and dividends and \$7,306 of interest from notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used at December 31, 2024 or 2023.

Mutual funds (registered investment companies): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Tax Status

The Plan, and the trust established under the Plan, is qualified under the appropriate section of the IRC and intends to continue as a qualified plan and tax-exempt trust. The Plan Administrator believes the Plan and trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan Sponsor's management evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Note 6. Plan Termination

Although the Plan has not expressed any intent to do so, the Plan reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7. Exempt Party-in-Interest Transactions

The Plan holds interest-bearing cash in an account with Charles Schwab, the Plans current custodian. Matrix Trust was the former custodian. Transactions qualify as exempt party-in-interest transactions as defined by ERISA.

The Plan pays administrative fees to its recordkeeper for services rendered. The recordkeeper is a service provider to the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions as defined by ERISA

These party-in-interest transactions are not deemed prohibited because they are covered by statutory and administrative exemptions from the Code and the rules of prohibited transactions of ERISA.

Note 8. Non-Exempt Prohibited Transactions

During the years 2018-2023, the Plan Sponsor inadvertently failed to deposit \$2,691,490 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The Plan Sponsor has deposited lost earnings to correct this failure from 2018-2023 from the Plan Sponsor's assets.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the participants' account balances, and the amounts reported in the 2024 statement of net assets available for benefits.


