Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Afiniti 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Afiniti 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Afiniti 401(K) Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan covering substantially all employees of Afiniti, Inc. (the "Company"). Employees, except for nonresident aliens, union employees, and leased employees, are eligible to participate in the Plan the first day of the calendar month coincident with or next following the date an employee begins service.

The Company serves as the Plan administrator and has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Empower Annuity Insurance Company of America is the appointed insurance carrier and recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Contributions

Participants may elect to contribute up to 100% of eligible compensation not to exceed the limits of the Internal Revenue Code. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans.

The Plan allows for discretionary matching contributions. Participants must complete a year of service to be eligible to receive the Company's discretionary matching contribution. During 2024 and 2023, the Company contributed 50 percent of compensation that a participant contributed to the Plan. This contribution was limited to six percent of a participant's annual salary.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions and the related earnings. Vesting in the Company's discretionary matching contributions, including related earnings, is based on years of service with the Company. A participant becomes 50% vested after one year, 75% vested after two years, and 100% vested after three years of service.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$36,463 and \$150,694, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024 and 2023, forfeited non-vested accounts totaled \$129,553 and \$0, respectively, and were used to reduce Company contributions.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate established by the Plan administrator in a nondiscriminatory manner. Principal and interest are paid through payroll deductions. If a participant terminates employment with the Company, the loan becomes due and payable in full immediately. If the loan is not repaid, it will automatically be treated as a distribution to the participant on the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment.

Payment of Benefits

Benefits are payable upon retirement at age 65, disability, death, or termination of employment in lump sum payments. Participants may also elect to roll over their accounts to another tax-deferred account or remain in the Plan until they are legally required to begin taking distributions. All vested account balances not exceeding \$7,000 may be immediately distributed. With the plan administrator's approval, participants may withdraw all or part of their aggregate contributions in the event of financial hardship.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are charged to the participant and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan

administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Corrective Distributions Payable

Corrective distributions payable represents amounts payable to participants for contributions in excess of amounts allowed by the IRS.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Participants are also charged an asset based fee for recordkeeping, education and investment advisory services.

Use of Accounting Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Any unrealized appreciation or depreciation, as well as realized gains or losses for the year, are reflected as net appreciation or depreciation in fair value as shown on the statements of changes in net assets available for benefits. Purchases and sales of securities are recorded on a trade-date basis. Interest is accrued on a daily basis.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued. See Note 11.

NOTE 3 - INVESTMENTS

Certain information related to investments and notes receivable from participants information disclosed in the accompanying financial statements and ERISA required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest income, and interest income from notes receivable from participants for the years ended December 31, 2024 and

2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America on behalf of and pursuant to a power of attorney granted by Massachusetts Mutual Life Insurance Company, the insurance carriers of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to Unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based the lowest level input that is significant to the fair value measure in its entirety.

All of the plan's fair value investments are valued using net asset value as a practical expedient and therefore, are not required to be categorized in the fair value hierarchy levels described above.

Following is a description of the valuation methodologies used for instruments measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts:

The fair value of the units of pooled separate accounts is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the insurance company based on the fair value of the underlying assets in the account, less the liabilities.

NOTE 5 - INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan participates in a traditional benefit responsive investment contract with Massachusetts Mutual Life Insurance Company ("MassMutual") via an investment in a guaranteed investment contract ("Fixed Account"). MassMutual commingles the assets of the Fixed Account with other assets in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MassMutual is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include failure of the trust to qualify for exemption from federal income taxes or an amendment to the Plan that adversely affects MassMutual's obligations under the contract. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 - RISKS AND UNCERTAINTIES (CONTINUED)

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments. As of December 31, 2024, approximately 30% and 14% of the plan's net assets were invested in Vanguard 500 Index Admiral and IndexSelect Moderate 2055 Fund, respectively. As of December 31, 2023, approximately 29% and 14% of the plan's net assets were invested in Vanguard 500 Index Admiral and IndexSelect Moderate 2055 Fund, respectively.

NOTE 7 - TAX STATUS

Prior to June 30, 2022, the Plan was a volume submitter plan of The Retirement Advantage Inc., which received an opinion letter on March 31, 2014, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC").

Effective June 30, 2022, the Plan is a pre-approved plan of The Retirement Advantage Inc., which received an opinion letter on June 30, 2020, in which the IRS stated that the form of the plan document was acceptable under the applicable requirements of the IRC.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are managed by affiliates of Empower Retirement ("Empower"). Empower is the insurance carrier and recordkeeper as defined by the Plan. The Plan pays expenses related to the Plan operations and investment activities to Empower and various other service providers. These transactions qualify as exempt party-in-interest transactions.

The Plan was a party to a plan expense agreement with Empower. Under this agreement, participants were charged an asset based fee, a portion of which was credited to the BRISA budget account to pay any Plan expenses. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

NOTE 9 - PROHIBITED TRANSACTIONS - DELINQUENT CONTRIBUTIONS

NOTE 11 - SUBSEQUENT EVENT

Effective January 1, 2025, the Plan eliminated the prior one-year service requirement for eligibility to receive the Company's matching contributions. Employees are now eligible to receive matching contributions starting on the first day of the calendar month coincident with or next following their date of hire, consistent with the Plan's deferral policy.

Previously, the Company's matching contribution was funded on a per pay period basis, but the match formula was based on annual compensation. The Plan has since revised the matching formula to a fixed rate of 50% of participant deferrals, up to 12% of compensation, applied and funded on a pay period basis, resulting in a maximum match of 6% of compensation per pay period.
