### NOTE 1 PLAN DESCRIPTION

The following description of Acorn Distributors, Inc.'s 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan was established to provide for the retirement of Acorn Distributors, Inc. (the "Company") employees. The Plan is a defined contribution plan covering all employees who are not covered by a collective bargaining agreement. The Plan entrance dates are the first day of each quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Eligibility

Employees are eligible to participate in the Plan when they have attained the age of twenty-one and have completed six months of eligible service.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, and an allocation of the Company's contributions and Plan earnings (losses). Participant accounts are charged with an allocation of any administrative expense paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are participant-directed.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Plan provides that the Company's matching and discretionary nonelective contributions, including earnings thereon, vest fully at the end of six years or if they die, become permanently disabled, or reach early or normal retirement age.

Upon termination of employment and distribution of participant's entire vested account balance for any reason other than death or permanent disability, the Company's matching and discretionary nonelective contributions on their behalf, not then vested, are transferred to a forfeiture account. A forfeiture occurs in a plan year in which a one-year "break in service" occurs. If the participant is re-employed within a five-year period or before five consecutive "break in service" years, all or part of their forfeited non-vested account is restored through current year forfeitures and an employer contribution, if necessary.

#### **NOTE 1 PLAN DESCRIPTION** - continued

##### Contributions

Each year, participants may contribute up to the maximum amount allowable by the Internal Revenue Code of the their compensation, as defined by the Plan. Participants may elect to contribute funds on a before-tax elective deferral basis (salary deferral contributions), on a post-tax elective basis (Roth account contributions), or a combination of the two. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, with an automatic increase of 1% per year up to a maximum of 10% of eligible compensation, and their contributions invested in designated mutual funds until changed by the participant. The Company may make a discretionary matching contribution equal to a uniform percentage of the participant's salary deferral contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds.

Additional discretionary nonelective amounts may be contributed at the option of the Company's Board of Directors. There were no discretionary nonelective contributions to the Plan for the years ended December 31, 2024 and 2023. Contributions are subject to certain statutory limitations.

##### Payment of Benefits

Upon termination of employment, death, disability, or retirement, the participant may receive a lump sum distribution as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

##### Participant Loans (Notes Receivable from Participants)

Participant loans are permitted under the Plan. The minimum amount of a loan is \$1,000. Loans cannot exceed the lesser of \$50,000 or 50% of a participant's vested balance. Repayment of loans shall not exceed five years except if the loan proceeds are used to acquire the participant's principal residence. An administrative fee is charged for establishing and maintaining the loan. The loans are secured by the balance in the participant's account and bear interest. Loans are repaid ratably through payroll deductions. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

##### Forfeitures

Forfeitures are first used to pay Plan expenses or to reduce the Company's contributions. Forfeitures for 2024 and 2023 were \$890 and \$3,599, respectively. As of December 31, 2024 and 2023, forfeited nonvested account totals were \$2,522 and \$1,615, respectively.

### NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

#### Concentration of Credit Risk

The Plan invests in investment companies (funds) administered by Ascensus Trust Company, Nationwide Life Insurance Company, and Newport Trust Company, LLC. The funds' investments are not insured and are affected by the fluctuations in the stock and bond markets.

#### Payment of Benefits

Benefit distributions to participants are recorded when paid.

#### Plan Expenses

Investment advisory fees for portfolio management are paid directly from fund earnings; they are included in the fund expense ratio and will not reduce assets of the Plan. All other expenses including administrative costs, legal fees, auditing fees, and other costs are paid by the Plan or Plan sponsor.

#### Valuation of Investments and Income Recognition

Except for certain contracts held by Nationwide Life Insurance Company and described in Note 7, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Security transactions are accounted for on the date securities are purchased or sold (trade date). Dividend income is recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Capital gain distributions are included in dividend income. Net appreciation and depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year and the realized gain or loss on investments sold during the year.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

#### Reclassifications

Certain amounts from the prior year have been reclassified to conform with the current year presentation.

#### Evaluation of Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

#### **NOTE 3 PLAN TERMINATION**

Although the Company has not expressed any intent to do so, it has the right, by action of its directors, to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, amounts credited to the participants' accounts will become fully vested and nonforfeitable.

#### **NOTE 4 PARTIES IN INTEREST**

There were no known prohibited transactions with known parties in interest as defined in ERISA Section 3(14) and regulations thereunder, including those transactions set forth in ERISA Sections 406 and 407(a) and Internal Revenue Code Section 4975(c).

Certain Plan investments are invested in mutual funds and an insurance contract sponsored by the Custodian of the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

#### **NOTE 5 INCOME TAX STATUS**

The Company adopted a Volume Submitter Profit Sharing Plan, sponsored by American Pension Advisors LTD, with a cash or deferral arrangement that received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020. The plan document has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

As of July 1, 2023, American Pension Advisors was acquired by CBIZ.

Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### NOTE 7 INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive investment contract with Nationwide Life Insurance Company. Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported to the Plan by Nationwide Life Insurance Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

#### **NOTE 7 INVESTMENT CONTRACT WITH INSURANCE COMPANY** - continued

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The value of the investment contract was \$4,315 and \$4,735 at December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. The interest rates are reviewed on an annual basis for resetting.

#### **NOTE 8 FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Statement ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
